The Executive Office cannot prepare and ship show supplies until this document has been received in the Executive Office. Please fill out and mail IMMEDIATELY together with a copy of your show flyer. The Executive Office is authorized to charge a fine of \$20 for failure to submit show flyers. Show supplies are shipped the first week of the month prior to the month your show is held. If the application is not on file in the Executive Office when show supplies are shipped, a LATE APPLICATION FEE of \$25 will be charged. Show supplies will not be shipped without an application on file, and all charges for late shipment will be assessed to the club.

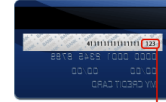
