Amend Show Rule 212.3, 212.4 (Top 10 AB Alters) – Board Directive

Explanation:

Amendments to these rules were approved by the membership in the 2016 membership ballot. During programming work it became clear that the rule changes had left definitions of final awards for SP rings as ambiguous and therefore unacceptable. In April 2017 the Board agreed to delay implementation until May 2018 so that revised wording could be submitted to the membership.

The above rules have been completely re-written to represent the Top 10 AB Alters proposal as originally envisaged.

If this change does not pass the membership ballot in 2017, then the wording of these rules will revert back to those as of August 2016 – in other words the concept of "Top 10 finals in all AB Alter Rings" is rejected.

For completeness the original rationale for the change (presented to the Annual 2016 Board meeting) is provided below. Rules comments reflect a mix of original comments at the time and those made following the re-drafting.

Rationale:

The entries in the Alter class have changed over the last 5 to 10 years. So much so that the judges are constantly commenting that the Alter class has now become one of the most competitive classes in TICA due to the number of high quality of Alters in the show ring today. Alter exhibitors have changed over the years as well. There is an increase of Alter-only exhibitors (non-breeders) competing. As a result, the HHP and Alter classes appeal to the TICA members who do not breed, do not consider the shows as part of a cattery business and simply show as a hobby and out of a love for our cats. It is widely known that many TICA breeders started out by showing HHPs and Alters and then gradually made the transition to becoming breeders. Changing the current Alter Finals rule would provide more incentive for the hobby exhibitor, especially the new or first time exhibitors, as the HHP and Alter classes are where TICA needs to be enticing exhibitors to eventually consider breeding in the future.

TICA already splits the Alters into LH and SH Speciality classes and offers a Top 5 regardless of count. As a result, this should not be a stretch to offer a Top 10 Alter Allbreed class regardless of count.

By increasing the AB Alter finals to equal the number of cats competing up to a maximum of 10, this also helps increase our show counts. Currently, the more competitive TICA exhibitors are concentrating on supporting the shows that have a minimum count of 25. Since the economy took a down turn in 2008, the shows with a routine count of 18 to 20 Alters have suffered as a result of Alter exhibitors choosing to attend shows known for having larger counts. By increasing the number of finals, this gives the TICA hobby exhibitor more incentive to support the smaller shows and helps increase entries and revenue for those shows. Again, keeping those exhibitors participating in the TICA show world and eventually increasing our breeders.

I come from the horse show world, as a judge, competitor and breeder. Due to the economy crashing in 2008, we had one major division in particular that began to suffer and we eventually changed the rules to reflect something similar to my proposed rule change for the TICA Alter division. There was much discussion in regards to the pros and cons and whether this would provide an incentive or lead to a false sense of accomplishment by potentially awarding lesser quality animals. What we have found over the last five years, though, has been the opposite. The high quality horses are still present at our horse shows, but by "tweaking" our rules, we in turn helped increase exhibitor attendance during a tough economic down turn. As a result, the smaller shows with less exhibitors that began suffering through 2008 to 2010 have now increased in numbers and we are back to seeing these shows thrive despite the current economy. And again, we are ultimately creating an incentive to ensure many of these exhibitors continue to participate in our industry and eventually make the move into becoming future breeders or supporting the industry in other aspects. I hope for the same success rate for TICA!

Amend Show Rules 212.3 and 212.4:

(delete current 212.3 and 212.4 and substitute new wording)

212.3 If there are FEWER THAN 10 cats, kittens, alters competing, judges in either allbreed or specialty rings shall present the top five. However, if there are fewer than five entries in any class, the club is required to provide rosettes for the number of entries competing.

212.4 Number of Rosettes Awarded

212.4.1 Household Pet Adults and Household Pet Kittens - The number of rosettes awarded in the HHP adult class and Household Pet kitten class shall be equal to the number of cats competing up to a maximum of 10.

212.4.2 Alters - The number of rosettes awarded in the Alter allbreed rings shall be equal to the number of cats competing up to a maximum of 10. If there are FEWER THAN 10 alters competing in specialty rings, judges shall present the top five.

212.4.3 Top 5 Format - 20 or Fewer Cats Present: When 20 or fewer cats or kittens are present, the judge shall award Best through Fifth Best final awards.

212.4.4 Top 6 to 9 Format - 21 to 24 Cats Present: When 21 to 24 cats or kittens or household pets or household pet kittens are present, the judge shall award final awards as follows:

When 21 cats are present, Best through 6th Best, except Alters, HHP Adults and HHP Kittens, See 212.4.1and 212.4.2

When 22 cats are present, Best through 7th Best, except Alters, HHP Adults and HHP Kittens, See 212.4.1 and 212.4.2

When 23 cats are present, Best through 8th Best, except Alters, HHP Adults and HHP Kittens, See 212.4.1 and 212.4.2

When 24 cats are present, Best through 9th Best, except Alters, HHP Adults and HHP Kittens, See 212.4.1 and 212.4.2

212.4.5 Top 10 Format – 25 or more Cats Present: When 25 or more cats, kittens, alters or household pets or household pet kittens are present, the judge shall award Best through 10th Best final awards.

212.3 Number of Final Places Awarded

212.3.1 Household Pet Adult class, Household Pet Kitten class, and AB Alter class.

The following places shall be awarded for finals of these classes depending on number of cats present and competing:

212.4 Rule deleted

Rules Comments:

(A)
I think that if it is limited to AB rings then I'm for this top 10 Alter proposal. I'm not leaning toward the Kitten or Champion Class at all. Years ago when we did rosettes for all finals, this might cause a burden on our clubs but now with Plaques, it's not cost prohibitive.

(B)

I think our system is fine the way it is. Alters are judged on a written, confirmation standard. I do not think awarding top ten placements in AB rings is going to change entry numbers at all.

(C)
Agreed. We extended some years ago the HHP finals up to 10 no matter the count and we are not seeing any increase in the HHP entries at shows.

I don't like the idea of having a special treatment just for Allbreed Alter finals. We should treat all pure breed judging in the same way for consistency.

- (D)
 I do not like being required to give finals to cats that are not deserving when we have low numbers. I realize that the alter class can be highly competitive, but am not in favor either of treating them differently than or kittens and cats.
- (E) I agree with this as well. There are other ways to try to increase entries.
- (F)
 The proposal would remove consistency of finals awards across the Championship, Kitten and Alter Classes. I think that is a bad idea, especially as there is no guarantee that the amendment will increase Alter entries. I am not convinced that a comparison with the horse world is appropriate.

Comments on the format of the replacement rule:

- (D) The re-formatted rule looks clear as day to me. Much better.
- (F)
 I agree. I did wonder at first about the table format, but it does make it so clear and easy to understand..

Add Show Rules 22.1.2.3 (Pet Expos) – Adler/Hutcherson

Rationale:

The Pet Expo determines the date of the Expo and the club has no control over the date. It is financially advantageous for the club to have the pet expo cover the cost of the show hall. Additionally, the Expo company frequently pays the cost of the caging service as well. Pet expos also provide considerable publicity for TICA.

Limiting the expo show to a maximum of 125 entries will prevent the show from drawing too many entries from adjoining regions which may be having their own shows within 500 miles.

Add Show Rule 22.1.2.3

- 22.1.2 Show Dates. When a club desires a show date from the Regional Director, they may request that date in writing. After 30 days, there being no response from the Regional Director, the club may proceed with the show date, scheduling it through the Executive Office by providing the Executive Office with a copy of the written request.
- 22.1.2.1 The Regional Director may deny a club a specific show date if there is a previously scheduled TICA show within 500 miles (805 kilometers) or in the same region on the requested weekend.
- 22.1.2.2 If there are multiple show requests for the same show weekend, shows may be held within 500 miles (805 kilometers) of each other only with both A and B below:
 - A. Written permission from the show managers, and
- B. Written permission of the regional director or regional directors if the show requests are from multiple regions. The first club that requests a show date is authorized to have the show.
- 22.1.2.3 The provisions and restrictions of 22.1.2.1 and 22.1.2.2 shall not apply when one or both of the scheduled shows for the same date is part of a Pet Expo in which the Pet Expo determines the date of the expo, the shows are in different regions, and when the show is limited to a maximum of 125 entries.

- (A) The format looks fine (and I agree with the rationale behind it)
- (B) Works for me and makes sense.
- (C) I agree with the intent of this proposal. Pet Expos are an important showcase for TICA
- (D) I support this proposal.

Add Show Rule 29.1.1.6.1.1 (Signage in show halls) - Jones

Rationale:

I was asked to put this forward this by a board member.

It deals with Show Rule 29.1.1.6.1 and TICA being displayed at shows. We had a show last season where there was no TICA signage displayed in the show hall and people were wondering if it was a TICA, CFA or Royal Canin show.

Add new Show Rule 29.1.1.6.1.1:

29.1.1.6.1 All advertising, promotion or information that is disseminated to the public regarding a TICA show shall include the name of the club putting on the show and the TICA name and/or logo. In no event shall the name of any public relations firm, production company, show management company, professional show manager or any other entity be displayed in larger type nor more prominently than the name of the club and the TICA name and/or logo.

29.1.1.6.1.1 Show hall displays shall ensure that the club name and/or the TICA logo is displayed as prominently as any show sponsor's name and/or logo.

- (A) Works for me
- (B) Fine by me
- (C) OK with me too
- (D) I think this covers it
- (E)
 I'm hoping the incident referred to in the rationale was a one-off and won't be repeated. Hall signage is implicitly included in the existing rule, but I think it deserves explicit clarification.

Amend Bylaws 120.2 and Standing Rules 901.4.2, 901.4.3 (Breed Awards) - Stevens

Rationale:

Cats Breed Win (BW)

- *Not all exhibitors can afford to campaign their cats but may be able to achieve the breed win award for their cat by showing at local shows; this will contribute to the prestige of minority breeds and allow those who have these cats to have an award when they may not achieve a regional win (RW) or an international win (IW). It recognizes the excellence of individual breeds, no matter how small their numbers are and improves numbers of entries at local shows.
- *A breed win may be more important for a breeder of a specific breed as they are competing against other breed examples and although the points may not be there for an international win (IW) or regional win (RW), breeders can compete for the award of Breed Winner (BW) and know they are Best in their breed. It will be equivalent to an RW or IW in prestige.
- *It will give breeders reason to take their whole cats back into the show hall once they reach sexual maturity and to compete with other examples of their breed, to know if their breeding program is successful. We always felt one way to know if your breeding program was successful was to see your cat or cats in competition with other breeders' cats. The BW title will help bring out the competition and solidify your breeding success.
- * This adds a third title, and as championship cats are the life blood of our breeds, without them there would be no future Kitten or Alter classes, there should be a specific title to recognize their contribution to their/our breeding programs.
- * This potentially has the possibility of adding to the count at shows if breeders feel a BW is possible where a RW or IW is not. This is especially true for minority breeds and at local shows with lower counts.
- * The BW will replace one RW requirement, with requirement for a RW and IW still in place, in the LA award.

Kitten Breed Win

* Not all exhibitors can afford to campaign their kittens but may be able to achieve the breed win title for their kitten(s) by showing at local shows; this will contribute to the prestige of minority breeds and allow those who have these kittens to have a title when they may not achieve a regional win (RW) or an international win (IW). It recognizes the excellence of individual breeds, no matter how small their numbers are and improves numbers of entries at local shows.

(Breed Awards: Page 1 of 6)

- *A breed win is often more important for a breeder of a specific breed as they are competing against other breed examples and although the points may not be there for an international win (IW) or regional win (RW), breeders can compete for the title of Breed Winner (BW) and know they are Best in their breed. It will be equivalent to an RW or IW in prestige.
- *It will give breeders reason to take their developing kittens into the show hall once they begin to show promise and to compete with other examples of their breed, to know if their breeding program is successful. We always felt one way to know if your breeding program was successful was to see your kitten or kittens in competition with other breeders' kittens. The BW title will help bring out the competition and solidify your breeding success.
- * This adds a third title, and as kittens are the future of a breeder's breeding program, without them there would be no future Championship or Alter classes, there should be a specific title to recognize their contribution to our breeding programs.
- * This potentially has the possibility of adding to the count at shows if breeders feel a BW is possible where a RW or IW is not. This is especially true for minority breed kittens. And potential for improving numbers of entries at local shows.
- *The BW will replace one requirement for RW, with requirement for a RW and IW still in place, in the LA award.

Alter Breed Win

- *A breed win is often more important for a breeder of a specific breed as they are competing against other breed examples and although the points may not be there for an international win (IW) or regional win (RW), breeders can compete for the title of Breed Winner (BW) and know they are Best in their breed in retired cats. It will be equivalent to an RW or IW in prestige.
- *It will give breeders reason to take their altered cats back into the show hall once they reach maturity and to compete with other examples of their breed, to know if their breeding program is successful. We always felt one way to know if your breeding program was successful was to see your cat or cats in competition with other breeders' cats. BW title will help bring out the competition and solidify your breeding success and show that neutered or spayed cats are often a more mature example of the excellence of a breed than kittens or whole cats.
- * This adds a third title, and as altered cats are often the proof of our success as breeders, they should be given a title as a BW. In addition, many breeding cats cannot be shown as whole cats as out of condition, pregnant, in heat, spraying etc., and when retired they should be able to achieve a BW to recognize their beauty and success in their breed. Many cats come into their full potential when altered and they should be awarded for this with a BW.

(Breed Awards: Page 2 of 6)

- * This potentially has the possibility of adding to the count at shows in the altered class if breeders feel a BW is possible where a RW or IW is not. This is especially true for minority breeds (see following research discussion). And improves numbers of entries at local shows.
- * The BW will replace one RW requirement in the LA award, with requirement for a RW and IW still in place.
- * A minimum of 1,000 points is required whereas in the IW and RW it is an aggregate only that determines the win. However, all current breed winners were examined at the end of the 2016-2017 show season and currently there are 15 breeds at the end of the show season that had either kittens, cats, or alters that do not have 1,000 points who would be awarded a breed win (BW) if the minimum points of 1,000 were not required. The required 1,000 points would give breeders or owners a reason to show their alters as 11 of these breed owners either did not show alters, or their points were low. Second lowest that were not shown in breeds were kittens with five breeds that did not show or who had low points for their kittens. The lowest level for breeds was in cats, where only four breeds had none shown or had low points.

Amend Bylaws 120.2:

120.2 The Board of Directors shall establish a system for computing wins and determining the winners of international awards, **breed** and regional awards.

Amend Standing Rules 901.4.2 and 901.4.3

901.4.2.2 Eligibility: All eligible cats must have received at least one Top 25 International award as a kitten, cat or alter and two International or Regional top 25 awards as a kitten, cat or alter **One Breed Win as kitten, cat, or alter may substitute for an RW**. Two titles may be achieved in 1 year, i.e., top kitten and cat or alter **or Breed Win**. However, a Regional, **Breed or award and** an International award on the same cat (See Show Rule 21.73) in the same year counts as only one title. Ownership of the cat may change from year to year. The award is for the cat, not the owner, although the current owner will be requesting the award.

901.4.2.3 For pedigreed cats, awards shall be earned in the kitten class, the championship class and the alter class. Years of awards need not be consecutive.

901.4.2.6 Claiming the title: The following items must be provided by the owner of the cat:

901.4.2.6.1 A copy of the TICA registration of the cat claiming the title.

901.4.2.6.2 A completed application form.

901.4.2.6.3 Proof of the wins as evidenced by any one of the following:

901.4.2.6.4 Copies of the certificates issued by Executive Office or copies of the Official Standings posted on the TICA Website by the Executive Office showing that a Breed Award or an RW or an IW have been achieved.

[Remainder of 901.4.2.6 is unchanged]

(Breed Awards: Page 3 of 6)

- 901.4.3 <u>Calculation of Regional and International Awards and Breed Awards</u>. The Executive Office will accumulate the scores of each registered cat, kitten, alter and household pet as well as household pet kittens as shown in the marked catalogs from all TICA sanctioned cat shows held during the period May 1st through April 30 (show year). NO cat, kitten, alter, or household pet shall receive a regional, breed or international award unless it has a TICA registration number. Allow unregistered Household Pet Kittens to earn IW and/or RW awards.
- 901.4.3.1 The cumulative points of the 50 judgings of each registered cat, alter and household pet carrying the highest point value will be used to determine the aggregate Regional and International points for each registered cat, alter and household pet during each show year. The cumulative points of the 30 judgings of each registered kitten and each household pet kitten carrying the highest point value will be used to determine the aggregate Regional and International points for each registered kitten and each household pet kitten. Breed award winner will be awarded to pedigree cat, kitten or alter who achieves highest points within breed category by end of current show season. Last kitten of breed to achieve highest points before aging out during show season will achieve Breed award. Breed award winner must attain minimum of 1,000 final points towards titles for cats and alters and 1,000 final points for kittens. For cats and alters a minimum of one AB or SP final is also required for BW title.
- 901.4.3.2 In order for a cat/kitten to be eligible for a **breed or** regional award, it must be shown at least once in that region. An exception will be made in the case of kittens and household pet kittens in that a show as an adult will fill the requirement that they be shown one time in the region.
- 901.4.3.3 Points earned in a breed congress format (Show Rule 21.68) or a breed/multi-breed congress format (Show Rule 21.69) shall not be scored for regional, **breed** or international awards.
- 901.4.3.4 Regional Awards. Regional Awards will be presented to the 25 cats, kittens, alters, household pets, household pet kittens and 25 longhair cats and 25 shorthair cats having the highest aggregate points of all cats, kittens, alters, household pets and household pet kittens, as applicable in the region. In order to receive a Regional Award, the owner of the cat, kitten, alter, household pet and household pet kitten must have exhibited the cat, kitten, alter, household pet or household pet kitten, as applicable, in at least one TICA sanctioned cat show in the regions presenting the award during the show year for which the regional award was earned. All awards earned during the show year will be listed accordingly for every region or recognized area and internationally.
- 901.4.3.4.1 All winners are notified by the appropriate Regional Director.
- 901.4.3.4.2 The Top 3 Cats in each color of their respective breeds receive a color certificate from the appropriate Regional Director.
- 901.4.3.4.3 The Top 25Cats, Kittens, Alters, Household Pets and Household Pet Kittens, in each region are featured in a visual media presentation at the Regional Banquet.

(Breed Awards: Page 4 of 6)

- 901.4.3.4.4 The Regional Top 25 Longhair Cats and Shorthair Cats, and Breed Award winners, are honored at the Regional Awards Banquet.
- 901.4.3.4.5 The Top 10 Cats, Kittens, Alters, Household Pets and Household Pet Kittens are featured in the TICA YEARBOOK free of charge.
- 901.4.3.5 <u>International Awards</u>. International Awards will be presented to the 25 cats, kittens, alters, and household pets, household pet kittens; and 25 longhair cats and 25 shorthair cats having the highest aggregate points of all cats, kittens, alters, household pets, and household pet kittens, as applicable, in the association during the applicable show year. All awards earned during the show year will be listed accordingly for every region or recognized area and internationally.
- 901.4.3.5.1 The Top 25 Cats, Kittens, Alters, Household Pets and Household Pet Kittens, are featured in a visual media presentation at the Annual Awards Banquet and in the TICA YEARBOOK in color, free of charge.
- 901.4.3.5.2 The Top 25 longhair and shorthair cats, and the Best Cat in each breed are honored at the Annual Awards Banquet.
- 901.4.3.5.3 International Best of Breed winners are pictured in the TICA YEARBOOK.
- 901.4.3.6 Breed Awards. Breed Awards will be presented to the highest scoring Breed winners in the association during the applicable show year. In order to receive a Breed Award, the owner of the cat, kitten, alter, must have exhibited the cat, kitten, or alter, as applicable, in at least one TICA sanctioned cat show in the regions.

All awards earned during the show year will be listed accordingly for every region or recognized area and internationally.

- 901.4.3.6.1 All Breed winner's awards earned during the show year will be listed accordingly for every region or recognized area and internationally, are featured in a visual media presentation at the Annual Awards Banquet and in the TICA YEARBOOK in color, free of charge.
- 901.4.3.6.7 The Executive Office is responsible for the International Awards and Breed Awards. After Regional Directors lists are furnished, notification letters are mailed to International Award and Breed award winners.

Rules Committee Comments:

(A) First off the initials BW are what is used by CFA so I don't think that is going to fly.

Second, I don't think being a breed winner should take the place of a RW towards an LA. Some of our breeds can be shown once or twice and be a breed winner. The LA's that our cats are getting are being earned by these owners because of dedication to the association, not just looking for another title.

Third, I do think they should be recognized in cats, kittens and alters.

- (B) How about "BB" for the Best of Breed abbreviation?
- (C)
 Don't we already have breed wins in championship cats? Do we really need to add more and have it be in the yearbook? (Adds expense to something we generally lose money on)

I think it would really be making something like an LA be weak (or cheapen the accomplishment) if it can include a breed win with a minority breed that has only 2 or 3 showing in a year.. or even one.. Here's the wins in alters last season: http://tica.org/pdf/standings/stand_altbrd.pdf

I'm not sure what is meant in 901.4.3.1 by "Last kitten of breed to achieve highest points before aging out during show season will achieve Breed award"." How is the above different from the one with the highest points?

(D)
The wording in 901.4.3.1 needs further review before being approved by the Board in my opinion.

In answer to (C)'s question, this might be because when originally submitted the changes weren't properly formatted so I asked for it to be corrected. I also asked what happened should two cats/kittens/alters both get the same points?

I'm not sure what the "aging out" does - and on a practical level can the EO actually handle this in the programming?

(D)
I agree about the RW/IW issue. The initial part of the rationale talks about this new award being for those not campaigning cats ... yet later on wants this new award to be equivalent to an RW.

RW and IW to my mind are awards for sustained competitive success against other breeds within a show year, and the LA is similar across multiple show years. The proposed awards really only demonstrate competitive success within a single breed. I like the concept of Breed Awards, but not as an equivalent to an RW.

If the Board (and membership since there is a Bylaw change) approve the proposal the implementation date should be set as the "ensuing May 1 following completion of programming and testing".

(Breed Awards: Page 6 of 6)

Amend Bylaws 114.2 (Qualifications for Breed Committee) - Chamberlin

Rationale:

Including "breed/breed group section" here is causing confusion for both the designers of our online election form and those wishing to file for breed committee. There is no such membership requirement listed under 15.2 Qualifications for Election to a Breed/Breed Group Committee and the EO has not applied this requirement when vetting candidates for breed committee or checking their documentation.

Amend Bylaw 114.2:

114.2 Announcement of Candidates. After the initial election, any member who has been a member in good standing for 2 consecutive years immediately preceding shall be eligible to seek office and shall declare his candidacy in writing to the Executive Office not more than 6 months nor less than 2 months before the election month with the filing fee established by the Board of Directors. If no member in the region *or no member in the Breed/Breed Group Section* has been a member for the 2 years immediately preceding the election, the 2 year membership requirement shall not apply. This shall entitle the candidate to be listed as a candidate for the office sought in every issue of the newsletter including the newsletter prior to the ballot being mailed to the membership. Each candidate shall be entitled to publish a summary of his/her experience, credentials and platform in accordance with Standing Rules.

Rules Committee Comments:

(A) In my opinion the rationale for the amendment is founded on a fallacy.

Bylaw 114.2 applies to candidates for ANY office, where 15.2.2 applies only to breed committee elections, so the 114.2 rule is cumulative (i.e. in addition to) the 15.2.2 requirements, especially since 114.2 specifically references breed committee elections.

That being said, the real problem is that 15.2.2 is in the wrong place; it shouldn't be with breed section membership, it should be with the election rules in Article 14.

The point of the 2 year rule is protective: to stop just anybody joining a breed section and then being able to stand for the breed committee and influence the standard - without necessarily having the experience to understand the breed concerned.

(B)
I agree with you, although I think 15.2.2 should probably be in both places, just to make sure there is no confusion.

(C)

I think you should be an active participant in the breed committee for which you want to apply.

I agree with (A) in the fact that anyone could file and run and have a say in the standard when they don't even work with it.

- (D) Sometimes we have a difficult time filling the slot and sometimes not enough breeders run.
- (B)
 I understand that, but what is better for the breed to have fewer committee members well versed in, and committed to the breed, or a full complex of members, some of whom are uninformed and inexperienced?
- (D)
 I guess the issue is how much of a problem is it for a breed committee to be inactive

Add "Conflict of Interest Policy" to Board Governance Policies (Fisher)

Rationale:

Following governance best practices, this proposal formalizes and adopts a Conflict of Interest Policy in accordance with TICA's status as a tax-exempt organization.

TICA does need to adopt a COI policy as it is something that is asked about on TICA's tax return. Since TICA is relatively small, it hasn't been something that is hard to "police", but it is time to formalize. Also, we have had some times in the past that I felt certain Board members didn't fully appreciate their potential conflicts.

The proposal below is borrowed from the Winn Feline Foundation which borrowed it from national non-profit organizations that help non-profits. It is possibly a bit overkill, but certainly covers the intent of IRS and governance gurus.

Add the following as the "Conflict of Interest Policy"

The International Cat Association

Conflict of Interest Policy

Article I: Purpose

The purpose of the conflict of interest policy is to protect The International Cat Association's (the Association) (a tax-exempt organization) interest when it is contemplating entering into a transaction or arrangement that might benefit the private interest of an officer or director of the Association, might result in a possible excess benefit transaction or may be a non-financial perceived, real or potential conflict which might preclude an interested person in performing impartially their responsibility to the Association. This policy is intended to supplement but not replace any applicable state and federal laws governing conflict of interest applicable to nonprofit organizations.

Article II: Definitions

- 1. <u>Interested Person</u>. Any director, principal officer, or member of a committee with governing board delegated powers, who has a direct or indirect financial interest, as defined below, is an interested person.
- 2. <u>Financial Interest</u>. A person has a financial interest if the person has, directly or indirectly, through business, investment, or family member(s):
- a) An ownership or investment interest in any entity with which the Association has a transaction or arrangement,

(Conflict of Interest Policy – Page 1 of 5)

- b) A compensation arrangement with the Association or with any entity or individual with which the Association has a transaction or arrangement, or
- c) A potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which the Association is negotiating a transaction or arrangement. Compensation includes direct and indirect remuneration as well as gifts or favors that are not insubstantial.

A financial interest is not necessarily a conflict of interest. Under Article III, Section 2, a person who has a financial interest may have a conflict of interest only if the appropriate governing board or committee decides that a conflict of interest exists.

- 3. <u>Non-financial conflicts of interest</u>. Situations and influences which may present the risk that an interested person might make a decision based on, or affected by, these influences rather than in the best interests of the Association. Voting on judging acceptances and advancements, disciplinary actions, hiring employees or contractors and voting on complaints may give rise to non-financial conflicts of interest.
- 4. <u>Family member</u>. A person is a family member if they are a spouse, domestic partner, parent, sibling, child or grandchild.

Article III: Procedures

- 1. <u>Duty to Disclose</u>. In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest or family relationship and be given the opportunity to disclose all material facts to the directors and members of committees with governing board delegated powers considering the proposed transaction or arrangement.
- 2. <u>Determining Whether a Conflict of Interest Exists</u>. After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.
- 3. Procedures for Addressing the Conflict of Interest.
- a) An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest.
- b) The chair of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.

(Conflict of Interest Policy – Page 2 of 5)

- c) After exercising due diligence, the governing board or committee shall determine whether the Association can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.
- d) If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Association's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement.

4. Violations of the Conflicts of Interest Policy

- a) If the governing board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose.
- b) If, after hearing the member's response and after making further investigation as warranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

Article IV: Records of Proceedings. The minutes of the governing board and all committees with board delegated powers shall contain:

- 1. The names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the governing board's or committee's decision as to whether a conflict of interest in fact existed.
- 2. The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement, and a record of any votes taken in connection with the proceedings.

Article V: Compensation

- 1. A voting member of the governing board who receives compensation, directly or indirectly, from the Association for services is precluded from voting on matters pertaining to that member's compensation.
- 2. A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Association for services is precluded from voting on matters pertaining to that member's compensation.

(Conflict of Interest Policy – Page 3 of 5)

3. No voting member of the governing board or any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Association, either individually or collectively, is prohibited from providing information to any committee regarding compensation.

Article VI: Annual Statements.

Each director, principal officer and member of a committee with governing board delegated powers shall annually sign a statement which affirms such person:

- Has received a copy of the conflicts of interest policy,
- Has read and understands the policy,
- Has agreed to comply with the policy, and
- Understands the Association is a not for profit entity and in order to maintain its
 federal tax exemption it must engage primarily in activities which accomplish one
 or more of its tax-exempt purposes.

Article VII: Periodic Reviews

To ensure the Association operates in a manner consistent with tax-exempt purposes and does not engage in activities that could jeopardize its tax-exempt status, periodic reviews shall be conducted. The periodic reviews shall, at a minimum, include the following subjects:

- Whether compensation arrangements and benefits are reasonable, based on competent survey information, and the result of arm's length bargaining.
- Whether partnerships, joint ventures, and arrangements with management organizations conform to the Association's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes, and do not result in inurement, impermissible private benefit, or in an excess benefit transaction.

Article VIII: Use of Outside Experts

When conducting the periodic reviews as provided for in Article VII, the Association may, but need not, use outside advisors. If outside experts are used, their use shall not relieve the governing board of its responsibility for ensuring periodic reviews are conducted.

Rules Committee Comments:

- (A) Sounds like a good policy to me
- (B) It looks great

(Conflict of Interest Policy – Page 4 of 5)

- (C) If Legal Counsel says it's good then I'm good with it.
- (D)
 This comprehensively covers what is required and, as well as federal requirements, the inclusion of the policy is authorized by Bylaw 17.2.2

(Conflict of Interest Policy – Page 5 of 5)

Amend Standing Rules 601.2.12 and 601.2.13 (Kitten and HHPK Scores) - Maddox

Rationale:

Responsible breeding is defined by many attributes, but not by a show year. Our show rules place unintended restrictions on show kittens based on time of year born. Kittens shown should be able to receive the full opportunity to show for 4 months and have the scores attributed to a single show year. The current rule unintentionally discourages kittens who's eligibility spans 2 show seasons from competitively showing. The end of year and beginning of year kitten counts are likely lower because of kitten's not being shown who's date of birth causes the scoring to be attributed to 2 seasons.

Amend 601.2.12 and 601.2.13

601.2.12 Cumulative scores **for a cat, alter and HHP** are based on the show year May 1st through April 30th each and every year. The score totals as of April 30th are used in the Regional Awards Presentations (usually the following summer) and the Annual Awards Presentation (the following Labor Day weekend).

601.2.12.1 Cumulative scores for a kitten or HHP kitten are based on the show year in which its last full weekend of kitten eligibility falls, regardless of the show year in which it begins showing as a kitten or HHP kitten.

601.2.13 Come May 1st, cat, alter and HHP start over again with 0 points. Kitten and HHP kitten scores will only count for 1 show year as defined in 601.2.12.1

- (A)
 The amendment as written appears to meet the requirements for submission, however I wonder how it will affect the EO, specifically the programming to keep track of cats' scores and/or the people who keep track of these records.
- (B) CFA does this. It has not really increased the counts.
- (C)
 I think changing that rule might give an end of season kitten an unfair advantage over a May baby trying to be shown in the early part of the season.
- (D)
 I see a problem. Kittens in the same final could be scored in 2 different show season depending when the last weekend of kitten eligibility falls ... however the points that a kitten gets is a representation of the finals points plus cats defeated. So, in some way there would be kittens scored in different seasons while the same cat count would affect both seasons.

The total number of cats competing is figured in a ring-by-ring basis, and each ring belongs to a specific show season, then two kittens in the same final can't be scored in different show seasons. It would a big inconsistency for our scoring system.

(E)
A decision on this rule proposal shouldn't be made until after the programming implications are understood and costed by the EO and IT team and then presented to the Board.

If it does go through, the implementation date should be proposed as "the ensuing 1 May after all programming changes have been completed and tested".

(C)
I don't really see the need for this. I agree with (D) that this is in conflict with our scoring system.

And when will it stop? I have a cat that turns 8 months old the last show of the season. Do I get to carry over my points because I didn't get a full show season?

(F)
I can understand the thinking behind this, but it is too complex – and I worry about how much IT work will be needed.

Add Standing Rule 109.2.1.6 (Agenda Timescales) - Wood

Rationale:

It has long been policy for Rules Committee to send any rules changes to the EO 60 days prior to the date of the Board Meeting for placement on the Agenda, so that an Agenda can be published at least 30 days prior to the meeting. TICA has rules on timescales for submissions for the agenda and minutes publication, yet nothing on when the agenda should be published,

30 days provides adequate time for members to contact their RD with comments about the proposals on the Agenda and for RDs themselves to be familiar with the agenda. In recent years, the Agenda has often been published late, which reduces the ability of members to comment in time.

Add Standing Rule 109.2.1.6:

A detailed Agenda for each regularly scheduled Board meeting shall be supplied to all Board members, and also published on the TICA web site, at least 30 days prior to the opening day of each Board Meeting.

Rules Committee Comments:

- (A)
 I agree with this RDs need time to let their members know about proposals
- (B)
 I would like to add that if people are late getting reports in, which they are, then Leslie has nothing to send out.

On the other hand, my RD told me she had exactly one comment when she put up the last agenda.

- (C) I support this.
- (D)
 I don't. More rules it's not gonna make people to work properly and sending what they are supposed to send on time.

We have already rules in place that cover how to handle the agenda and we are not able to enforce them. So more rules .. it has not sense to me.

If people are late ... many times, then it's time to replace them. If we say we are business, let's work as a business.

(E)
I support the proposal – RDs need time to understand the agenda.

Add Standing Rule 1017.1.2 (Other Rule Changes) - Wood

Rationale:

There is no defined procedure for members to submit proposals to change Standing Rules and other Rules documents. A procedure is already defined for the Bylaws, Show Rules and Registration Rules.

This amendment addresses that omission. Standing Rule 1017.1.1.1 is renumbered so that it also applies to the proposed new 1017.1.2.

Note that no form is specified as the existing form only applies to Bylaws, Show Rules and Registration Rules.

Add Standing Rule 1017.1.2:

Proposals to amend Rules or Policies (other than the Bylaws, Show Rules and Registration Rules) shall be considered by the Board of Directors at regularly scheduled meetings. Proposals from the membership must be in writing and received by the Rules Committee no later than 90 days prior to the opening day of the meeting to allow time for review in order to reach the Executive Office 60 days prior to the opening day of the meeting. Proposals received by the Rules Committee after the 90-day deadline will be placed on the following meeting agenda. Proposals must contain a rationale for the change plus the new rule wording (or the original rule wording and the amended version).

1017.1.2.1 Amendments, if approved by the Board of Directors, shall take effect immediately unless the proposal itself provides another effective date. Any changes which will affect the way a cat may be shown shall take effect May 1 of the ensuing year.

Renumber Standing Rule 1017.1.1.1 as 1017.1.3

1017.1.3.1.1 Notification. Members are to be notified of action taken at the Board Meeting on proposals submitted by them with a target date of 10 working days after completion of the minutes.

Amend Standing Rule 903.2.1.2 and 903.2.2.1 (Rings at Annual) – Gilmore

Rationale:

Recently my club was granted an exception for the number of rings we are hosting at the 2018 Annual so that we could have all regions represented by a judge. The exception was granted but Ralph Stadter (EN RD) requested that there be a proposal to change the rules permanently. Our rationale for the request was that the guidelines were written when TICA was smaller and had 12 Regions. We now have 13 and could grow to a 14th Region.

While TICA could grow beyond 14 Regions, as this proposal was contemplated and discussed with several Board members, it was agreed that trying to do a show with greater than 14 rings was not conducive to timely completion of judging each day. If the guidelines simply allowed the host club to put on as many rings as allowed for a standard show, a club could offer a 20 ring continuous show, which would not be acceptable. It was agreed that a minimum of 12 rings and maximum of 14 was ideal.

Amend Standing Rules 903.2.1.2 and 903.2.2.1:

903. 2.1 Show Hall

903.2.1.1 Minimum of 35,000 square feet, 40,000 feet recommended

903.2.1.2 A minimum of Twelve (12) and a maximum of fourteen (14) rings set up in the center of the show hall with benching on two or four sides.

903.2.1.2.1 Rings may be set up back to back, with an exhibitor access corridor.

903.2.1.2.2 Rings may be set up in a square or rectangle, with open space in the center for Master Clerk(s) and Announcers. An exhibitor access corridor should be provided through the square or rectangle for access to rings.

903.2.2 Show Format.

903.2.2.1 Two-day split format with *twelve (12)* continuous rings

Rules Committee Comments:

(A) I think 14 rings is going to be tough to get done on a Saturday night before a banquet. 12 is tough enough. While I know we don't hit all 12 rings some people might if showing in different classes.

There is no rule that says you have to invite judges from each region.

- (B)
 I have no problem with this- it offers clubs the option to choose.
- (C)
 An exception to the existing rule has already been made. I don't see a problem in extending to 14 rings if a club wants that.
- (D)

 The proposal is correctly formatted. Time will tell if 14 rings can be comfortably completed without delaying the banquet start.

Amend 903.1.18 (Annual Ring Sponsorship) - Gilmore

Rationale:

These guideline rules were written some time ago and certainly during different economic times. Currently, Host Clubs are seeking sponsorship for rings well beyond these amounts. There is really no need to even suggest a dollar amount.

Amend Standing Rules 903.1.18:

Delete 903.18.1.1 and 903.18.1.2, renumber existing 903.1.18.3 and 903.1.18.1.4

903.1.18 Sponsors.

903.1.18.1 Contact all TICA clubs to solicit sponsorship for rings (can be done by notice in the TREND and online).

903.1.18.1.1 An Allbreed ring should cost approximately \$250.00.

903.1.18.1.2 Each specialty, (i.e Longhair or Shorthair) should cost approximately \$250.00.

903.1.18.1.31 Specialty rings may have a different sponsor for each specialty.

903.1.18.1.42 Clubs generally prefer to sponsor a judge from their own Region.

- (A)
 Agreed don't know why it was ever in there
- (B)
 I am reading this like there is a limit of one sponsorship per AB ring and 2 for SP. If that is correct, perhaps it should read Sponsor or multiple Sponsors for each ring. It seems at times there are multiple clubs from a region or catteries that go in together to share the cost of sponsoring a judge. Why limit it if it might mean increased potential for more income to cover costs.
- (C)
 I am in favour of the proposal I don't think we need to micromanage to this extent
- (D) I agree with (C)
- (E)
 I agree with (B), the proposal as written is vague and difficult to interpret its true intent, however I also agree that there shouldn't be a dollar amount specified for ring sponsorship.
- (F)
 I personally think that whole section on sponsorships could be deleted. Why does it even need to be in there?
- (G) I agree with (F)

Amend 907.4.2 (Therapy Cat Titles) - Stadter

Rationale:

50 visits to get any kind of recognition seems like a very high bar. I think it would be a good idea to add an earlier level to give something a little earlier. The number of visits and the "title" reflect suggestions made for the Winter 2016 Meeting by the Rules Committee, and again in Spring 2016.

Add Standing Rules 907.4.2.1 and re-number remainder of 907.4.2

907.4.2 Requirements for titles.

907.4.2.1 The title of Therapy Novice Cat (TNC) is awarded after the team has completed 10 visits.

907.4.2.**4 2** The title of Therapy Cat (TC) is awarded after the team has completed 50 visits.

907.4.2.23 The title of Therapy Cat of Excellence (TCX) is awarded after the team has completed 100 visits.

907.4.2.**3 4** The title of Therapy Cat of Distinction (TCD) is awarded after the team has completed 200 visits.

Rules Committee Comments:

(A)
This proposal for an entry level Title after 10 visits is consistent with recommendations by the Rules Committee (submission to the Winter 2016 meeting) and comments on the submission for Spring 2016 meeting.

The Novice title allows early recognition – for example under the current rules, someone who only does one therapy visit a month could take over 4 years to gain a Therapy Title. That would not motivate them to follow the TICA program.

(B)
One therapy visit a month is the most I could manage, so I wouldn't want to wait years to be recognised.

Amend 907.4.4 (Title and Badge Prices) - Stadter

Rationale:

Apparently USD 5.00 does not cover the cost incurred through processing of the application and sending out certificates and badges.

Both the EO and the TICA Treasurer should be consulted on appropriate fees before deciding on the level to be set.

Amend Standing Rules 907.4.4

907.4.4 Recognition. Upon successful completion of each title level, the therapy cat will receive the appropriate certificate and badges on payment of the relevant fees, namely: \$[X] \$5.00 per title. (TC, TCX, TCD) and \$[X] \$5.00 per badge. (TC, TCX, TCD)

- (A) Agreed sounds good.
- (B)
 Rules had questioned whether the original proposal underestimated the cost of supplying titles and badges. Comments from Spring 2016 Agenda below:
 - (A) The fees of \$5 for a title and \$5 for a badge may not be realistic. I can't see how \$5 will cover the cost of supplying, processing, packing and posting a badge to anywhere in TICA's world. Whilst TICA is not required to make a profit, fees should at least cover the cost of providing that service.
 - (B) I agree with the concept of the program, but I agree with (A), it must not become a fiscal burden on TICA. People who seek to be active in pet therapy usually do so for good altruistic reasons and enjoy it and I don't believe they would be averse to a fee covering the costs to legitimize their good intentions in this age of litigation. What amount seems reasonable? Perhaps a prototype badge, etc be priced out plus a processing fee needs to be better determined.

Amend 2014.1.1 (Counts for Judges' Fees) - Parkinson

Rationale:

It seems that some clubs are confused about what to pay judges for. Some are paying for Exhibition Only cats entered in the show catalog as well as those competing. That was never the intent, but the rule is vague. So, here is a proposed standing rule amendment to clarify this.

Amend Standing Rule 2014.1.1:

2014.1.1 <u>Judges Fees</u>. Based on number of entries in the catalog **eligible for competition**; based on status of judge, not type of show judged.

- (A) Looks good to me
- (B)

 Definitely an improvement I would never have thought that judges would be paid for the Exhibition Only cats!
- (C)
 Clubs/entry clerks will have to make sure they give judges an accurate count of the number of cats in. competition. Since judges cannot look at the catalogs which contain the count summaries, the responsibility will rest with the clubs.
- (D)
 I understand there's been some confusion over counts coming from TOES which automatically calculates the judges' fees. I am informed by Erwin that cats entered as EX Only are not included in the calculation of judges' fees.
- (E)

CCCA - TICA Cooperation Framework

Respected TICA President and Board of Directors,

We feel so excited that CCCA's application for TICA club was approved in Portland. We would like to develop our business in China based on TICA's rules.

We, hereby, present some suggestions and objectives for our cooperation. We expect that the principals of the boards of directors from both parties discuss the proposal further. Or, we can take the cooperative agreement between TICA and the club in Nice as reference.

Terms of Cooperation:

- 1. CCCA shall be the only club in cooperation with TICA in China Mainland and TICA logo shall be printed on CCCA pedigree;
 - 2. CCCA shall hold shows in China Mainland in TICA system, not in other systems (such as CFA system);
- 3. CCCA shall be in charge of issuing pedigrees in China Mainland; both parties shall negotiate on the pattern of the pedigree; the logos of CCCA and TICA shall be printed on the pedigree;
- 4. CCCA shall be in charge of registrations related to TICA pedigree application in China Mainland, including microchip implantation, review of parent cats' breeding qualification, DNA collection of kittens (if necessary), certificate creation and issuance;
- 5. CCCA shall be in charge of TICA's registration of international membership and cattery names in China Mainland; TICA reserves the right to review the membership qualification and to register the cattery name;
- 6. CCCA shall hold over 20 shows in TICA system in China Mainland every year and the results shall be included in TICA's standings;
- 7. CCCA shall be in charge of clubs application and management in China Mainland: the registered 31 clubs under CCCA and registered clubs under TICA in China Mainland shall be in the charge of CCCA;
 - 8. CCCA shall invite TICA All-Breed Judges for judge training in China Mainland based on TICA's rules.

The terms can be categorized into three parts: first, CCCA shall organize shows in TICA system; second, TICA is in charge of the registration of international members and catteries; third, the pattern of pedigree shall be decided after negotiation between both parties and the pedigrees shall be issued by TICA and CCCA jointly in China Mainland.

We look forward to the reply from TICA Board of Directors!

Guest Judges & Licensed International Guest Judges

Rationale - Right now we do not have included in the Judges Rules how much a Guest Judge and a Licensded International Guest Judge shall get paid. I think that the Board shall make a decision as this is a very important guideline both for the clubs and judges. Furthermore I also want to discuss if a Training Session with a LIGJ counts officially or not. Right now the Rules state clearly that only training sessions held by Approved Allbreed Judges count. But I checked and found out that one trainee used a training session with a LIGJ to fulfill the 40-Training-Session requirement to advance. I think that this needs clarification and should not be up to the Judging Administrator/Allbreed Sponsor to decide. Right now clubs pay LIGJ the same amount like an Approved AB Judge. This is for me not really okay because in this case there is no motivation for the LIGJ to take the exam to become finally a TICA Judge / Approved AB Judge.

Dear Mr. President, Officer, Members of the Board, Chairs of the Rules and Genetics Committees, and Mrs. Leslie Bowers, Executive Director, TICA:

Thank you again for giving us the opportunity to show our wonderful breed – the Australian Mists in TICA's world and also for giving us the yearly opportunity to brag about them as well.

As most of you know, we have just completed our second year in championship. This year we added two more supreme grand champions, several m,ultiple grand champions, and attained three Reginal Top 25 wins – one in the Mid Pacific Region in the Alters, and two in the Norethwest Region – one in the Altrs and one in cats. Further – if we can borrow a few wins from the current show season – one female has now produced enough TICA grand champion offspring to become TICA's first Outstanding Dam Australian Mist. Her name is Thera Marmor Bell Amaraf. She was bred by our breed founder Truda Straede and was imported and is owned by Erma Goforth and myself. (NW Region)

The highlight of the year, at least for many of us in the USA and others in TICA's world, was the visit of Dr. Straede to the US and the TICA Annual in San Diego. Dr. Straede was given the opportunity to speak on the breed both as part of the CEU and also very briefly during the show. Several TICA judges and trainees did attend her talk. Another result of her talk was the eventual importation of Australian Mists to Japan – where a new breeder is getting started and we look forward to seeing his cats in the show ring.

I personally had a wonderful time visiting with Truda after picking her up in San Francisco. We travelled down to San Diego on the coastal route where she got to see some wonderful scenery — including the coastal redwoods near Santa Cruz. Dr. Strade's dissertation was on certain types of trees — so she was fascinated by the huge redwoods. She was also surprized at seeing her first squirrel. They don't apparently have squirrels in Australia. We had many fine discussions and saw many animals and plants along the way — but it apparently was too much for the highway — as a big chunk of it fell into the ocean this year......

Truda also brought presents for the breed winners for the year. It was also my sincere pleasure to receive the 12th Riki award from Truda at the Annual. The Riki Award is very special in the Australian Mist community. It is named after one of the all time favorite Australian Mists – Awatea Kohu Ariki - and is presented to individuals who have made exceptional contributions to the breed.

I also gave a breed presentation at the CEU hosted by Skyway Cat Club in Florida in May of 2016.

We have had some discussions among the breeders and exhibitors about the breed standard. We feel

that the majority of the standard is very good but we will be recommending some slight changes as we go to permanent status this next year. Part of the difficulty is the use of the word "medium" in many places.... and how some of the judges are interpreting it. We look forward to working with you on those changes.

Another very exciting thing that has happened this year is that breeders in the United Kingdom and Dr. Straede in Australia have almost at the same time – initiated bringing in new outcross domestic blood into the Mist genepool. Another Mist breeder in Australia started an outcross program about two years ago – but so far nothing from that line has been exported. It has been around ten years plus since Truda introduced her last outcross. These cats will of course – have to work up through the 4 generations in order to reach stud book ranking.... We have a lot more tools available now with genetic testing – to select for specific criteria.

Per the Registration Rules, we are required to provide you with the following information and to meet or exceed certain requirements. We met or exceeded them all.

Our thanks to the Board for accepting our application for advancement to Championship at the 2016 winter meeting! We have had an exciting year and a half since advancing with Donskoy cats shown at over 30 shows in 9 regions, with over 20 Donskoy cats shown in the 2016/17 season alone! There is a growing interest in our breed and we are confident that this will be reflected with a continued increase in the numbers of Donskoys shown across the globe.

We have achieved all of the TICA requirements to retain our Championship level. We have shown over 23 individual Donskoy cats in the last season, from 25 shows and in over 300 judging rings.

There have been approximately 40 Donskoys registered during the last season, with 18 of those being registered since January 2017.

We currently have 14 members of our breed group, some of whom (at least 6) are breeders who are actively breeding. A number of others have intentions to begin breeding their Donskoys and start their own Donskoy breeding programs. There have been 8 litters registered since January 2017, and during 2016 there were 40 litters registered.


There has been one breed seminar conducted in the last season - on the 28th of May by Becky Brown in conjunction with a Peterbald seminar presented by Susanna Shon to provide

comparisons between the two different but related breeds - which has been well received, and we are hopeful in holding another this season.

We have seen Donskoys across the globe achieving their champion, grand, double grand, triple, quad and even a supreme title during the 2016/17 season which was a huge achievement for all cats and owners concerned and a real testament to the quality of Donskoy being shown.

We have had the opportunity to promote our breed at Pet Expos and vet conferences since our advancement, including:

- The Tampa Bay Pet Expo in April 2016 with the TICA promotion stall.
- The South West Veterinary Symposium in September 2015 in conjunction with TICA promotion.
- TICA's 'Meet the Breeds' Convention, February 2017 in conjunction with the American Kennel Club. Thousands of people attended this event and the Donskoy was photographed by many news sources. The exposure was seen nation wide in print, on television and online.
- We have also been published in a variety of magazine and web sites. Twice we have been in CATSTER Magazine. First on the cover and featured in the premier edition of CATSTER when the name changed from CAT FANCY May/June 2015, and again in the July/August 2017 edition on the top friendly cat cities.
- As breed chair, I contributed to an article in the French magazine TOILETTAGE MAGAZINE.
- I also wrote a breed description for the online site <u>CATOVERDOSE.COM</u> to be published in 2017.
- My Doneden cat ALEF DON RAMZES/WC and I have become a registered PET PARTNERS Therapy team of Southern New England achieving the highest COMPLEX rating.
- Important Genetic research is being worked on with the Donskoy Breed. When one of my Doneden litters produced a "Chocolate" looking kitten I reached out to UC DAVIS to identify the color. When they were unable to identify the color I also contacted ORIVET to retest. The results were the same. They could not identify the color. This led me to contact other breeders in Germany, Russia and the Ukraine who also had these kittens with red pupils and "chocolate" color. I reached out to Veterinarian and genetic researcher Marie Abitbol, DVM, PhD, HDR, Lyon School of Veterinary Medicine, France and she eagerly began research on this unverified color. She has received a grant in 2017 to fund her work on identifying the gene responsible for the unverified Donskoy color trait. The Highlander Breed Group Report: 2016-2017

 The Highlander seems to be slowly gaining popularity as more people become interested in our breed through increased presence at the show hall and in breed outreach online, our breed section membership has grown from last year and we are now at 23 members.

Highlander Litter Registrations

 In the 2016-17 TICA year there were 95 Highlander litters registered from 18 different catteries, which is a small decrease in the number of registered litters compared to the past year.
 Unfortunately, I did not receive a breakdown of the registration codes for each litter.

Individual Highlander Registrations

- In the 2016-17 season, there were a total of 49 Highlanders registered, which is a decrease from last year, but represents a greater percentage of individual cats to be registered from the litter total.
- Of the individually registered kittens: 3 were 02T registered, 5 were 03T registered, 2 03V registered, 7 A2P registered, 6 B3P registered, 3 C3P registered, 4 C0P registered, 17 SBT registered, and 1 SBV registered.
- The even spread of codes show that while we are working for consistency in our breed, we are also working on improving the number of lines of cats to decrease the chance of breeding. We also been testing for the tail gene so that we can eliminate any detrimental Manx genes.

Highlanders in the Show Hall

• 26 unique Highlanders were shown in 15 different shows and 5 different regions representing 13 different catteries in the 2016-2017 show season. This has been a grown year in the show hall as we expanded into the European and International Regions.

Summary

- In review, in breed section membership, the Highlander breed has grown in membership and has increased in the number at the show halls. There was a decrease in the number of cats registered but this should be only temporary as our new members register their cats.
- Our focus is to improve the consistency in the breed amongst the catteries, increase genetic testing and increase genetic diversity.

SERENGETI CAT BREED REPORT JULY 17, 2017

Dear Board Members,

Thank you for allowing me to make this written report to the Board. I am sorry that it has been submitted late. I did lose track of time and then was not able to find anyone in the TICA office to produce the usual reports. The staff was very willing to help, so I sent them copies of all of the prior year's reports that I have received which have been invaluable in helping me to see and, at some level, guide the breed development. Using those as a guide, I was able to get some of the data over the last week.

Starting the summer of 2016, I begin my efforts to find a new home for myself and my cats after living in Southern California for 55 years. I did move to Southern Arizona in November. I mention this only to have you understand why I wasn't able to be very active in showing and shepherding the Serengeti Breed Group during the last year. My plan is to continue my efforts to develop the breed as the feedback from my kitten owners is extremely positive. Also, as I will be outlining later in the report, the breed is gaining more and more TICA breeders throughout the world. There are several Facebook Groups devoted to the breed including one in the UK and one in Russia. I am only responsible for starting two of them.

Statistics as of May 2017:

Serengeti Breed Group has 9 members. There are far more breeders in TICA, but it always seems to be a challenge to get people to realize that they should activate their membership in our Breed Group.

There were 37 serengetis individually registered last year. Most were in the UK and in Russia. They were bred by 11 different breeders. The total individual serengetis registered now stands at 580.

I did not receive information on the total number of litters registered for 2016, but I know that as of the May 2016 report (a year ago) we had 345 litters registered representing 1329 live kittens.

Sadly there were only 3 shown last year – 2 in the UK and a girl I showed.

I am now fully settled into my new location and will carry on developing the breed.

I want to thank Bobbi Tullo, Anthony Hutcherson, Judy Sugden and Pat Killmaier for their continued support and Jay Boden, Jackie Morris, Lesley Dart and Carol Hope in the UK for their efforts on developing the breed in that part of the world.

Supporting letter for Deutsch Langhaar (German Longhair) breeders

Dear Board Members, dear TICA members, dear Catfriends,

If breeders of a new cat breed ask for a documentation in an experimental studbook, some people usually work with negative signs.

The first argument is: there are enough breeds. I remember the FIFe recognition process of the Maine Coon in Europe. Barbara Simon and many others had to fight against the opinion of most FIFe judges: "... why do we need an American Longhair Cat? There are enough breeds! You can breed and show Norwegian Forest Cats! ..." The result: many, young, new Maine Coon breeders founded new independent clubs and the German FIFe club had lost many, many members.

If my information is correct one reason why the TICA was founded was CFA board had slowed down the recognition of the Maine Coon in the 1970. In its first year TICA had recognized the Maine Coon and the Ragdoll Cat.

Regarding the Ragdoll Cat: if my information is correct the friends and breeders of the Ragdoll Cat, who asked for registration, had heard the second and third argument: this isn't a breed and this cat looks similar to other breeds (Himalayan, Birma). Is the Ragdoll Cat a breed? Does a Ragdoll Cat look like Birma or Himalayan today?

I remember the time Siberian Cats were smuggled via trains from East to West. The first reaction of the European Cat Fancy was: ".... they look similar to the Maine Coon and the Norwegian Forest cat..." But the Siberian Cat got a chance. Its breeding program was documented. The Siberian Cats were allowed to be shown. The breeders have done their homework and today a Siberian Cat does not look like a Norwegian Forest Cat or Maine Coon.

The fourth argument: there are not enough breeders/cats of the breed. If my information is correct there was a serious suggestion in Europe in the 1960. All longhaired cats - except Persians - should be grouped together in one breed named International Longhair. The reason: there were not enough breeders and cats of others longhaired breeds.

Recently there seems to be a trend for old and almost forgotten breeds. The Deutsch Langhaar (German Longhair) is an old breed from the middle of Europe. There are old books describing the Deutsch Langhaar (German Longhair) dated in 1920, photos dated from 1930. The first show standard of German Longhair written by Dr Friedrich Schwangart (1874-1958) is dated in 1929. Deutsch Langhaar (German Longhair) breed was recognized by WCF in 2012 and many other independent club (Championship!).

If the board need more information about German Longhair - please ask - the board will get it. If the board want to see German Longhairs, some cats have to get the chance for the presentation e.g. to be in a showhall in Germany.

The TICA made good experiences with an open concept. All the time TICA offered a home for ideas, new breeds and new breeders.

My TICA does not build walls. My TICA is fair.

It is time to open the experimental studbook for German Longhair Cats.
