Motion was made by Vlach and seconded by Fisher to amend the Judging Program 42.3: A longhair/shorthair specialty applicant shall have bred and/or acquired as a kitten (5 months of age or younger) and shown to TICA Grand Champion status a minimum of two whole cats in the applicant's breed specialty and one cat of opposite coat length/body type (may be an alter). The cat of opposite coat length/type must be owned or leased by the applicant and **must reside with the applicant**.
- 42.3.1 At least one whole cat bred and/or acquired by the applicant as a kitten (5 months of age or younger), shall be shown to Supreme Grand Champion status.
- 42.3.1 Applicants applying under the requirements of 42.2.5.2 must have shown to TICA Grand Champion or Grand Champion Alter five cats from both the longhair and shorthair breeds, with no fewer than three from one coat length/body type and the remaining from the opposite coat length/body type. One Supreme Grand Champion or Supreme Grand Champion Alter and Regional Winner must be in the opposite coat length/body type from the primary coat length/body type Motion carried unanimously.

- 42.2.5.1 (For Breeders) Prior to being granted a Probationary Specialty License shall have been breeding cats for at least 5 years; shall have bred a minimum of five TICA registered litters; *and shall* have shown in at least 25 TICA shows (back-to-back shows will be considered as one show).
- 42.2.5.2 (For Non-Breeders) Prior to being granted a Probationary Specialty License shall have been actively showing cats in TICA for a minimum of 5 years; shall have acquired cats at 5 months of age or younger; shall have shown a minimum of five cats to TICA Grand Champion or Grand Champion Alter, three of which must have achieved the title of Supreme Grand Champion or Supreme Grand Champion Alter; shall *have* achieved a minimum of three Regional Wins in the Top Ten; *shall* have shown in 25 shows (back-to-back shows will be considered one show).

The "third generation" requirement means that the non-domestic ancestor is no closer in relation than a great-grandparent.
- 203.9.2 Savannah. Savannahs with a 3rd generation non-domestic ancestor may be shown in Preliminary New Breed (PNB) or Advanced New Breed (ANB) with full disclosure for any judge handling the cat. The "third generation" requirement means that the non-domestic ancestor is no closer in relation than a great-grandparent.

The Master Clerk shall provide the judge with a receipt indicating that the judge's book has been received. The judge shall retain the pink copy of his/her judge's book and the receipt until 45 days after the close of the show season, at which time the judge's book and receipt may be discarded.
- 2017.1.1 At the completion of the show, the Master Clerk shall submit the marked catalog and ALL judges' books to the Show Manager or designated member of the Show Committee. The Show Committee shall be responsible for mailing the Master Catalog and Judges' Books in accordance with Standing Rule 209.1.1.4.

Show Rules:

- 209.1.1.4 <u>Marked Catalogs</u>. The Show Committee shall forward the Master Catalog and ALL Judges' Books to the Executive Office within 48 hours after the close of the show.
- 209.1.1.4.1 It is suggested that priority mail and/or an express delivery system be used rather than regular mail. In regions outside of North America, it is recommended that the senior US Allbreed judge be appointed by the Show Committee to transport all judges' books and the Master Catalog to the US and forward them to the Executive Office within 48 hours of his/her return or within 8 business days of the close of the show, whichever is earlier.
- 209.1.1.4.2 Failure to forward the Master Catalog and judges' books in accordance with 209.1.1.4. or 209.1.1.4.1 shall result in a fine to the Club of \$ xxx.xx.
- 209.1.1.4.3 Additionally, the Show Committee shall forward a fully marked catalog to the regional reporters and the appropriate regional director within 48 hours after the close of the show. The Show Committee is required to forward one completely marked catalog to the judging administrator, to each

judge, the master clerk and to any person who ordered a marked catalog NO LATER THAN 7 DAYS AFTER THE SHOW. The show committee shall also send a catalog marked with the finals page(s) and the appropriate breed awards to each certified ring clerk within 7 days after the show.

- 2016.5.1 A judge must have the ability to remove from and return to the judging cage every cat entered in the show, except for those cats not amenable to handling. In the event that a judge believes that a cat may not be amenable to handling, the judge may request that the owner or agent remove the cat from and/or return the cat to the judging cage.
- 2016.5.1.1 A judge must disclose an inability to meet the minimum handling requirements to the club at the time the club offers the judging assignment to the judge or, as soon as such inability is known to the judge.
- 2016.5.1.2 If the inability to meet the minimum handling requirements becomes known to the judge after entering into the judging contract, the judge must notify the club of such a change of circumstances as soon as possible. Either the club or judge may, at that time, cancel that judging contract.
- 2016.5.2 In the event that a judge is unable to meet the minimum handling requirements, the **club** must:
- 2016.5.2.1 Contract a handler at the time of contracting the judge or as soon as the inability of the judge to meet the minimum handling requirements becomes known. The handler must be a licensed judge or a trainee. (Show Rule 216.1)
- 2016.5.2.2 List the handler on the flyer with the judge or, if the inability to handle is unknown until after the assignment is published, list the handler on all revisions of the show flyer, and on all other show announcements including the show schedule.
- 2016.5.2.3 Compensate the handler with lunch on the day of handling, a fully marked catalog and **the handler's choice** of <u>either</u> one night's hotel OR a minimum of \$xx.00. [Suggested options: \$35.00, \$50.00, \$75.00].

Motion carried with Basquine, Fisher and Parris opposed. Parris was opposed because her clubs don't want an amount in the rule.

The cumulative points of the [30] 50 judgings of each registered kitten and each household pet kitten carrying the highest point value will be used to determine the aggregate Regional and International points for each registered kitten and each household pet kitten.

- 414.6 The completed annual Judge's Record Form must be sent to the Judging Administrator/Designee with a postmark, fax or email date NO LATER THAN June 30th of each year. The annual Record Form lists a judge's activities (shows. CEU's, etc.) for the previous show season (May 1st April 30th). Judges Emeriti are exempt from the Record Form requirement.
- 414.6.1 Not less than a 4x6 professional color photograph must be sent to the Yearbook Editor once every 3 years and NO LATER THAN June 30th of said years as a requirement for relicensing.
- 414.7 Each judge's license shall be reviewed at the scheduled Semi-Annual Board Meeting. To all approved for relicensing, the Judging Administrator shall issue a judge's license by April 15th of each year, which shall be effective for May 1st through April 30th of the following show year. Not less than a 4x6 professional color photograph must be sent to the Yearbook Editor once every 3 years as a requirement for relicensing
- 414.7.1 The Board may vote not to relicense any judge as it deems necessary for the benefit of the Association.
- 414.7.1.1 Should a judge not be relicensed, he/she shall return his/her Judge's License to the Judging Administrator within 30 days of such notification
- 414.7.2 The Board may vote not to renew a judge's license for the upcoming show year, based on missing requirements. It may advise the Judging Administrator to issue a license when the missing requirements have been met. The license has not been revoked, it has expired; it may be renewed upon meeting requirements for renewal
- 414.7.3 A judge's license shall not be renewed if that judge has any outstanding fines. The Board may instruct the Judging Administrator to renew the license when the fine(s) has/have been received in the Executive Office

The TWiG of a cat is calculated by adding the TWiG of the sire and the dam of a cat, a domestic cat having a TWiG of zero percent and wildcat having a TWiG of 100 percent, and dividing the total by two. HEAD:

Shape: Modified wedge, medium in size with a long, sloping forehead and high ,angular, long cheekbones that meet a strong, full muzzle and chin. A change in direction at the sides of the muzzle gives the appearance of rounded whisker pads.

Eyes: Medium, slightly flattened oval and set on bias to just below the outside edge of the ear. Gold or yellow eye color preferred, hazel to light green allowed.

<u>Profile</u>: Long sloping forehead flows into the rise between the eyes, continuing down with good length, to meet the nose bump, which is rounded where it meets the convex nose leather.

<u>Ears</u>: Tall, large ears should be placed fairly close together on top of head with a wide base cornering the head and the ear set at a slight outward angle. The ear itself should be fairly wide all the way up with rounded ear tips. Ear tufts preferred, lack of tufts not a penalty.

Neck: The muscular neck is of medium length and thickness.

Muzzle: Proportionate to the cheekbones and length of nose, with full whisker pads.

<u>Chin</u>: Strong, full, both in profile and frontal view *with depth* resulting from good bone structure.

Nose: Medium-wide slightly broader between the eyes. Nose leather is convex and full.

BODY:

<u>Torso</u>: Long, lean and *muscular, firm to the touch*; the large rectangular body is strong and athletic, with a *balanced* chest and good depth of body without any roundness of the ribcage.

<u>Legs</u>: The legs are moderately long, well muscled with medium boning. The hind legs are slightly longer than the front, as the cat is built for running and leaping.

<u>Feet</u>: The feet are round and small in comparison to the overall size of the cat.

<u>Tail</u>: Three-quarter or full length tail acceptable; the 3/4 tail has fewer vertebrae and is preferred. Both tail lengths should be of medium thickness and fully articulated.

<u>Musculature</u>: The musculature of the Chausie is long and lean rather than bulky.

Boning: The Chausie has medium leg boning with long, lithe legs, while the torso is substantial with good depth.

COAT/COLOR/PATTERN:

<u>Length</u>: Short to medium, with enough length to accommodate at least two bands of ticking. Not open.

<u>Texture</u>: A dense, softer undercoat with a harder resilient texture to outer coat.

COLORS:

Brown ticked tabby: A mouse-gray color next to the skin with sandy-gray to reddish-gold base coat. The coat will have two or more bands of color in the ticking. Reverse ticking and/or flecking may also be present. There should be tabby markings on the face and barring on the legs and tail. Barring on the front legs appears primarily on the upper front and inside of the leg, With the inside being more bold than the outside. The barring on the front legs may be more bold than on the hock of the back legs. The tail should be black-tipped. Barring may or may not be present on the neck. Faint tabby markings on the body may be present but not preferred. The backs of the ears will have "thumbprint" markings of a lighter color. A white or off-white color should outline the eyes and muzzle. Nose leather pink to brick red. The underside will range in color from white or off-white to sandygold. Stomach may appear flecked, speckled or spotted.

Black: Solid black.

<u>Silver tipped</u>: This pattern is a new gene that appears to be a form or modification of ticked tabby in that it is grey or lighter at the skin followed by black and is marked by lighter bands of color or ticking on the shaft ending in black tips. Faint tabby markings on the torso may be present but not preferred. Ear furnishings will appear silver and will be banded. Nose leather is black, The Silver Tip gene is a dominant gene found in the Chausie breed as a result of the Jungle Cat ancestor used to develop this breed.

GENERAL DESCRIPTION: The Chausie is a statuesque cat, tall, upright, medium to large framed with legs more moderate in boning giving the cat a tall, slender-legged look. Its musculature is that of an agile hunter with great jumping ability. They have large upright, tufted ears. Males will be proportionately larger than the females. The overall appearance should bring to mind the Middle Eastern/Asian Jungle Cat as the breed retains a strong resemblance to it's ancestor. This cat is good-natured, loyal and intelligent and should be amenable to handling showing no signs of challenge.

ALLOWANCES: Variation in tail length starting from just below the hock (3/4) to full length. Slight ghost body markings on kittens. *Black paw pads with rosy or pink overtones allowed.*

PENALIZE: Vivid green eyes. A cat that is too refined or too heavily boned. A cat void of tabby markings on the legs or tail.

WITHHOLD ALL AWARDS (WW): True classic pattern. Any colors other than the three allowable colors. White lockets.

DISQUALIFY (DQ): Tail too short, resulting from a mutated gene (MX/PB/BB). Tail kinked or lacking flexibility.

Temperament must be unchallenging; any sign of definite challenge shall disqualify. The cat may exhibit fear, seek to flee, or generally complain aloud but may not threaten to harm. <u>Shape</u>: Long, inverted triangle, measuring from ear tip to ear tip to blunted chin, forming a wedge.

<u>Ears</u>: Extra large, pointed, and broad at the base, slightly flared. Set to extend just below the line of the wedge.

<u>Eyes</u>: Medium in size, almost almond* in shape. Obliquely set, flush with the skull, neither protruding nor recessed. Distance between eyes not less than width of one eye. Eye color independent of coat color.

<u>Profile</u>: Almost straight profile with slightly noticeable angle from forehead to nose; two-planed. Flat forehead.

<u>Muzzle</u>: Strong, smooth, slightly blunt. Not narrow. No whisker pinch.

Chin: Strong, tip of nose in line with tip of chin. Not protruding.

Neck: Long and slender.

BODY:

<u>Torso</u>: Medium-sized, long and graceful. Shoulders and hips equal in width.

<u>Legs</u>: Long, medium-fine boned. Firm muscles. Straight vertical forelegs. Hind legs slightly longer than front legs.

<u>Feet</u>: Oval, medium in size with long, agile prominent toes and a discreet, non-prominent foot pad.

Tail: Long, strong and whippy.

Musculature: Firm and well-developed.

Boning: Medium-fine.

COAT

The Peterbald coat ranges from completely hairless, to a flocked or velour coat, to a brush coat. The gene which causes the Peterbald coat is a "hair-losing" gene rather than a "hairless" gene. All coat types are accepted and no preference should be given to one coat type over another. Instead, attention should be paid to the quality of the coat type.

The hairless Peterbald has soft, warm skin that feels almost sticky, but not oily, to the touch. The texture is chamois-like. The hairless Peterbald may have wrinkles all over the body. The flocked or velour coat ranges from a short fine, sparse down to a slightly longer, closer down which offers resistance to the hand

when stroked. The flocked or velour coat may appear hairless until touched. The texture is suede-like.

The brush coat is one of the Peterbald's most distinguishing characteristics. No other breed has a coat similar to this. The brush coat is a dense, wiry coat of irregular texture, ranging from soft to coarse. Brush coat may range from one-eighth to one-quarter inch, but should in no way feel or look like a normal coat when closely inspected.

In some instances, a Peterbald may combine coat types. For example, a cat may have brush coat on the extremities (i.e. muzzle, ears, legs, tail) and have a flocked or velour coat on the body. In such cases, coat that is retained on extremities is short, close lying and downy in texture, rather than the typical wiry texture.

GENERAL DESCRIPTION: The overall impression of an ideal Peterbald is an elegant and intelligent cat. The Peterbald has a sturdy, lean elongated body that contributes to its graceful movement. Peterbalds originated in Russia in January, 1994. They were originally produced by mating an Oriental Shorthair with a Don Hairless (Don Sphynx). The original litter demonstrated that the Don Hairless gene is a dominant gene, unlike the Sphynx gene. It also demonstrated various unusual coat types, including the distinctive brush coat.

LOCKETS: Allow

PENALIZE:

<u>Head:</u> Curved profile; weak chin; muzzle break. <u>Body:</u> Heavy, rounded body; bowed forelegs.

Savannah 2005 Semi-Annual Breed Report

Progress:

This is a short report for this meeting of the Board.

The Savannah breed is currently in Advanced New Breed Status, working towards becoming a Category IV Championship Breed. Savannahs are being shown at nearly every TICA show, in such numbers that tracking the actual statistics proves difficult.

We have continued to push the idea that TICA membership is most desirable for Savannah breeders, as TICA is the Association that has most energetically championed the Savannahs. Other Associations either do not support the Savannah at all, or they do, but their membership and activities are so limited that the breed gets little visibility from it.

Most Savannah breeders are currently TICA members and are currently registering their cats in TICA. There are over 100 Savannah Breed Sections members currently. We have reached the point where large numbers of third and fourth generation Savannahs are being registered, and we are now getting fertile F5 males, a long time goal of the Breed. With fertile F5 males we will have other options for our females than simply continuing to outcross to other breeds.

With the Permissible Outcrosses approved at the 2004 Annual meeting we have given Savannah breeders the chance to continue to work towards Championship. As a result of this action, many Breed Section Members who have invested countless dollars in cats now have progeny that will be counted toward our goal of creating a Championship breed.

We do not have a count of the number of Savannahs that have been bred, registered or shown for this year. The breed had reached the point in its development where Savannah breeders are members of several separate clubs with limited contact with each other.

Previously, I reported to the TICA Board, Simbabies, one of the co-hosts of the World Cat Congress, was a 501 c3 corporation. We incorporated with the intent of being a tax-exempt entity to affect rescues of servals, Savannahs, other hybrids and felines in general, with the intent to be good stewards of our breed and responsible and worthwhile members of both TICA and Simbabies. Despite being involved in many rescues, at considerable expense to our members, the legal steps to complete the process with the IRS are yet undone by our attorney. Simbabies has not accepted any illegal donations from our benefactors wishing to donate. The benefactors are still sitting on the sidelines willing and waiting to donate funds to our efforts. The entire reporting of our status, by me, to the Board, was due to the advice of our incorporating attorney/board-member/TICA member informing our Simbabies Board to go on ahead as the tax exempt status would be retroactive. I am currently taking the steps to accomplish the tax status with a different attorney and it should be completed soon.

We would like to thank the Board for its continued support of our breed.

As you can see above, advertising income was down in 2004. Commercial advertisers continue to advertise with us and we continue to gain more commercial advertisers, but we saw a dramatic drop off in show advertising during the first half of the year. The sale price for show ads announced in the June/July 2004 Trend turned this around and has been so popular that I will make it permanent. We also had less member advertising in the regional and international awards Trends (Numbers 4 and 5). This combined with the original drop off in show advertising makes me think that the increase in advertising rates at the end of 2003 was a factor along with the continuing poor economy. (Two previous advertising rate increases were also followed by a year of reduced advertising.) However, members were so pleased with how their catsÕ photos looked in the awards layouts created for TICAÕs 25th anniversary, and with the new glossy paper, that I am hopeful of seeing a return to normal advertising this coming year.

I am pleased to report that the cost of switching the inside pages of the TICA Trend to glossy paper has stayed within the original estimate. I regret to report that I made a mistake at the Annual when I told the Board that glossy paper would not increase the cost of postage. I thought that switching from 70 pound paper to 70 pound paper meant the per page weight would remain the same; I have since learned that O70 pound is the description of the cotton content within the paper, not of the actual weight of the paper.

To give you an idea of the weight difference, the 36 page December/January Trend published on glossy paper weighed 134 grams, compared to 94 grams for the 36 page June/July 2004 Trend published on the cheaper paper. This increased weight made little difference in the cost of US postage since US postal rates, especially for bulk mail, start low and increment up in small amounts. However, it made a noticeable difference in the cost of international mail.

In addition to this, we also had a international rate increase with the October/November Trend. This has been expected for several years: After 9/11, increased security measures to keep the mail safe dramatically increased international postal rates to pay for the added security.

The following are estimated annual increases in costs based on the Trends we produced in 2004. Please keep in mind that the number of pages we print each issue, the number of copies we print each issue, and the number of copies we mail internationally each issue are variables affecting costs that I cannot predict with any certainty:

effect of a 6% International Rate Increase: \$565.00 more per year

effect of a 26% increase in international postage due to the increased weight of

glossy paper: \$2,000.00 more per year

increase in cost of publishing Trend

on glossy paper: \$5,700.00 more per year

Total additional cost of the Trend

if we continue using glossy paper: \$8,263.00

Note: International postage is extremely difficult to estimate accurately. We pay a flat per piece price based on weight, not destination. For example, using the two 36 page Trends mentioned above: The one printed on cheap paper cost us \$1.60 per piece at the old rates; it would cost us \$1.69 per piece at the new rates. The one published on glossy paper, with the increased weight, would have cost us \$1.90 per piece at the old rates; it cost us \$2.01 per piece at the new rates. So although I have done my best to provide a reasonable estimate, weight makes a tremendous difference in actual cost.

I also received a letter from our international mailer stating that there will be a 4% increase in rates effective January 16, 2005. This cost increase is due to the dramatic increase in the price of fuel, a yearlong decline in the value of the dollar vs the Euro, an 8% increase in REIMS II (remuneration of mandatory deliveries of cross border mail), and a 4.5% increase in Canadian postal rates.

Despite the rate increases at the international mailer, we are still saving a lot of money over using the US Post Office. The October/November Trend was our most expensive Trend to mail internationally: we paid \$2.18 per piece. I mailed the same Trend at the US Post Office to the UK for \$4.80 and to Australia for \$5.40; the post office stated it would have cost \$5.30 to mail that Trend to Japan.

Despite increasing costs, both those out of our control and those caused by the switch to glossy paper inside the Trend, I recommend that we continue using glossy paper inside the Trend. Our members have been resoundingly pleased with the new professional look of the TICA Trend.

Most new TICA members do not register cats when they join, therefore, the registration of cats is not indicative of a "legitimate" member. Thus, the new Asia members are no less legitimate members than any other new members and therefore the proffered explanation that these new members were interested in shows is reasonable and believable.

Affect of New Asia Members on the Election Result

- •314 votes for Motoko Oizumi
- •32 votes for Shunichi Kuroda
- •3 votes for write in (Yukimasa Hattori)
- •Even if all votes of the 234 new Asia members are discounted, Mrs. Oizumi would have won the election 80 to 32, and the result of the election would not change!

Conclusion

There is no reason to believe that any of the new Asia members differ from any new TICA members, nor did these new members affect the election in any manner, therefore no tampering with the election process occurred.

Feline Welfare Committee and Rescue Presentation

- I. Opening Statement: Thank you for this opportunity to speak about the reorganization of TICA's Feline Welfare Committee and the organization of TICA's Rescue Committee. TICA needs to take a proactive approach to feline welfare and rescue as opposed to a reactive approach.
- II. Presentation: Necessity for an active Feline Welfare Committee
 - A. A committee to arbitrate complaints regarding feline welfare
 - 1. Notify appropriate TICA officials of complaint
- 2. Develop procedures to assist TICA members in need to help prevent complaints being filed or to arbitrate complaints after they are filed to keep them from having to go to the board for resolution
- 3. Develop procedures to identify problem areas within TICA prior to complaints being filed
 - B. Education
 - 1. Appropriate education will help prevent emergencies and reactive situations
 - 2. Education is necessary to promote feline welfare for breeders and pet owners
 - C. A committee TICA members can contact for questions on feline welfare
 - 1. TICA is a cat registry; TICA is Feline Welfare
 - D. A Committee to market the Voluntary Responsible Breeder Program
 - 1. Develop controls to guarantee a licensed veterinarian does the cattery evaluation
- E. A Committee to handle issues and problems and be proactive in regard to feline welfare and handle problems before authorities have to step in
- F. Any organization working with or having anything to do with animals cannot operate without a Feline Welfare Committee
- G. The Feline Welfare Committee is part of TICA's Standing Rules, #106.2.5, it should be viable, active and available to TICA members
- H. A committee that show committees, Judges, exhibitors and other interested parties can report problems/issues at cat shows or other locations
- III. Organization of Feline Welfare Committee
 - A. New Chair must be a current and active TICA member Present Chair resigned
 - B. A minimum of one Committee Member in each TICA Region
- 1. New Committee members, current members are inactive and most TICA members were unaware the Committee exists
- 2. Appointments to the Committee will be made by Regional Directors and must be current TICA members and active within TICA
- C. Set up one Yahoo List for the Feline Welfare Committee and the Rescue Committee to hold meetings and have discussions
 - D. Goals and Objectives
 - 1. Develop polices and procedures and guidelines for the Committee

- 2. Develop procedures to utilize committee members expertise for handling questions and other issues to help prevent complaint from being filed
- 3. Develop policies and procedures for handling complaints and arbitration of the complaints to help prevent complaints going to the board
 - 4. Develop reporting procedures for complaints that cannot be arbitrated
 - 5. Make recommendations to the board for programs involving Feline Welfare
 - 6. Develop forms for feline welfare programs and issues
- 7. Develop a form for questions regarding feline welfare and refer the form to the committee member with expertise dealing with the question
 - 8. Develop procedures for assisting TICA members in need
- 9. Develop voluntary inspection procedures for TICA members either requesting a cattery inspection or members requiring assistance needing inspections of their catteries or foster homes
- 10. Develop informational documents and publications for educational purposes to distribute to TICA members and promoted by TICA
 - 11. Develop procedures for working with Legal on issues dealing with feline welfare
- 12. Breeder and pet owner and Household pet exhibitor education programs, seminars and publications
 - E. Necessity for a TICA Rescue Committee
- 1. In recent years rescue numbers have risen substantially these numbers include purebred cats and TICA members and/or TICA catteries
- 2. Rescue is necessary for the welfare of the cats being shown in TICA as well as other cats owned by TICA members
- 3. Many TICA members are involved in rescue so it would be easy to mobilize and organize these efforts
 - 4. Education
- 5. CFA Purebred Rescue has many TICA members working physically with them and donating funds to their rescue efforts
 - a. TICA as on organization needs to be more involved
 - b. TICA needs to take credit for their member's physical work and donations
 - c. Joining forces with CFA Purebred Rescue will save time and energy since their organization is operational with policies and procedures in place
 - F. Organization for TICA Rescue Committee
 - 1. Chair
- 2. A minimum of one Committee member with rescue experience from each TICA Region
 - 3. Goals and Objectives
- a. Combine rescue efforts with the already operational and functional, CFA Purebred Rescue, to benefit both rescues both financially and with additional manpower and expertise.

- b. Appoint Regional Rescue Directors/Coordinators with rescue experience from each TICA Region
 - c. Help TICA members in need
 - d. Education
 - e. Promote getting TICA members involved in rescue
- f. Promote TICA members involvement in fostering, adoptions, helping with shelter IDs, transporting, home visits and other rescue functions
- g. Develop a system or data base to keep track of TICA approved fosters, transporters, shelter walkers, and other volunteers
- h. Develop an approval process for fosters, transporters, and adopters and other necessary volunteers
 - i. Voluntary home visit program
- j. Develop a reporting system to the TICA BODs with the Rescue Chair and each of TICA's Regional Directors
 - k. Develop policies, procedures and guidelines for the Rescue Committee
- I. Make recommendations to the Feline Welfare Committee and board for programs and issues regarding rescue
 - m. Develop forms for rescue programs and issues
- IV. Closing. We cannot stop seizures of cats from breeders and Household pet exhibitors or from the hoarders and collectors. The reorganization of the Feline Welfare Committee and the organization of a Rescue Committee can make TICA proactive and possibly slow these types of issues down within our own community. TICA members are asking for a resolution to current and previous problems. The activation of the Feline Welfare committee and organization of the TICA Rescue Committee is the solution to future problems. Thank you for this opportunity to speak and make this presentation. These committees will not get organized overnight but TICA members working together as a team can make them work and become a reality. I hope the board will seriously consider this proposal and that the Feline Welfare Committee will be active once again.
