CLUB CHARTER RENEWAL

CHARTER RENEWAL FEES: Club charters are renewable at \$25 per year on May First. Charter renewal Fees must be paid for each year. An inactive club charter may be brought up-to-date by the payment of Unpaid charter renewal fees up to a maximum of \$75. Date of Expiration of 11/11/11 indicates a LIFETIME Charter, therefore, no fees are due, however, ALL clubs must provide a list of current officers/addresses/phone numbers. Please fill out this form and return it to the Executive Office.

MEMBERSHIP REQUIREMENTS: The membership of all TICA clubs must include not less than five members of The International Cat Association, Inc. ALL officers MUST be members of TICA.

BY-LAWS: Any provision may be included in the Club By-Laws that is not inconsistent with the By-Laws, rules and regulations of TICA. Members may amend the By-Laws at any time, however, a copy must be furnished to the Executive Office for inclusion in the club file.

Standing Rule 1021.1 Members. Five members including all officers of each TICA club must be TICA members in good standing.

Standing Rule 1021.2 Charter renewal fees shall be \$25.00 and are due and payable each May 1st together with a current Officers' list with addresses. Lifetime chartered clubs are required to provide a current Officers' List with addresses.

Standing Rule 1021.2.1 If the club charter renewal fee is not received by May 31st; a surcharge of \$10.00 per month is added to the renewal fee for a maximum of 4 months.

Standing Rule 1021.2.2 A \$10 fee will be assessed to any club where the Officers' List with addresses is not received by May 31st.

Standing Rule 1021.2.3 Failure to pay charter renewal fees, surcharges, and/or provides an Officers' List after 4 months from May 31st, TICA shall place a club, including Lifetime chartered clubs, in inactive status. Reactivation of a club including a club with a Lifetime Charter shall be up to the equivalent of 3 years' charter fees.

Club charter must have current status with a list of current club officers/addresses/telephone numbers on file in the Executive Office before any Show Licenses may be issued. (Club charters cannot be renewed until all the officers of the club have membership expiration dates equal to or later than the expiration date of the club's charter.)
