### 109.1 Annual Convention.

109.1.1 Annual Convention. Labor Day weekend each year is reserved for the Annual Convention. No other shows may be held the weekend of the Annual Convention with the following exception. A club may receive permission to hold a show on the Annual weekend upon application to the Board. Application must state specific reasons for the request for exemption and why such a show would have no impact on the Annual.

109.1.1.1 The rotation for the Annual Conventions shall be: Mid Pacific - 2010, Mid Atlantic - 2011, Great Lakes - 2012, Northwest -2013, Northeast - 2014, International - 2015, Southwest - 2016, South Central - 2008, Southeast - 2009.

109.1.1.2 Proposals to host the Annual Convention in the designated region must be received for the Annual Meeting 3 years prior to the proposed convention.

109.1.1.3 In the event no club submits an acceptable proposal, any club in any region may submit a proposal to host the Annual Convention by the agenda deadline for the Semi-Annual Meeting 2½ years prior to the convention and a notice soliciting such proposals shall be published in the TICA TREND.

109.1.1.4 The subsequent designated order of rotation will remain the same.

### 109.2 Meetings of the Board.

109.2.1 All Board Meetings shall be scheduled for a minimum of 2 days.

109.2.1.1 Meetings of the Board shall be the fourth full weekend in January (Winter Meeting), the third full weekend in May (Spring Meeting) and the week immediately preceding Labor Day weekend (TICA Annual).

109.2.1.2 The Winter Meeting shall be held in Harlingen TX without a show OR at a location outside the United States in conjunction with a show, approved by the Board.

109.2.1.3 The Spring Meeting shall be held in the United States, rotating from Central to West to East, with or without a show. The meeting venue must be at or near a major international airport at a hotel with adequate meeting space, full restaurant service and airport shuttle.

109.2.1.4 The Winter and Spring meeting locations shall be selected by the Board without consideration of accompanying show.

109.2.1.5 Minutes of all meetings of the Board of Directors shall be completed within 10 working days following the meeting.

## Amend Standing Rules 106.4 (Committees) - Vasquez

### Rationale:

The rationale is because many people feel that with board members on the rules committee that there is an unfair advantage to those not on the rules committee. They can form opinions on rule and program changes before the entire board has a chance to see it and discuss it as a board. It creates a more level playing field during meetings.

This rule used to include that sentence and was changed in 2006.

(Rules Chair note: Mike Vasquez has clarified that although the rationale focuses on the Rules Committee, the intention is for the amendment to apply to ALL committees).

### Amendments:

106.4 Standing Committees. The President, with the advice of the Board of Directors, shall appoint persons knowledgeable in the fields specified to serve on the following standing committees. Any other committees, which from time to time may be necessary and proper for the effective and efficient operation of the Association, may be created by the President and appointments to them made by the President, with the advice of the Board. **Each committee shall have a chairperson, members as needed and a Board member who works with the committee as a liaison director .Board members may not be included in the committees other than a liaison to the committee.**

### Rules Comments:

(NP) I believe the proposal is not well thought out. If it is taken as written it would prohibit Legal Counsel from sitting on the Committee(s), it would prohibit the current chair of Legislation from acting as such and it would prohibit people that are interested in volunteering to serve on committees from doing so.

Truthfully, working on the Rules Committee (or any committee on a volunteer basis) is not something people are beating down the door to do. Look at how many people have said they wanted to be on the Rules Committee that have not contributed or discussed or lost interest and left over the years. To tell people that are interested and will participate that they cannot do so and hopefully find people to take their places seems to be not well thought out to me.

(AB) I'm not crazy about the structure of the second sentence he is proposing to add: "Board members may not be included in the committees other than a liaison to the committee."

I'd suggest changing it to: "No Board members other than the member serving as a liaison to the committee may participate in the committees." I think it gets Mike's point across more succinctly. Other than that I think the proposal is in order.

(CL) From a Rules point of view, there is a problem between the rationale and the proposal. While rationale refers to Rules Committee the proposal refers to Standing Committees. We don't have many experts in genetics ready to work in a voluntary way for TICA, what happen if in the future any of them become a board member...I think it's a pity to lose their work from Genetics just because they are in the Board. It's the same with Rules and Legislative committee. Additional I think this proposal needs to define the role of the liaison since this position was removed from the current rules. What is the liaison supposed to do? Duties?

I also agree that Amanda's suggestion is a better wording.

(PS) Technically the proposal appears to be in order, however I am not following the rationale, and even after reading it still do not clearly understand what the issue is.

(MW) Only the final sentence of Mike's addition ("Board members may not be included in the committees other than a liaison to the committee") was removed in 2006.

A couple of years later the entire rule was comprehensively revised and the requirement for liaison Director roles removed, along with the explanation of that position. Consequently, the proposed revision adds a requirement without any explanation of the duties. That is unsatisfactory and, in my opinion, requires further drafting before it could be incorporated into TICA's rules.

As regards prohibiting any Board member from all committees (except for a "liaison" position), I think this is short-sighted and detrimental to the overall best interests of TICA. For example, that would have meant excluding the current Chair from the Legislative Committee, thus depriving that Committee of "persons knowledgeable in the fields specified". And our current Legal Counsel would be excluded from the Rules and Legal Committees if the proposal went through, which is totally unsatisfactory.

In any Board, members are always going to have varying degrees of knowledge about a subject so a "level playing field" is very difficult to achieve in reality. Having more than one Board member familiar with TICA's rules (and the implications of any proposed change) is an advantage in my opinion.

## Delete UCD 71.6.1, 71.6.2, and 71.6.3. (Bird)

### Rationale:

The current rules were written before commercial genetic tests for recessively inherited feline coat colors were available. Now that reliable genetic testing is widely available and widely used, UCD 71.6 should be sufficient to ensure that no “orphan” colors are created in breeds. For example, if a breed accepts black and chocolate, but not cinnamon, it is easy to use testing to distinguish chocolate from cinnamon and eliminate cinnamon from the breed.

### Amendment:

71.6 The genetically anticipated product of any two recognized colors shall also be a recognized color for a given breed. Examples of specific instances of broad applicability appear in the following paragraphs, however, the applications are not limited to those specifically mentioned.

~~71.6.1 A breed may accept a single pigment genotype with or without its dilution; however, a breed which accepts pigment genotype B/- and either other pigment genotype must accept all pigment genotypes. (See chart 71.5)~~

~~71.6.2 A breed which recognizes cats in all eight divisions of a category must accept all colors of these divisions.~~

~~71.6.3 A breed may be recognized in white only. However, if other colors are recognized in addition to dominant (epistatic) white (W/-), the breed must accept all colors of all divisions which are accepted by that breed.~~

~~71.6.4~~ **71.6.1** A breed may choose to recognize only the black-based (eumelanistic) colors or the sex-linked red-based colors. Recognition of both implies automatic acceptance of the corresponding tortoiseshells as well.

~~71.6.5~~ **71.6.2** A breed that accepts the “with white” divisions in any color shall include the combination of white together with any and all colors accepted for the breed.

~~71.6.6~~ **71.6.3** A breed which recognizes both sepia and pointed categories shall also accept the mink category.

### Rules Comments:

(MW) This is a valid proposal from a Rules perspective. The impact of this proposal needs to be evaluated by the Genetics Committee.

(NP) I agree with Martin.

(CL) I also agree with Martin

## Cut Off for Excepting Show Entries

Requested by Ralph Stadter, EN

In the past we have had quite a few precedents over on this side of the pond where clubs accepted entries very late in the game and would sometimes take substitutions at the door. This is somewhat common practice. Once or twice over the last couple of years I stumbled across show rule 29.2.3 which actually prohibits clubs from doing that:

*“29.2.3 Under no circumstances may the show management accept entries not printed in the catalog. This does not apply to entries accepted prior to the printing of the catalog which have been inadvertently omitted from the catalog by show management.*

*29.2.3.1 No substitute cats or kittens can be accepted in place of the original entry printed in the catalog.”*

I'm not really sure just how old these rules are and why they were created. I absolutely understand that obviously no new entries could ever be accepted once the show was officially closed and entries were (explicitly or implicitly) refused...

### **About 29.2.3**

We usually don't print our catalogs until Wednesday - if someone decides after that they still want to come to our show, I guess you could say that they're just out of luck ;)

However, there are a lot of clubs over here struggling to get enough cats to pay for their shows (yes, in Northern Europe as well!) and as we found out last year these clubs are also competing with other associations where this is allowed and encouraged... I'm not sure what the reasoning is behind this.

From a master clerk / judge point of view it's annoying to deal with late entries - but if it helps a club stay afloat...

I see two main issues with accepting entries at the door:

#1 Exhibitors may enter for Saturday only, see how their cat does and then enter it for Sunday as well. So if the cat doesn't do well the club misses out on the entry fees for Sunday...

#2 Other exhibitors will complain if these late entries do well, i.e. better than their own cats ;) Right now they will file a complaint. If they didn't have that option - would they stop showing (i.e. clubs would lose future entries from these exhibitors)? Or would they learn that it shouldn't really make a difference when their competition was entered - if the cats are better then they will do better...

### **About 29.2.3.1**

I don't understand why substitutions should not be acceptable. We've had things like cats hurting themselves the day before the show and exhibitors asking whether they can bring a substitute for that entry. I don't think this should be an issue:

Nobody was refused because of the substitute (the place was already taken even if other entries were refused).

- The exhibitor has to pay for the entry one way or the other - why not let them actually show a cat for it...

- There are always absentees anyway and we're struggling with counts. This would be a way to avoid even lower counts...

### Amend Registration Rule 36.3.1 (Foundation Cats)

#### Rationale:

TICA has grown significantly since its inception and is now expanding into areas where sometimes there is no existing cat fancy or established pedigree registry. People have imported cats many years ago and have been breeding without registering because there is no local registry - like India, and possibly other countries. The cats are "purebred" but have no papers.

Such areas may hold only 2 ring shows on an infrequent basis, leading to difficulties in getting cats registered with TICA under the existing rule.

The "3 judge" requirement should be relaxed to 2 Allbreed judges for such developing areas. Also, as an additional safeguard, the form should only be signed by Approved Allbreed judges.

#### Amendment:

36.3.1 A cat of a recognized breed for whom one or both parents either are unknown or are not registered with TICA or an association which has a reciprocal registration agreement with TICA may be registered in the ancestry record of the association if the application for registration is accompanied by a signed Certification Form ( R-1020) from three TICA **Approved** Allbreed judges stating that they have evaluated the cat in question and find that it sufficiently meets the standard for its breed to be used in a breeding program. **In developing areas (as agreed by the Board), only two Approved Allbreed judges need to sign the form.**

#### Rules Comments:

(EC) I believe that this might be a good compromise - Personally here in North America, I won't sign off on most cats because in most cases it is a way to get around breeder's contracts, or because the cats are one or two generations down from such contracts.

Developing areas are different - say India - where cats have been bred for generations without benefit of registries. Costa Rica was another example.

(TJ) I think we need to hold our standards high. In new, developing areas, two judges would be sufficient...in established areas I feel it needs to remain at 3.

(SA) I agree with Toni

(AB) I agree with Toni.

(BT) I can live with 3 for developed and 2 for developing or I can live with 2 total. If we split it between developed and developing there will always come the question of "what is a developing area" - it will mean different things to different people.

Truth is - if someone wants a cat signed off on bad enough in places like the US they will keep asking judges until they get the number of signatures required.

(MW) I'm in agreement with this change. To address Bobbie's point, I don't believe we can easily draft a "one size fits all" rule to define a developing area. I'm happy to leave it as a Board decision – the same way as we currently have in the Judging Program.

## Amend Reg Rules 33.2, 33.9. (Stop combining of Structural Mutations) - Dany

### Rationale:

I am proposing a couple of rule changes with the intention to stop the creation of new breeds based on combining structural mutations simply because it's possible. Too often the intentions behind these "designer breeds" are solely focused on the money that they will be able to generate with no or too little regards to the physical well being of their creations. Way too little is known about the side effects that the combination of structural mutations may cause. In the best interest of the cats we have to stop this practise.

The following breeds are already considered Experimental in TICA: the Dwelf (Munchkin / Sphynx / American Curl); the Kinkalow (Munchkin / American Curl) and the Scottish Kilt (Munchkin / Scottish Fold). Just because their cats are listed as Experimental by TICA, many breeders are promoting their cats as being recognized and/or registered by TICA. This reflects very badly on us. If these breeds advance to Championship, this will definitely be the time when I stop being a TICA judge.

### Amendments:

The following are my suggestions for rule changes – additions in red, deletions crossed out:

#### Registration Rules

33.2 Classification of Registrations. A breed shall be classified for registration as one of the following:

33.2.1 Domestic Hybrid Breed - A breed developed from a deliberate cross between two existing domestic breeds, incorporating characteristics of both parental breeds into the new breed. **Breeds that have a structural mutation as breed characteristic must not be used as source breeds.**

33.2.2 Domestic x Non-Domestic Source Species Hybrid Breed – A breed being developed by means of deliberate foundation crosses between domestic cats and a single non-domestic source species. **The domestic cats used must not have a have a structural mutation.**

#### Add a new registration rule:

**Structural mutations are "owned" by the first breed establishing championship status that displays that structural mutation (such as folded ears = Scottish Fold, short legs = Munchkin, curled ears = American Curls, etc.) New breeds may only use this structural mutation with permission (majority vote of the breed section) of the breed/breed group owning it.**

33.9 New Traits of a Championship Breed.

*303.9 Trait: A visible distinguishing characteristic.*

33.9.1 ~~Any~~ new trait or traits of a Championship Breed, not recognized for competition in the kitten, cat or alter class of that breed, **that is not a structural mutation (such as, but not limited to, folded ears, short legs etc.)** may be exhibited in the New Traits Class. New Traits Class cats appear in the catalog and judges' books and judges include these cats in judging fees.

#### Add to definitions:

**Structural mutation: Appearance of the skeletal and/or cartilage expression different from the average domestic cat such as, but not limited to, folded ears, shortened legs, shortened or absent tail, etc. The difference in expression may or may not affect the physical abilities of the cat.**

**Rationale:** The Munchkin is being used/over used extensively to create "designer breeds." In addition to the previously-mentioned Experimental breeds there are more new "breeds" that are using the Munchkin: Bambino/Minskin (w/Sphynx), Genetta (w/Bengal), Skookum (w/LaPerm), Lambkin (w/Selkirk Rex) and the Napoleon (w/Persian Breed Group), which is planning to apply for advancement to Championship status at the Annual.

### Rules Committee Comments:

(BT) While I understand and sympathize with what Monika is trying to accomplish with this rule change it basically defeats the whole purpose of the new traits class and would only allow new colors to be accepted in a breed.

(PS) I have to agree – it also potentially stops the progression of those experimental or preliminary new breeds already accepted by TICA that include mutations in their standard, if they are no longer able to use source breeds with those mutations in their programs.

While I'm not a fan of introducing mutations simply to create a 'new breed', I think each new breed needs to be evaluated by the TICA BOD on an individual basis as to whether it is truly a unique breed, or simply a variation of an existing breed.

(EC) Personally I believe that it is detrimental to existing breeds to have "their" mutation used to create "sub-breeds".

I have forwarded this to the Genetics Committee, because I believe that it is an issue that needs the opinion of that committee as well.

IMO, the majority of our membership would love to see this type of protection for their breeds.

(MW) I am in full agreement with Bobbie's comments. I think that the proposals are too restrictive in their present form.

(TJ) I think Monica's rule change is properly written and I think it needs to go on to the board for discussion. This is a real "hot topic" right now. I believe it deserves the attention of the board.

I know that I am hearing more and more from people that that they are kind of tired of the experimental breeds and people being able to say they are registered with TICA when they are just an experimental breed. Maybe what we need to look at is a change in words or semantics, if you will...instead of saying that they are registered with TICA, what about being recorded with TICA just for tracking purposes. I think that would go a long way with a lot of breeders.

(BT) We have talked about that more than once....that the Experimental Breeds are not an accepted breed but are being tracked....and in fact, a breed is not accepted as a breed until Registration Only when the breed name and breed are accepted by the Board. Maybe that is the way to go.

(AB) I know I get a lot of questions about this outside of Rules. People do not understand that breeds are not fully accepted until they reach championship. They try to misuse this confusion to get new breeds registered for championship using the fact that we register them.

(NP) I think it would be simple to issue a Certificate of Record rather than a Certificate of Registration. If the breed moves on to Registration Only, then a Certificate of Registration can be issued. Because at that time, a breed name is approved and instead of EXP+birthdate a breed abbreviation will be assigned and used with the birthdate as in normal registrations.

(BT) I think Nancy's idea has merit and should be considered. It was never the intent of the experimental registry to suggest an experimental was a breed. The name is approved by the Board when the breed is accepted for Registration Only. Before that happens they basically have no status in TICA.

(SA) I agree with Nancy that the Certificate of Record is a more appropriate term,

## Amend Reg Rules 32.3 (Experimental Breeds) - Rules

### Rationale:

By issuing Certificates of Pedigree for Experimental breeds, this can be perceived elsewhere as the breed being registered with TICA, whereas in reality TICA is just tracking ancestry in case a later application is made for formal breed recognition.

The amendment changes the issued document to be a Certificate of Record, together with revised wording on the certificate clarifying that TICA does not recognize the breed.

### Amendments:

32.3 The registration certificates for cats registered in the Foundation or the Experimental Registry shall be distinguished from those registered in the Stud Book to avoid potential confusion regarding the status of a given cat or breed within the association. Experimental Registration Certificates shall **be issued as Certificates of Record and** clearly state **that the breed and breed name are not recognized or approved by TICA and are** "Not Eligible for Exhibition."

### Rules Comments:

(CL) Fine with me.

(EC) I still think we need to separate the experimentals from the word "registration" by removing it from the rule.

(BT) I have a question on the wording "exhibition" - are we talking about exhibition only and they can't come into the show hall or competition type exhibition? I think we need to be clear. My understanding was that it meant competition.....but it was used to stop an experimental breed from coming as exhibition only.

(EC) I'm wondering if it really means "not in the show hall"?

(BT) I called and talked to Nancy about this when an experimental breed was refused exhibition only in a show hall as I'd seen many experimental breeds come so people could see them while being worked on and Nancy's feeling was the same as mine, that we were talking about "can't be shown competitively" - not can't come into the show hall.

(VF) I think the rule is talking about the breed, not an individual cat. The unrecognized breed is not eligible for exhibition/competition.

(SA) I agree that I would interpret it as talking about the "breed" and not the cat.

(MW) I'm happy with the main wording regarding Certificates of Record. As regards "Not Eligible for Exhibition", I've always understood that to mean not eligible for competitive classes, but that an individual cat could be put "on exhibition only" (as with Registration Only" breeds). I think that the topic is a separate discussion to the current proposal and that the existing words are left "as is" for now.

## Creation of Category VII – Breed Revitalization (Klamm, Hall, Wiklundh)

### Rationale:

For years, TICA Bombay, Burmese, Havana and Singapura breeders have been very concerned about the extremely low genetic diversity of their breeds, which has led to increased health issues and reduced numbers. Data published in the journal *Genomics* in January 2008 demonstrated that these breeds have the lowest genetic diversity of all cat breeds (Appendix A). (Note: Bombays were not included in this study. However, because of its smaller breeding population and dependence on Burmese for outcrosses, the Bombay breed is highly likely to have low genetic diversity as well.)

Because of this concern, the idea of creating a new category, Category VII, specifically for the revitalization of breeds was discussed with Dr. Pfleuger. It was her recommendation that outcrossing not be limited to specific breeds approved by each breed section. She stated that if limited to specific breeds, breeders may overlook potential outcrosses. Additionally, almost every breed has problems. She suggested that Category VII should have open registration to include not only recognized domestic breeds, but domestic cats of unknown or unregistered ancestry. She pointed out that common street cats are often the most hardy due to “survival of the fittest.”

The creation of Category VII to allow open registration will give the above-mentioned breeds now in need of revitalization and other breeds in the future the genetic diversity that they require. While outcrosses can be done at any time, the offspring of such outcrosses cannot be shown until the 4<sup>th</sup> generation. In order to maintain a viable breeding program, breeders have to maintain a relatively large number of cats. By creating Category VII and allowing open registration, the progeny could be shown, if of show quality, which would encourage MORE breeders to work with outcrosses.

### Proposal: Create Category VII – Breed Revitalization

Amend Registration Rules:

37.1.2 ~~Six~~ **Seven** registration categories are provided as follows:

37.1.2.1 Category I: Established Breeds

37.1.2.2 Category II: Natural Breeds

37.1.2.3 Category III: Variant or Mutation Breeds

37.1.2.4 Category IV: Domestic Hybrid Breeds

37.1.2.5 Category V: Non-Domestic Source Breed Hybrids

37.1.2.6 Category VI: Experimental (Developing) Breeds

**37.1.2.7 Category VII: Breed Revitalization**

37.1.3 For a list of breeds recognized in each registration category, see Standing Rules 307.2, 307.3, 307.4, 307.5, 307.6, 307.7, **307.8**

**Add new 37.8 to create new Category VII, and renumber existing 37.8 (Assignment of Registration Categories) to 37.9 and renumber 37.9 (Change of Categories) to 37.10**

### **37.8. Category VII – Breed Revitalization**

**37.8.1 Purpose.** This category is for breeds/breed groups that have been identified as needing outcrosses to improve their genetic health. It assumes that the goal is to improve the health and long-term sustainability of the breed/breed group. This category is to allow breeds/breed groups a limited period of time during which wider choices of outcrosses are available. This will be an open registration

category. Outcrossing to all recognized domestic breeds and unknown or unregistered ancestry domestics is permissible. No change to the standard is necessary or recommended to move a breed/breed group to Category VII, although it is recognized that some standard changes may be needed as a result of the outcross policy. This category is NOT to create a New Trait. Any new trait that occurs within Category VII will have to go through Registration Rules 33.9 New Traits of a Championship Breed. This category is NOT to create new breeds. Any new breed that occurs within Category VII will have to go through Registration Rules 33.3 Procedures for Acceptance for Registration.

Requirements to move a breed/breed group to Category VII include:

- The breed section(s) must vote to request transfer to Category VII
- Supporting rationale for the category move may include any of the following, as determined to be adequate by the board:
  - Peer reviewed studies
  - Information from breeders acceptable to the Genetics Committee
  - Any other information that the board deems adequate, including information on the number of registered cats and litters of the breed.
- The Board of Directors may approve, disapprove or impose additional requirements on the breed/breed group as a condition of transferring to Category VII.
- A breed/breed group may not transfer to Category VII during the period it is subject to Registration Rule 33.8.15. [Three years after acceptance into championship, a new breed must maintain required registration and showing requirements.]
- Breeds/breed groups may remain in Category VII for five years. Should a breed/breed group not achieve its revitalization goal, the breed committee may petition the board for a two-year extension. The breed/breed group shall be transferred back to its prior category upon expiration of the outcross policy unless the breed committee, with approval of the board, requests assignment to another breed category.
- Outcross offspring shown while in Category VII will continue to be shown and retain their titles after open registration has ended and the breed has returned to its original or subsequent category. Any outcross offspring born after open registration has ended will be subject to the exhibition rules of the breed or breed group's category.

It is highly recommended that any outcrossing program should include screening of candidates for known phenotypic traits and genetic defects to ensure that undesirable genes are not introduced into the breed/breed group.

**37.8.2 Requirements for Championship Exhibition.** Hybridization is acceptable within the pedigree. Any cat conforming to the standard will be considered a first generation purebred and will be eligible for Championship Exhibition. (See Requirements for Registration 37.10.3.)

**37.8.3 Requirements for Registration.** A cat which is the product of two members of this breed or breed group shall be considered a purebred of this breed. The hybrid between this breed and an outcross breed shall be considered a first generation purebred if it conforms to the standard, otherwise a first generation "variant". Cats of unknown or unregistered ancestry for which proof of origin is available and such origin is acceptable for the breed in question. Such cats may be registered as first generation purebreds, providing the application is accompanied by a health certificate, customs declaration, air bill, or similar evidence of origin. For a domestic breed, a signed Certificate Form (Form R-1020) from three TICA Allbreed judges must be submitted stating that they have handled the cat in question and find that it sufficiently meets the standard for its breed for use in a breeding program.



**“The Burmese and Singapura breeds have the lowest heterozygosity and the highest FIS of any breed, reflecting the most intense inbreeding (See Figure 4 on the next page).** The newest CFA breed, the Siberian, had the highest variation, comparable to random-bred populations. This indicates that it was derived from a broad foundation stock. The Sphynx, which is a derivative of the Devon Rex breed, also had high genetic diversity. **Given these results, Burmese and Singapura breeders should be concerned about genetic diversity,** while Siberian breeders should be encouraged to retain existing diversity as their breed becomes more established. Similar to the conservation efforts in captive exotic felid populations, genetic analyses, breed histories, and population dynamics could be used to develop breed management or survival programs to maintain genetic variation within the breed gene pool for an extended period of time. “

### **Rules Committee Comments:**

(CL) I like the proposal. Not sure if Revitalization breed is the right name for this new category. I think we need the input from Nancy Parkinson about coding. What happen with the codes registration when a breed is moving from category I to category VII during this time?

(PS) According to 37.9.3 any change to a less restrictive category shall be retroactive to all cats of the breed regardless of birth date.

(PS) I am a little confused about the codes that she is using on the bottom of pg 2 – are those supposed to be Registration Rules' codes? If so, they don't seem to fit in to what those codes currently say. Also, I'm not sure that coding cats that don't fit the standard as 'variant' is the correct use of this code.

(BT) I also wonder about the cats that come from non-domestic source breeds.....if they wanted to expand the gene pool and go to this category the "unknown" would not work for them but a recognized breed could.

(MW) This is a complex change which arrived very close to the submission deadline so I have not been able to fully review all the implications and check for potential conflicts with existing rules. For example, who will determine in 37.8.3 if a "hybrid between this breed and an outcross breed ... be considered a first generation purebred if it conforms to the standard"? I think that this is a useful proposal but needs more analysis before it can go to a membership ballot.

It would be more logical to call this Category V and to move the existing V and VI categories accordingly, so that all the Championship categories are consecutive - but that involves a substantial edit to the existing rules.

(NP) I think the category should be set up so that breeds in this category are registered as AOP, BOP, COP, 01P, 02P or 03P to indicate that the crosses are permissible within the description in the proposal. Whether to use the ABC or 123 codes would follow the registration rules as they are now ...ABC for crosses between existing breeds and 123 for breeds with an unknown or unregistered cat. Only thing that would need to be changed in standards is the section about outcrosses. It should simply state "Allowed" rather than "None" without listing breeds.

**Comment from Genetics Committee:**

I think this proposal is sound and has merit. We need "something" to help with the genetic diversity problems, while allowing incentive for folks to do it. And this proposal places the approval in the breed section's hands.....where it should be in my opinion. I feel pretty strongly that the proposal should not actually make mention of breed names at the very beginning. It places an automatic bias that those are the breeds are in peril (and a newer Singapura study shows they are not as inbred as originally thought).

## Amend Show Rule 216.9 (Biting) - Barton

### Rationale:

The current rules ARE vague. According to the current rule a cat can be disqualified for biting anything at any time. It does not specify when the biting has to occur nor who or what has to be bitten. It simply says "any cat that bites". Rules should not be open to interpretation, they should be specific. The proposed amendment is far more specific as to who is protected by the rule and when the rule is in effect.

The current rule is also quite lax in terms of penalties and does nothing to prevent the cat from being entered in additional TICA shows nor does it do anything to protect our judges being from being exposed to repeated injuries from the same animal as was recently the case in California. The penalties proposed in this rule will prevent the cat from being entered in any additional shows. If the owner does enter the cat and the Entry clerk accepts the entry, the owner will be in direct violation of the show rules and thus, be subject to Board discipline up to and including expulsion from TICA.

We need to take the situation of our judges being injured by biting cats more seriously and the rules and penalties need to reflect this.

### Amendment:

Delete the current 216.9 and 216.9.1:

~~216.9 A judge shall disqualify and dismiss from the ring any cat that bites.~~

~~216.9.1 A cat that is disqualified from competition for biting shall be noted by the Executive Office. If three disqualifications for biting by the same cat occur, the cat will no longer be scored or allowed to confirm titles, and the owner of the cat shall be notified by the Executive Office.~~

Replace these rules with the following:

**216.9 Any cat or kitten which intentionally bites the judge, clerk, steward, trainee or any other show official during the course of judging, shall be immediately disqualified from that ring. The cat shall not be eligible to compete in any rings in which it has not already been judged for the remainder of the show.**

**216.9.1 The judge shall notify the owner/exhibitor and the show manager that the cat has been disqualified for biting.**

**216.9.2 Awards received prior to the disqualification will remain in effect.**

**216.9.3 In the event a disqualified cat is subsequently selected for a final award based on the decision of a judge, the cat shall be officially excused from being present in the final.**

**216.9.4 Any cat or kitten that has been disqualified from competition for biting shall be recorded by the Executive Office. If any cat receives three disqualifications for biting, the cat will no longer be considered as eligible for entry in any TICA show. All titles won prior to this shall remain in effect, but no additional scores shall be**

**accumulated nor shall any additional titles be confirmed. The cat shall not be eligible for any Regional or International wins for the show season in which it becomes ineligible for entry. The EO will notify the owner that the cat is no longer eligible to enter TICA shows, but it shall be the owner/exhibitor's responsibility to comply with all the provisions of this rule whether they have received notification from the EO or not.**

**Rules Committee Comments:**

(BT) This proposal is formatted correctly from a rules standpoint. While I understand what Carol is trying to accomplish I am very concerned over the parts of what has been submitted, especially taking all RW or International wins from a cat for the show season.

(TJ) I appreciate the thought behind the proposed rule change and I agree that the judges need protection from biting cats and everything needs to be properly documented by the judges and the Executive Office but I think that the cats should be able to keep whatever awards they have achieved up to the time that they are no longer scored because of three documented bites.

(EC) - I agree that biting cats have been "falling through the cracks" due to issues with how they are reported to the EO - I do not agree that voiding a whole season's wins are the way to deal with it. Our current rules, if used correctly, are adequate.

(SL) I agree with Bobbie. The cat in question has earned the awards fare & square up to that point and should be awarded such.

(AB) Totally agree with Ellen

(CL) From Rules point of view the proposal is not in conflict with any other current rules. However I think there is a problem about what means "Any cat or kitten which intentionally bites...", this is very open to the judge's subjective point of view. One situation: a cat bites a trainee, the trainee thinks the bite was intentional but the judge thinks it was not, I see too much room for an arbitrary decision. I'm in disagreement about having a cat ineligible for entry after 3 DQs for biting, how are the Entry Clerks supposed to enforce this proposal? This is not practical. Finally I don't see the point of changing the current rules about not allowing the cat to be eligible for any RW or IW wins for the show season in which it receives 3 DQs for biting. In all TICA history, the EO has never scored a cat with more than 3 DQs for this reason, what means judges could be not reporting detailed the bites, I don't see this proposal helping the judges to follow the rules more than the current ones in place.

(MW) The proposal is correctly formatted from a Rules perspective but withholding RW/IW awards that have already been earned before the cat was DQ'd for biting for the third time sounds draconian and not in the spirit of TICA. Also, it is not clear how Entry Clerks can comply with the proposal that such a cat is ineligible for entry to subsequent shows. If an Entry Clerk accepts such an entry by mistake, would they then also become liable to disciplinary action?

## Amend Show Rule 29.4.5 (Benching of males) – Board Directive

### Rationale:

The Alter and adult HHP classes are predominantly neutered males, which make the benching and judging of large classes problematic. However, there are many instances where there are two or more neutered males who would have no problem being benched next to each other as they either live together or are just very laid back. Clerks who know these cats have been asking the owner(s) if the cats may be benched next to each other in order to facilitate matters. This is a practical solution to the problem, but is against show rules. The following amendment to the show rules would bring this practice into line with the show rules and would continue to facilitate judging. It would also ensure that former breeding males who might have a problem with being benched next to another neuter would still be separated.

### Amendment:

29.4.5 Adult male or neutered cats shall not be benched in adjoining cages in the judging ring. **However, neutered cats may be benched in adjoining cages if permission is obtained from the owner(s).**

### Rules Committee Comments:

(BT) I think this is fine.

(EC) I think this is fine.

(TJ) I think the wording is fine now. The owners know their cats better than anyone and should be able to tell the clerk/judge if it's ok for them to go side by side.

(AB) Given that the Board gave direction to Wendy, I have no problem with the way her proposal is worded but my comment for the record is that it should be handled the same way we handle Kittens and HHP. In fact if we really wanted to simplify the rules we would change it so that the rule is about whole males something like "In the judging ring whole males may not be placed next to each other".

(PS) The amendment appears to be appropriate as written. I was actually wondering about the logistics of how this rule would be carried out, in other words how clerks would be obtaining permission before putting up numbers, but since the rationale stated that it is already happening I assumed that it is being done in a way that doesn't break other show rules, e.g. identifying a cat with its owner.

(BT) Even in kittens where we can run them in order there is sometimes a young male (or female) that is starting to get hormonal - when I see it happening I stop whoever is picking up the kitten from my ring and suggest they tell the other clerks to separate the kitten or not put it next to xyz.

I think the majority of exhibitors know to go to the clerk and if we [judges] help reinforce the concept I really don't see a problem with it.

(CL) The spirit of the proposal seems to be to treat the alters and HHPs in the same way we do with kittens. I think the proposal is properly written, however my suggestion would be just delete from the current rule "or neutered cats". In this way clerks will tend to call the alters and HHPs in the same way we call kittens. If a neutered cat needs not to be benched next to other neutered cat, then the owner/agent might ask the clerk to do in that way.

(MW) The amendment is correctly formatted from a Rules perspective. We also need to ensure that the Clerking Manual (54.1.9.3, 54.2.2.3) is updated if this change passes the membership ballot.

(SA) Wording is fine although I have some concerns with the logistics.

## Amend Standing Rules 202.2 (Show Formats)

### Rationale:

Clarify the rules for allowable show format combinations as the existing rules can be confusing.

### Amendments:

202.2 Maximum **number of consecutive days for which a club may apply for a show license is three and the maximum** number of times any single cat may be judged **during any three day period in any location** ~~on any show weekend~~ is twenty, regardless of format.

202.2.1 One-Day Alternative Format shows may have up to five rings in the morning and five in the afternoon for a **daily** ~~weekend~~ maximum total of 10 rings including Congresses. ~~A 1-day alternative format show with more than 8 rings may not be combined with any other format.~~

202.2.2 Two-Day Alternative Format shows may have up to four rings in the morning and four rings in the afternoon for a daily total of eight rings and a ~~weekend~~ **combined** total of sixteen rings including Congresses.

202.2.3 At Back-to-Back Shows or Split Format Shows any single cat may be judged not more than eight times per day, including any Congresses.

202.2.4 A club may choose to have different formats for each day of a show. ~~(For example, a club may opt to have a one-day Alternative format show on Saturday with four rings in the morning and four rings in the afternoon and a one-day show on Sunday with five rings.)~~ The show format(s) must be clearly advertised in all promotional material.

### Rules Comments:

(CL) I do think we need to try to eradicate the term "show weekend" from the rules. I think a maximum of 3 days shows is realistic and a maximum of 20 times for each cat as well.

With this wording you can do sat AM 5 times / sat PM 5 times and then sun 5 times. I don't like the idea of 20 times a single for 2 days, it's too stressing, 16 times it's reasonable.

(EC) We want to make the maximum 20 - and allow for alternative format of one day 10 and another 5 - and I'm not seeing how that works with what is written here. Personally I'd be fine with alternative format 2 day with 5/5 and 5/5/

(BT) I agree with you Ellen - I don't see how this will allow for 5/5/5 - I'm probably ok with 5/5/5/5 as well

(MW) As Carlos points out, you can have a 1 day Alternative Format show of 5/5 rings and then a one day show of 5 rings. The club is free to choose to restrict the number of entries on Day 2 to 125 maximum. Personally, I feel that 5/5 and then 5/5 might be too much – the rules are there to help prevent cats from being overshadowed.

## Amend Standing Rules 901.4.2 and 901.4.3.4 (Increase RWs to Top 25) – Board Directive

### Rationale:

As TICA has grown substantially over the past 5 years, it is appropriate to increase the number of Regional Awards to account for the growth and widespread geographical competition in many regions.

### Amendments:

#### 901.4.2 Lifetime Achievement Award.

901.4.2.1 The TICA Board of Directors shall establish the Lifetime Achievement program to recognize cats who have excelled in the show ring. These special cats will be awarded the title LA on a certificate, suitable for framing, and will be recognized in the TICA TREND, the Yearbook, and in the Annual Awards Program. Cats certified as earning this award shall be eligible to use the title LA before their name in the following fashion LA OD SGC Babsy's Baby.

901.4.2.2 Eligibility: All eligible cats must have received at least one Top 25 International award as a kitten, cat or alter and two International or Regional top 20 **or Regional Top 25** awards as a kitten, cat or alter. *(Example: A regional top 20 kitten and top 20 cat in 1998 and a top 25 international alter in 1999 would make the cat eligible for this title.)* Two titles may be achieved in 1 year, i.e., top kitten and cat or alter. However, a Regional award and an International award on the same cat (See Show Rule 21.73) in the same year counts as only one title. Ownership of the cat may change from year to year. The award is for the cat, not the owner, although the current owner will be requesting the award.

901.4.2.3 For pedigreed cats, awards shall be earned in the kitten class, the championship class and the alter class. Years of awards need not be consecutive.

901.4.2.4 For Household Pets, awards shall be earned in the Household Pet Kitten class OR in the Household Pet class.

901.4.2.5 There is no time limit for claiming the LA title. You may claim it for deceased cats if you choose to do so. However, awards for 21st Best through 25th Best International **or Regional** may be claimed only for years in which those awards were actually presented.

#### 901.4.3.4 Regional Awards.

Regional Awards will be presented to the ~~20~~ **25** cats, kittens, alters, household pets, household pet kittens and ~~20-25~~ longhair cats and ~~20~~ **25** shorthair cats having the highest aggregate points of all cats, kittens, alters, household pets and household pet kittens, as applicable in the region. In order to receive a Regional Award, the owner of the cat, kitten, alter, household pet and household pet kitten must have exhibited the cat, kitten, alter, household pet or household pet kitten, as applicable, in at least one TICA sanctioned cat show in the regions presenting the award during the show year for which the regional award was earned. All awards earned during the show year will be listed accordingly for every region or recognized area and internationally.

901.4.3.4.1 All winners are notified by letter by the appropriate Regional Director.

901.4.3.4.2 The Top 3 Cats in each color of their respective breeds receive a color certificate by mail from the appropriate Regional Director.

901.4.3.4.3 The Top 20 **25** Cats, Kittens, Alters, Household Pets and Household Pet Kittens, in each region are featured in a visual media presentation at the Regional Banquet.

901.4.3.4.4 The Regional Top 20 **25** Longhair Cats and Shorthair Cats, and Breed Award winners, are honored at the Regional Awards Banquet.

901.4.3.4.5 The Top 10 Cats, Kittens, Alters, Household Pets and Household Pet Kittens are featured in the TICA YEARBOOK in black and white free of charge. ~~(Some regions purchase pages in the TICA YEARBOOK to feature the 11th-20th Top Cats, Kittens, Alters, Household Pets and Household Pet Kittens in black and white.)~~

(BT) Fine with me

(TJ) I have no problem with this. I think with the regional rebates the cost will be of little concern.

(PS) Looks like everything has been addressed to accommodate the increase in RWs.

(EC) This is proving popular with the membership - I believe we have addressed all the rules.

Dear TICA Officers, Members of the Board and Committee Members:

On behalf of all of the Australian Mist Breed Working Group, I submit the following Annual Report on the status of the breed in the Advanced New Breed category.

Although we placed the announcement to request advancement to championship at the Annual in Worcester, we will not be doing so. Although we have met and actually exceeded many of the requirements we still have a few that we need to achieve – one of which is having the required number of breeders. Delaying the action to the Winter meeting will allow us to reach those goals as well as allow a number of new breeders the opportunity to participate in this exciting and important endeavor.

We would also like to ask, however, that we be allowed to present the breed at the Annual. I will be attending, as will possibly a number of other Mist exhibitors/breeders and we plan to have cats present. We may not be able to attend the Winter meeting and travel in the winter with animals can be difficult. Please let me know if this will be possible.

Our Working Group has followed up on various comments and suggestions given by judges who have handled our Mists in the Advanced New Breed Category. We have drafted some slight modifications to the standard in consideration of those issues as well as a couple of other items that were inadvertently left out of the original. We feel these changes will significantly help clarify a number of areas about our breed. The revised standard will be submitted with the Application for Advancement.

Here is a summary of our progress toward meeting the requirements on the Application for Advancement to Championship:

- **Date since advanced to Advanced New Breed** Last Annual Requirement met

- **200 adult cats registered in a WCC organization, 50 of which must be in TICA**

Report from the TICA Office shows 208 cats registered – all will be adults by the Winter meeting and there will be more registered.

In addition – there are hundreds of Australian Mists that have been registered with ACF, CCCof A and ANCATS in the 30 year history of the breed in Australia Requirement met and exceeded.

#### **List of 35 shows, 10 of which must be TICA shows**

Mists have been shown as ANB in 20 TICA shows to date with four more planned for June. We hope that by the Winter meeting we may have shown in 35 TICA shows.

Mists have been shown in numerous WCC shows in Australia. If we use those shows – as is allowed – we have met and exceeded this requirement.

#### **25 individual cats that have been shown**

Several hundred have been show to multiple grand championship in Australia in addition to the number that have been shown in TICA. We plan to submit a list of the cats that first were shown in Australia and then exported and shown as ANB in TICA, then those shown and exported but not shown in TICA, followed by some of the most noteworthy cats in the breed. We feel this report will show the Board some of the diversity in the lines we have and also the quality of the cats that have been spread throughout the world.

Requirement easily met and exceeded.

#### **List of Judges who have judged the breed in Advanced New Breed**

85 TICA judges and guest judges have handled the Australian Mists in the Advanced New Breed category.

No specific number requirement Requirement met when list is created.

Australian judged who have judged the breed in Australia were not included unless they have also judged them in the ANB category in a TICA show.

#### **15 Breeders Representing at least 5 TICA Regions**

To date we have 11 breeders that are TICA members. All of these have litters born – some still need to be registered. They represent 7 TICA Regions.

This is clearly the area where we need additional numbers to satisfy the requirement. There are several people who have queens they will be breeding or that will have litters in the near future. We will satisfy this requirement by the Winter meeting.

**At least 25 cats shown in Advanced New Breed in the past year**

23 cats have been shown in ANB since the Annual. Six more are planned to be shown in June 2014. This requirement will be met and exceeded by the Annual and more so by the Winter meeting.

The remainder of the requirements pertain to the actual Application for Advancement and will be submitted at the appropriate time for that action for the Winter meeting.

Many of the above lists have been drafted. Since we are continuing this process several are still "works in progress". If you would like copies of the draft materials – please let me know. We will be bringing them as a draft packet to the Annual. They will all be included in final, of course, with the final Application for Advancement.

That concludes my report.

## **The Highlander Breed Group Report: 2013-2014**

The Highlander has been a PNB since 2008. We are continuing to slowly gain popularity as more people become interested in our breed. As of this writing our breed section membership is at 21, however there are several active members who have not yet renewed so we expect that number to grow by the end of June.

The Highlander was a featured breed in the 2013 issue of Cats USA magazine. This has been a great opportunity to increase awareness of our wonderful breed to the public, and provide an accurate overview of the breed for the entire year that this magazine is available on store racks. The Highlander segment on Cats 101, Animal Planet also continues to generate interest in our breed as it continues to be rerun on television or viewed online. Although lacking accuracy in some facts, this exposure has overall been positive in promoting our breed.

### **Highlander Litter Registrations**

In the 2013-14 show season there were 89 Highlander litters registered from 23 different catteries, which continues the trend of a steady increase in the litters registered each year. Of these litters, 3 were 02T registered, 12 were 03T/V registered, 36 were A registered, 22 were B registered, 9 were C registered, and 7 were SBT/V registered litters. This also demonstrates a continued progression of advancement in breed codes by an increase in the number of B, C, and SBT litters.

### **Individual Highlander Registrations**

In the 2013-14 season there were a total of 97 Highlanders registered, this number is slightly down from the previous year when 103 cats were registered. Of these individually registered kittens 2 were 01T, 5 were 02T, 14 were 03T/V, 38 were A registered, 21 were B registered, 9 were C registered, and 8 were SBT. This again shows a progression in the codes of the cats being registered, particularly the SBT numbers which is almost tripled from the previous year's 3 SBT Highlanders that were registered.

## **Highlanders in the Show Hall**

Five unique Highlanders were shown in five different shows in five different regions, representing five different catteries in the 2013-14 show season. Although we are not seeing an increase in the number of cats shown, this does represent an increase in the number of catteries represented in the showhall. What is even more exciting is to find that four of these Highlanders were shown for the first time this past season, bringing us that much closer to meeting our show requirement for advancement to ANB.

## **Summary**

In review of the Highlander's progression over the years we find that we have met and surpassed all but one of the requirements needed to transfer to ANB, and that is the number of cats shown, as mentioned above. With this realization, we are going to make a push to get as many Highlanders as possible into the showhall this summer with the hope that we can submit our advancement packet this fall for consideration at the 2015 Winter Board of Directors meeting. This is an exciting time for the Highlander breed and we look forward to seeing it grow both in numbers and in popularity in the future.

## SAVANNAH BREED REPORT – SHOW YEAR 2013-2014

The Savannah breed had a fabulous first year in Championship and the second was a strong follow up. I believe the Savannahs are fully part of the TICA family and are here to stay!

TICA Registration Rule 33.8.15 sets out the requirements of every new breed advanced to Championship, these requirements need to be met for the 3 show years post-advancement.

33.8.15.1 asks that a minimum of 25 additional cats of the breed be registered each year. The Savannah breed continues to be a popular one, in the year 2013 1324 were registered, and so far in 2014 582 Savannahs have been individually registered.

33.8.15.2 asks that a minimum of 10 individual cats of the breed be shown in at least 15 rings in at least 3 regions. Collating the data sent by the Executive Office, 45 individual kittens, cats &/or alters were shown at 44 cats shows in 11 regions.

33.8.15.3 asks that our breed group have at least 5 TICA members in a minimum of 3 regions that are actively breeding the breed. Given the number of Savannahs registered, it is obvious that we exceed this requirement, but at least 5 members of our Savannah Breed Committee have had litters in the past year: Brigitte Cowell in the MP region, Paige Hiemier in MA region, Patti Struck in the SW region, Jennifer Gray in GL region and Lori Greer in the SE region.

What I think was one of the biggest achievements this past show year is the show success of one Savannah, alter Halestone Midnight Hunter (bred and owned by Mike & Sandy Hale, SW region). In only our second year of Championship competition the Savannah breed has its First International Winner! Hunter achieved 20<sup>th</sup> Best Alter Internationally. With that IW, Hunter additionally earned her Lifetime Achievement award which is also a First for the Savannah breed!

Hunter was not the only Savannah to be successful this past show year, there were 9 Savannah Regional Winners (almost 10, but for illness preventing one SV from being shown in her region to make her points count to a RW) in 5 regions. 7 catteries produced those Regional Winners also, showing that our breed is successful as a whole, not just one cattery.

In the last breed report, I mentioned the issue of PK Deficiency as being suggested in a scientific article as potentially being a breed concern for Savannahs (along with a number of other cat breeds). A number of breeders have tested, and a few cats were found to be positive for this issue but the great majority has been N/N. The identified cats have had related programs notified and lines chased as far back as possible. It's difficult to give accurate numbers on this issue as not all the breed section was comfortable publishing results, of those that have been tested and

published on Facebook, 122 cats were tested with 2 cats found to be K/K (affected) and 17 found to be N/K (carrier status). Whilst performing testing, a problem with the PK Deficiency test was found in regards to the Serval genes that can be involved in Savannah DNA. With some correspondence with the lab, it was determined that the Serval N gene was not being detected, which only caused an issue with a small number of N/K results that thence appeared to be K/K. This issue has now been resolved and the testing more accurate now. All cats that appeared to be K/K were retested to be certain of that result subsequently.

Savannah Rescue continues its trend of having a huge waiting list for the handful of cats available. On this day, there were 11,070 members of the email notification group. To further help, another yahoogroup was established by Savannah Rescue to allow pet owners to rehome their Savannahs without having to surrender to Rescue. Many pet owners wanted to have some choice and input into the new home, this group also allows breeders to post retired altered breeders. That yahoogroup has 3,672 members waiting for the right cat to be available.

In conclusion, the Savannah breed continues to grow and flourish. We feel that the Savannah is becoming solidly established in the TICA cat breed family.

## **Rules Committee – Breed Advancement Comments**

### **Lykoi Advancement to PNB**

(MW) I believe that the application is in order from a Rules perspective (I am assuming that the EO can confirm that the cats listed have been registered as Lykoi). As far as the proposed breeding program is concerned, I feel that is a matter for Genetics.

(EC) - I support their application - this is a distinctive new breed that deserves to be seen.

(NP). The Lykoi application is in order. A very interesting breed - one of the most unique and interesting to come along in a long time.

(CL) Requirements are in order to advance to PNB status. They have a unique look and certainly have a merit to keep progressing through TICA New Breed program.

(BT) The application appears to be in order for their advancement.

(PS) The packet appears to be in order, and I look forward to seeing this unique breed in the new breed rings

### **Burmilla Advancement to Championship**

(EC) - I believe their application is in order

(NP). The Burmilla application appears to be in order

(MW) The application looks to be in order. This is a long-established breed that has been at Championship status elsewhere in the cat fancy for many years.

(BT) Everything appears to be in order for their advancement.

(CL) everything is in order and this breed deserves to be approved for championship status.

(PS) Everything looks in order in the Burmilla advancement packet.

### **Napoleon Advancement to Championship**

(TJ) It appears that everything is in order but my concern is the lack of consistency in the breed. It varies from a Munchkin to a Persian to a domestic. Another concern is we are seeing them in numbers only in certain parts of the country. Judges in certain regions have never seen them at all.

(PS) The packet appears to be in order. I would recommend that if there are suggestions on standard changes (page 14 of the packet) that they be taken back to the breed section members to be voted on and submitted with the rest of the packet.

(MW) The application appears to be in order from a Rules perspective. However, I am aware that an objection has been raised to the breed name - which I trust will be discussed by the Board prior to taking a decision on this application.

(EC) I agree with Toni's concerns - I also believe that with the controversy over the name that this should be put on hold until such time as they can resolve the problems.

(BT) The application appears to be in order.

(CL) French members have complained about the breed name and it seems to be a conflict with registration rule 33.4.2. Before considering the advancing to Championship status the Board should ask the breed section to vote for a new breed name. If no clear majority of the breed section agrees on a new name, it's up to the Board to designate a new breed name.

(SA) I agree with Martin, that the objection to the breed name will need to be discussed.

### **Maine Coon Poly Advancement (New Trait to Championship)**

(PS) It looks to be in order to me

(BT) I agree

(MW) I think that, to be consistent with 2016.1.2.2, it should say "maximum of 7 toes on any foot". Otherwise, from a Rules perspective it looks fine.

(EC) I agree with Martin

(NP) OK with me

(CL) I must admit the application is in order from Rules point of view. However I would like to comment that in TICA history all the new traits than have been advanced to championship status were through and with the support of the Breed Committee: marble/snow/silver Bengals, silver Abyssinians/Somalis, British LH and Scottish Straights. I'm not against or in favor of this particular new trait, I'm just pointing out that this proposal could be handle in other way following the example of other new traits advanced to championship status.

33.8.2 A minimum of 200 adults registered in any full member association of the World Cat Congress (WCC) of which a minimum of 50 are registered in TICA at a level potentially eligible for championship competition.

**Attach Addendum A.**

33.8.3 List of at least 35 shows licensed by WCC organizations of which at least 10 must be TICA shows where cats have been exhibited, including region/countries and judges. A Show shall be defined as a "show catalog" for this purpose.

**Attach Addendum B.**

33.8.4 List of 25 unique individual cats that have been shown, including registration numbers and region/countries shown.

**Attach Addendum C.**

33.8.5 List of judges who have judged the breed.

**Attach Addendum D.**

33.8.6 A minimum of 5 regions are represented by a minimum of fifteen breeders who are TICA members in good standing actively breeding the breed.

**Attach Addendum E.**

33.8.7 At least 25 unique cats shown in the Advanced New Breed Class including entries shown in at least five regions during the year preceding the application.

**Attach Addendum F.**

33.8.8 Submission of an electronic Application for Advancement to Championship to each member of the Genetics Committee and each member of the Rules Committee at least 90 days prior to the board meeting at which approval is sought. Any proposed modifications to a previously approved standard must be submitted with the application. Following approval of the proposal by the Genetics Committee and Rules Committee, the application must be submitted by the ANB Working Group Chair to the TICA Executive Office at least 60 days prior to the Board Meeting for inclusion in the agenda. Any comments of the Genetics Committee or Rules Committee must be included. The application must include the following: (applications available from the TICA Executive Office or at tica.org)

33.8.8.1 A Letter of Intent to apply for approval as a Championship Breed, signed by at least ten TICA members in good standing; **Add. G**

33.8.8.2 A proposed breed standard; (See 33.8.8) Include as a separate document in the application packet.

33.8.8.3 A proposed breeding program;

33.8.8.4 A processing fee of \$50. Include copy of DAR in application packet.

33.8.9 A Notice of Intent to Apply for Advancement to Championship Status must be published in the TICA TREND at least 120 days prior to the meeting at which the application for advancement will be heard, and which invites comments about the breed to be forwarded to the Executive Office.

At the meeting of the Board where application is made:

33.8.10 Make a formal presentation at the meeting of the Board of Directors, including photographs, illustrations, statistics, health and breeding reports, examples of the breed and any other relevant material.

**FOR INFORMATION ONLY:**

33.8.12 No breed may recognize for championship cats which are phenotypically indistinguishable from an already established breed; that is, each breed recognized for championship must be unique. However, this restriction does not apply to registration. Such cats are acceptable for registration and breeding purposes.

33.8.13 If the breed is approved for Championship, a Breed Committee shall be elected in the next regular election.

33.8.14 Meeting the requirements set forth in these rules does not guarantee advancement. The Board of Directors shall judge each request for advancement on a case by case basis.

33.8.15 Every NEW breed must meet the following requirements in each of the next three show years following acceptance in order to retain championship status:

33.8.15.1 Register a minimum of 25 additional cats of the breed.

33.8.15.2 Exhibit a minimum of 10 individual cats of the breed in at least 15 rings in at least 3 regions.

**Location:** The show will be held at the George R. Brown Convention Center in Houston TX. This is a venue that is no stranger to cat shows and other like events. They have agreed to work with us in giving us the most reasonable rates possible and have more than enough space to accommodate 500 cats and numerous vendors. At the present time we are looking at securing at least 80,000 sq. ft. of floor space. Dear Madame President, Madame Vice President and Board Members,

Before the Napoleon comes before the Board for advancement to Championship, an important issue regarding the breed name needs to be discussed and decided upon by the Board. Therefore, I am requesting that this be added to the Agenda for the 2014 Annual Board Meeting. Below are the registration rules that pertain to breed names and with which I am concerned.

**33.4.2 A breed name shall not be derogatory, nor shall it make unsubstantiated claims regarding the merits of or geographic or genetic origins of the breed.**

**33.4.3 TICA may change a breed name at any time it is felt to be in the best interest of the association to do so. In such instances selection of a new name shall be by majority vote of the breed section with approval of the Board. If no clear majority of the breed section agrees on a new breed name, the Board may designate a breed name.**

Below are my concerns:

1. Napoleon Bonaparte was a prominent French military and political leader during the latter stages of the French Revolution and its associated wars in Europe. As Napoleon I, he was Emperor of the French from 1804 to 1814. He did not have cats and was NEVER the creator of the Napoleon breed. To the contrary, it is said that he either hated or feared cats, so naming a breed after him is not an honor.
2. The underlying reason the name Napoleon was chosen was because he was supposedly short. This reasoning was incorrect. Napoleon's height was actually average for his time period as the average 18th-century Frenchman stood at 5 ft 2 in (1m 57). Historians are now suggesting that Napoleon was 5 ft 6 in (1m 68) tall. To name this breed after Napoleon because he was supposedly short is derogatory to the man. The breed could easily have been named Stalin - 5 ft 6 in (1m 68) or Gandhi - 5 ft 3 in (1m60), Khrushchev - 5 ft 3 in (1m60), Keats – 5 ft 1 in (1m55), Stratton (aka General Tom Thumb) - 2 ft 9 in (.84m), Capote – 5 ft 4 in (1m63), Carnegie – 5 ft (1m52) or after any British, Brazilian, German, Japanese, etc. dignitary who was short in stature. I am certain that any of the board of directors would feel concerned by the misappropriation of the name of an important person in his/her country's history.
3. No other breed in TICA is named after a person. This should never occur unless that person is the particular breed's creator. I do not think anyone in the United States would appreciate it if a future new breed is named after one of the American Presidents, a famous (or infamous) politician, or a well-known public person.

I have been concerned about the name of this breed ever since it was created. I have requested many times for the name to be changed. I have heard the dumbest arguments not to change the name... business cards and documents are pre-printed with that name!!!!!!!!!!!! I do not believe these are good reasons to continue with a name that is inaccurate, as well as derogatory and demeaning. I am not the only one who believes the names should be changed. Attached is a list of people who also believe the name should be changed. I can provide copies of emails and letters to support these additional names at the Board's request.

I sincerely hope you will give my concerns serious consideration and request the Napoleon breeders to rename the breed.


Dear TICA Board of Directors,

It has come to my attention that the name of our beautiful Napoleon cats is being challenged. For several reasons I am asking you please to support the name staying the same.

First of all the rule being given to push for a name change is: 33.4.2 A breed name shall not be derogatory, nor shall it make unsubstantiated claims regarding the merits of or geographic or genetic origins of the breed.

I can only assume that this is in regards to the historical French figure, Napoleon Bonaparte. However our wonderful cats are not named Bonaparte, which is the surname of a man who may or may not bring bad connotations to the name depending on who you are. They are Napoleons which, true, was this man's first name, but a name shared with many other people, real and fictional, over history including royalty, athletes, artists, politicians, scientists, architects, musicians, cities in eight US states, characters in novels, video games and movies. It is also the name of a delicious pastry and candy. To imply that the name Napoleon, apart from the surname Bonaparte, is derogatory in any way, is somewhat discriminative and prejudiced against all those other people, characters and sweets who share this name.

The name of our breed, Napoleon, has been around now for 16 years. Many breeders, showers and happy pet owners are now very familiar with Napoleon as the name of the breed of cat we love. Napoleons have been the subject of countless magazine articles throughout the world and featured in books and television using this name. With the great advances in the internet and social media in the last decade or so, now more than ever, when something is "out there" in the media it spreads quickly and sticks. After a short break from breeding (due to financial, relocation, and school obligations), we are planning on getting fully back into the program here on the West Coast.

I am proud to have a cat named after such an important emperor. Though diminutive in stature, they both are regal, and able to capture the attention of people around them. Many leaders around the world have been nicknamed "the Napoleon of \_\_\_" in reference to his epic, sweeping accomplishments.

"Napoleonic Code

The Napoleonic code was adopted throughout much of Europe, though only in the lands he conquered, and remained in force after Napoleon's defeat. Napoleon said: "My true glory is not to have won forty battles...Waterloo will erase the memory of so many victories. ... But...what will live forever, is my Civil Code." The Code still has importance today in a quarter of the world's jurisdictions including in Europe, the Americas and Africa."

"Napoleon reorganized what had been the Holy Roman Empire, made up of more than a thousand entities, into a more streamlined forty-state Confederation of the Rhine; this provided the basis for the German Confederation and the unification of Germany in 1871.

The movement toward national unification in Italy was similarly precipitated by Napoleonic rule. These changes contributed to the development of nationalism and the nation state."

Metric system

The official introduction of the metric system in September 1799 was unpopular in large sections of French society, and Napoleon's rule greatly aided adoption of the new standard across not only France but the French sphere of influence. Napoleon ultimately took a retrograde step in 1812 when he passed legislation to introduce the mesures usuelles (traditional units of measurement) for retail trade—a system of measure that resembled the pre-revolutionary units but were based on the kilogram and the metre; for example the livre métrique (metric pound) was 500 g instead of 489.5 g—the value of the livre du roi (the king's pound). Other units of measure were

rounded in a similar manner. This however laid the foundations for the definitive introduction of the metric system across Europe in the middle of the 19th century"

"International Napoleonic Congresses are held regularly and include participation by members of the French and American military, French politicians and scholars from different countries. In January 2012, the mayor of Montrou-Fault-Yonne, near Paris (the site of a late victory of Napoleon) proposed development of Napoleonland, a commemorative theme park at a projected cost of 200 million euros."

#### "Legacy outside France

Napoleon was responsible for spreading the values of the French Revolution to other countries. (Napoleon provided the design for the flag of Italy on the basis of the French tricolor.)

The Napoleonic Code is a codification of law including civil, family and criminal law that Napoleon imposed on French-conquered territories. After the fall of Napoleon, not only was Napoleonic Code retained by such countries including the Netherlands, Belgium, parts of Italy and Germany, but has been used as the basis of certain parts of law outside Europe including the Dominican Republic, the US state of Louisiana and the Canadian province of Quebec.

The memory of Napoleon in Poland is highly favorable, for his support for independence and opposition to Russia, his legal code, the abolition of serfdom, and the introduction of modern middle class bureaucracies".

In France and throughout the world, some people love Napoleon and his accomplishments, and some saw him only as a tyrant, just as people here in America like/dislike some of our presidents and social figures. No one can doubt his historical importance.

I am not Joseph B. Smith (the originator of the breed and name), but I am fairly certain that in no way he meant the name to be derogatory or offensive in any way, nor an assumption that they originate in France

TICA Registration Rule 33.4.2: "A breed name shall not be derogatory, nor shall it make unsubstantiated claims regarding the merits of geographic or genetic origins of the breed".

I am fairly certain that I've shown some examples of how "Napoleon" is not derogatory. As far as "unsubstantiated claims", it seems no different to me than the Bombay (not from India), Havana (not Cuban), Himalayan (probably not really from the Himalayan Mountains), Javanese (not actually from Java/Indonesia), Maine Coon (A wide-spread (though biologically impossible) belief is that it originated from matings between semi-wild, domestic cats and raccoons) (taken from official TICA website <http://www.tica.org/public/breeds/mc/intro.shtm>), Munchkins (not actually from Oz, and little people could possibly take offense), Serengeti (Asian, not African in background), Singapura (though brought back from Singapore, may have originated in the US), Sphinx (not Egyptian, nor in close resemblance to The Sphinx).

This is truly not meant to be argumentative, but an example of already accepted names within TICA that seem to be in the same situation to that of the "Napoleon" cat.

If the only way to keep this beautiful and regal cat in the running for championship status, or indeed recognition with TICA is to change the name, then I would rather change the name. Since the Napoleon name has been associated to this breed of cat for almost two decades I am sure Napoleon will always be used as the Common Name.

If this is required, I have heard possibilities from other people, and also came up with a few potential names of my own, as follows

Nikita (American Indian - smooth or round one), Nappies, Nankin, Napkin, MiniPor/ Minipurr (although in use as the name for a Teacup Persian cattery), Luxurian, Mersian, Perkin, Hamkin, Achenroper (a play on achondroplasia - dwarfism and Persian), Munchian/Munshlan/Munchen, Belfaygor (a resident of Oz with a long beard), Kalidiah (also from Oz - a tiger/bear hybrid creature), Hobbics (also small with furry feet),

Gillikins, Winkies, Quadlings (groups from Oz - countries separated North, East, South, (accordingly) and West (designated for the Munchkins)





*My name is Lisa Martin and I own the registered cattery NapTimeNapoleon. I began breeding Napoleons about 10 years ago. I wasn't taught what being a breeder meant. At the time, I just knew what a Napoleon was and I bred one pair for years without any knowledge of what T.I.C.A. was or what it meant to really be a good breeder. I just had a passionate love for the breed. It wasn't until a little over 2 years ago when I discovered the facebook groups that I learned so much! By interacting with the other breeders I became aware of how important registration was, what diseases to test for, what the standard is, and so much more.*

*I was lucky to have started out with great cats and I have continued to be blessed. I have a very strong bloodline that I am continuing to improve upon. I believe that we, The working group of Napoleon breeders, need to continue expanding our gene pool. I plan to continue using a Persian to Napoleon model not only because I like the offspring but also to increase the gene pool. I have a very healthy cattery. I have never lost a newborn and have never had any positive results for PKD or FeLV. I've never even had fleas. I'm sure having such a small cattery has helped.*

*My goals are to continue to breed healthy cats that conform to the set standard and to educate as many as I can not just about breeding Napoleons but about breeding in general. I'd like to save beginners from making mistakes that a little education could prevent. I also educate buyers that contact me about the importance of getting proof that the kitten is PKD negative, why registration is important, what to look for in a healthy kitten, and so on. I have made myself available to answer questions to anyone even if they are not buying from me.*

*I believe the Napoleon should be granted Championship status. I would like to see the Nonstandard Napoleons given just as much attention as the Standard. In my experience the Nonstandard cats are just as different as the Standard from any other breed. They have the exact same qualities except for the leg length. I've had buyers come back to me to buy more Nonstandards because they love them! I have had buyers get a standard and nonstandard and they have reported back to me about how much they love them equally and how different they are from other breeds they have had.*

*One buyer has bought four of my kittens from different litters. She bought two Standards and two Nonstandards. She uses them to help Autistic children in a group home. After she bought the first two, a Standard and Nonstandard, she noticed such a difference in the children and was amazed at how well the cats tolerated and reacted to the children. A year later she came back for two more. I believe the Nonstandards are just as beautiful and unique as the Standards and they should be allowed to compete on the show floor as well.*

*I can not stress how much I believe in Napoleons and I have faith that T.I.C.A. will benefit from advancing them to Championship status. This breed is so unique that I find it hard to express how wonderful they are. You almost have to play with one for a few minutes to understand how wonderfully unique they are. RE: THE PROPOSED CHANGE OF THE NAPOLEON BREED NAME

My name is Lisa Martin and I own the registered cattery, NapTimeNapoleon. I have been advised by our liaison that there is a petition requesting that the name Napoleon be changed. I am STRONGLY against a change being made as are the vast majority of Napoleon Breeders as evidenced by a poll taken. My understanding is that this is an issue that has come up several times before. If it was such a serious problem, it would or should have prevented us from advancing before.

I happen to know many people that live in France and that have moved here from France. I asked 35 people from different age groups simply, " Do you find using the name Napoleon for a breed of cat that was developed in the U.S. offensive in any way?" The oldest person I spoke to, Marcelle Stuckey who is 92, chuckled and said " Are you serious? Why would the name of a sweet be offensive?" Marcelle lived in France during WW2 and didn't move to the U.S. until she was in her 50's. I spoke on the phone to a couple of people in their twenties that live in France and they found it ridiculous that anyone would find a problem with a cat breed developed in the U.S. would think the French would be offended. They were more offended that anyone would think it was offensive and that it was a way to fuel the stereotype that the French hate Americans.

I made these calls because I wanted to know if actual French people would be offended. Not one person I spoke with said it would be offensive. I am not saying there may not be a person offended, but I didn't come across one.



My name is Elizabeth Snead and I am a new Napoleon breeder. My cattery name is Chateau Napoleon.


My foundation females - all of whom have shown well -- are from solid lines including Creators and Bluebonnet cattery.





## Genetics Committee Comments on Polydactyl Maine Coons

Sorry about the delay in response. I just spent a couple weeks in intensive care in Brigham and Women's Hospital in pretty rough shape and am only now getting to my email again.

I personally see no reason why polydactyl Maine Coons should not be accepted. The trait is highly prevalent in the ancestral population from which the breed was derived and more than a handful of polydactyls were present in early lines. If any breed has a legitimate claim to the trait, it is the Maine Coon.

One can argue that more than one gene can lead to polydactyly, as is also true in humans. However the mutation seen here in New England and which is present in the Maine Coon appears to be benign and is not associated with other anomalies.

We already accept polydactyly in the Pixie Bob breed, so allowing it in another breed isn't bringing in a trait that has not already been accepted.

Although not all the polys I have seen are approaching show quality, allowing the polys to be shown and openly crossed with cats of excellent type should resolve this very quickly.

Your arguments appear valid and I personally am in support of your proposal to allow polys to be shown in championship.

I see no reason why they cannot take it to a vote. We already have polydactyls in Pixiebobs. I have seen my share of poly Maine Coons. I know that they have been in the breed from the very beginning and are already kept and used in standard Maine Coon programs (as an outcross as the Poly Maine Coons tend to have very different ancestry), with non poly kittens being kept. I remember seeing a poly Maine Coon not long after I went in the fancy in the early 80's. I also know the code generally used in naming the poly cats. It is not universal but if the cat's registered name has a P. in the middle as in Hairy P. Potter (I made that up) that is the code that it is a poly. All the Poly Maine Coon I have seen, have not had more than an extra toe per foot. It is generally a simple dominant with variable but not excessive expression in the Maine Coons and is not associated with any other problems.

I know that there are lots of anti-polydactyl Maine Coon breeders, so the breed section as a whole may very well not want them in as a New Trait, but that has nothing to do with their genetics and I see no scientific reason it should not be allowed on a poll.

After some additional research of available documents, I'd like to add that the scientific research around polydactily in cats is extremely limited. The gene responsible for this trait has been described as an incomplete dominant gene with variable expression. Records exist of cats with different digit configurations. A trait that cannot be controlled is a true can of worms. The variable expression issue alone will require a very strict regulation of what is allowed and what is NOT.

I still believe that promoting the breeding of animals with physical defects is against the foundation of values TICA was built on. I am completely against this. I have seen many cats with forms of polydactily with very abnormal postures in the front legs when standing. Cat's do not complain and are so resilient that they do not show evidence of pain. How can discomfort be evaluated? Even cats with 3 legs can run and jump....

I have seen several polydactyl MC, but only once I had a chance to test the fitness level. This was when my ring had a cat tree, once in America, and I was judging a big poly MC who was willing to climb it. Well, he could not, because of the contrasting push of his several "back" claws. I guess that, in smaller and lighter breeds, this would not be a problem. However, I cannot vote positively for poly MCs.

In the meantime I have seen the comments of other members of the genetic Committee. Then I would like to add that, in my opinion, the fact that we have already accepted polydactilism in PB is irrelevant, because MCs are much heavier and the lack of fitness and possibly pain or discomfort due to polydactilism might be correspondingly more severe.

But, in my opinion, accepting skeletal deformation in such a sensitive and functionally prominent part as the feet is unwise for all breeds. In my opinion we should not accept it for any other breed, and we should also stop accepting it in PBs.

To Whom it May Concern:

The following is a listing of individual comments of the TICA Maine Coon Breed Committee members on the Advancement of a New Trait-Polydactyl Maine Coon:

I am against accepting polydactyl Maine Coons for Championship competition despite the literature that was sent to us for review.

Also, to be forced to accept all kinds of polydactyly in MC's seems a bit unfair and should, at the very least, have strict definitions as to what is acceptable as stated by Phillipa. I would like to see some work done (and not be rushed into this with our backs to the wall) by discussing this genetic trait with a qualified orthopedist and internist to see what their experience is with the long term effects, if any, on the health and bone /structural health of these cats. I know cats are not kids but, as a pediatrician, polydactyly is often associated with other anomalies (heart, skin, blood dyscrasias, cartilage, brain abnormalities and other genetic syndromes). Although often this is a "benign" inherited familial trait, some of the syndromes that are associated with polydactyly IN HUMANS include:

- Asphyxiating thoracic dystrophy
- Carpenter syndrome
- Ellis-van Creveld syndrome (chondroectodermal dysplasia)
- Laurence-Moon-Biedl syndrome
- Rubinstein-Taybi syndrome
- Smith-Lemli-Opitz syndrome
- Trisomy 13
- Down Syndrome

So, I am a bit biased by this to be honest. If we allow polydactyly, why is a white spot which has absolutely NO associated problems considered a default and cats are DQ'd when judged? When I get the answer to this, maybe I'll yield on my opinion.

Dr. Judith Bernbaum

Again, I think our question to answer here is whether or not we accept the proposal of adding "polydactyls allowed" to our breed standard. I believe it needs to be worded better (being specific on the number of digits, their placement & even diagrams). Above all else, I believe it's the decision of the individual breed section members.

Dr. Liz Hansen

I have thought long and hard about this. I would back a separate class for these cats with clear cut parameters as to what is acceptable. I want a way for these cats to be separated on the register as well so they can be identified within pedigrees. As it stands I cannot and will not back this. It is TOO vague and leaves it wide open for abuse. As a judge I'm not being shouted at in a ring by an exhibitor because I think a foot formation is unacceptable but it doesn't say so in the standard.

I'm just back from NZ and whilst they do accept polys I didn't see any. My role on this committee is to protect my breed and it's Standard. Whilst I know polys are in the breed it doesn't make them show cats, unless they want to have their own class.

Dr. Phillipa Holmes

One thing all of us should keep in mind is that we all have polydactyl cats behind our current Maine Coons. The breed has been started with polydactyl cats but to have it accepted back then and lose the smell of a being "only" a barn cat the trait was cut out of the standard. Only a few breeders carried on with this old tradition, mostly those who did not care for show success or newer type fashion. So when some breeders started to show interest in maintaining and continuing that old and original trait they faced the problem that these cats did not look ready to match the other examples of the breed in the show hall. Still these people desired to have polydactyl Maine Coons accepted the same way the straight footed are. They took a lot of effort and accomplished their goal to match nowadays show hall requirements in type and size. They have come a long way; despite they have been treated really badly (or even totally ignored) by all the breed committees in the last 10 years. Of course accepting polydactyly back into the breed officially by allowing it into championship will cause some work like defining the amount of toes acceptable but then this should not be a big problem since it seems that there are barely any examples exceeding the 7 toes per leg limit that has been already set in the Pixie Bob. The other points of critic worded by a few members of this breed committee like various shape of paws needs to be adressed and from what seems to be observed by those who have been working with the trait for a while gives serious expectations that by selection it may become more uniform. There are already families that throw only one shape of paw.

In regards of the health concerns that have been worded by some I can assure you that polydactyl Maine Coons have no more or less health and/or temperament problems than any other Maine Coon. The absence of similar ill side effects like the mutations causing polydactyly in humans seem scientifically proven - see attachments to the rationale, these include scientific renowned studies and also documentation on the old ancestor cats who were polydactyl and that are behind every Maine Coon. Nobody asks extra health tests from the current Maine Coons, we have RWs and IWs who have no more teeth in their mouths by 18mo of age, who have problem with allergies and other symptoms of Eosinophilia, who have severe hip dysplasia (if only one would x-ray them) or who drop dead all of a sudden. Or who are well known as "judge eaters" but since they are campaigned they still win, no matter how bad they behave. Now I don't say that no Poly Maine Coon might ever come up with the same issues, but at least here in Europe, where many many breeders work currently on the Polys and who are responsible for their evolution in type and size, it is self evident that these breeders also care for health. I dare to say that at least over here the Poly Maine Coons have been monitored very closely in regards of hereditary diseases of all kind that run in our breed.

In the end both - straight footed and poly Maine Coon - follow the exact same standard of breed, share the same goals in temperament and health, have the same cats of origin, have the same genepool. While TICA has taken over some of the old separations in different breed groups for a few breeds like the Persian-Himalayan-Exotics-group, they run other breeds in the same group that are divided in other organisations, like the Siberians, who are judged in the show hall as Siberians, no matter which colour they have, while in all organisations in Europe their colourpoint sport run in a different class and even have a different name (Neva Masquerade). Maine Coons, no matter how many toes they have, share everything - the looks, the size, the temperament, the health (problems), the lines, the identity. Putting them in two different breed groups would arise even greater problems, since the current Maine Coon standard does not allow any "outcross". Also, I think, that it is totally irrelevant what CFA thinks of

polydactyl Maine Coons. If TICA ever cared for what CFA accepts we would definitely not have some of our most popular breeds like the Bengals and others. TICA has a long tradition of being a genetic registry, since 35 years. Maine Coons have an even longer history of polydactyly since the early days of the breed ... some 55 years long. It is high time to bring it back into the breed with full acceptance.

I write this not to serve my own purposes but simply from my knowledge of the breed and study of it's history, and my experience as a very health concerned breeder. I do not currently work with polydactyl Maine Coons, never have. I would not be in support if I had any concern in health or breed specific matters.

Ulrike Illia

Here are my thoughts in summary, based on all of the discussion so far and I appreciate having the benefit of everyone's thoughts to date. Many of my concerns have been voiced and there were a number that I would not have thought of as well.

- I think the wording of the acceptance into the standard is too vague as it stands. I agree with others who would like to see more specificity, including drawings of what is acceptable. And drawings without more specifics spelled out in writing and description, are not acceptable by themselves. I only have to reference all of the difficulties we have had in working the regular Maine Coon standard to get to this point. And there are still widely different interpretations by judges.

- I am 100% in favor of having PD identified on registrations and pedigrees. I think MC breeders need to know for sure what traits they are dealing with and be able to rely on the information to develop their breeding program without surprises.

- I lean toward the idea of a separate class for consideration, but I think this bears more detailed thought. If they are in a separate class they may get closer scrutiny which may/may not be to their benefit - it can be argued either way. In all cases, however, the rest -- and the MAIN part -- of the MC standard must be upheld. I worry about judge leniency based on the 'cute' factor (though I, for one, do not consider the trait cute).

- In the department of wishful thinking, I would like if there could be a gene test for the 3 gene variants that have been identified as non-problematic for other health concerns. The possibility of still-unknown issues plagues me. Since PDs have not been widely bred with the general population of MCs we may not really know the extent of issues that could arise. I state here that I am in no way considering myself a scientist so I cannot argue this point. I can only point to human studies and scientific findings which regularly get overturned and rethought.

Teri Matzkin

I, too, agree that the standard is vague and needs to be more detailed. Pictures or drawings would help define what can be accepted, but needs to be described in writing also. I would like to know if, bottom line, there are verifiable medical reasons why we should NOT breed polys. I think a separate class is the way to go, but polys must be identified in pedigrees and registrations.

If I had to vote now, I would say no to acceptance of the polydactyls as it is now. If we can have the time to work on what would be acceptable in the standard and research can identify the many questions in a favorable way, I could change my mind.

Jennifer Sable

The majority of the committee members (6-1) favor a breed group if this new trait is accepted by the breed section and approved by the board. The creation of a Scottish Breed Group with the acceptance of the Scottish Straight is an example to argue for a Maine Coon Breed Group.

I am concerned there is no way to track polydactyls within pedigrees and registrations. The breed chair for the NZCF Maine Coon Committee explained their registry does track the polydactyl MC with a different breed code. It is only fair that all Maine Coon breeders know exactly what is in their pedigrees.

Another question is why did the TICA Board reject the polydactyl Highlander?

More time is needed to make a decision that will affect the Maine Coon breed as greatly as this. There was insufficient explanation of the new trait other than polydactyl, seven toes per foot maximum. If this passes as is there will be a mad rush to revise the standard by May 2015. If the petitioners for this trait had chosen the route to work with the committee these things may have been worked out to a beneficial outcome. As it stands it is too vague to accept.

33.9.2.5 Following approval of the Genetics and Rules Committee, and at least 90 days prior to the applicable Board Meeting, the approved application shall be submitted by the Breed Committee Chair to the Executive Office for polling of the Breed Sections. The application shall include comments of the Genetics Committee on the genetic validity of the new trait or traits and any comments of the Rules Committee.

33.9.2.6 Upon receipt of the application marked as approved, the Executive Office shall issue a poll to all members of the related Breed Section(s). Polls must be returned to the TICA Ballot Judge no later than 30 days from the date of issue. In cases of a Breed Group, a majority of the Breed Section members voting in EACH of the Breed Groups, must vote to approve the new trait or traits in order to advance to championship status. The results of the poll shall be included in the meeting agenda with the application.

33.9.2.6.1 The expense of any poll shall be the financial responsibility of the individuals requesting the poll.

33.9.3 Meeting the requirements set forth in these rules does not guarantee advancement. The Board of Directors shall judge each request for advancement on a case by case basis.
