Subject: British Breed Group - Status of Standard and Category Change

Dear TICA Officials and Rules/Genetic Committee Chairs:

The British Breed Committee is inquiring as to the status on our two requests to the Board of Directors -

1. Change the British Shorthair/British Longhair Breed Standard - passed by majority vote in an election certified by Votenet on January 12, 2015. Per the minutes of the Winter 2015 Board of Directors meeting, passage of the standard changes was contingent on approval by TICA's Genetics Committee.
2. Move British Shorthair/British Longhair to Category 1. This also passed by majority vote in an election certified by Votenet on January 12, 2015. We cannot find where this item was acted upon by TICA's Board of Directors at the winter meeting, and are requesting it be added to the agenda for the Spring Board meeting.

I understand there has been some confusion as to whether our committee was in compliance, since Genetics did not receive the information prior to the meeting, having only been vetted through Rules. We were not aware of this oversight, and we just want to keep this project moving forward.

I have also attached the original request for Category change, submitted to the EO on April 6th, 2014.

Please, we have a May 1st deadline, the start of a new show season; and we are anxious to get these old matters settled so we can move onto a new Breed Seminar and presentations.

I am proposing a couple of rule changes with the intention to stop the creation of new breeds based on combining structural mutations simply because it's possible. Too often the intentions behind these "designer breeds" are solely focused on the money that they will be able to generate with no or too little regards to the physical well being of their creations. Way too little is known about the side effects that the combination of structural mutations may cause. In the best interest of the cats we have to stop this practise.

The following breeds are already considered Experimental in TICA: the Dwelf (Munchkin / Sphynx / American Curl); the Kinkalow (Munchkin / American Curl) and the Scottish Kilt (Munchkin / Scottish Fold). Just because their cats are listed as Experimental by TICA, many breeders are promoting their cats as being recognized and/or registered by TICA. This reflects very badly on us. If these breeds advance to Championship, this will definitely be the time when I stop being a TICA judge.

The following are my suggestions for rule changes – additions in red, deletions crossed out:

Registration Rules

33.2 Classification of Registrations. A breed shall be classified for registration as one of the following:

33.2.1 Domestic Hybrid Breed - A breed developed from a deliberate cross between two existing domestic breeds, incorporating characteristics of both parental breeds into the new breed. Breeds that have a structural mutation as breed characteristic must not be used as source breeds.

33.2.2 Domestic x Non-Domestic Source Species Hybrid Breed – A breed being developed by means of deliberate foundation crosses between domestic cats and a single non-domestic source species.

The domestic cats used must not have a have a structural mutation.

Add a new registration rule:

Structural mutations are "owned" by the first breed establishing championship status that displays that structural mutation (such as folded ears = Scottish Fold, short legs = Munchkin, curled ears = American Curls, etc.) New breeds may only use this structural mutation with permission (majority vote of the breed section) of the breed/breed group owning it.

33.9 New Traits of a Championship Breed.

303.9 Trait: A visible distinguishing characteristic.

33.9.1 ~~Any~~ new trait or traits of a Championship Breed, not recognized for competition in the kitten, cat or alter class of that breed, that is not a structural mutation (such as, but not limited to, folded ears, short legs etc.) may be exhibited in the New Traits Class. New Traits Class cats appear in the catalog and judges' books and judges include these cats in judging fees.

Add to definitions:

Structural mutation: Appearance of the skeletal and/or cartilage expression different from the average domestic cat such as, but not limited to, folded ears, shortened legs, shortened or absent tail, etc. The difference in expression may or may not affect the physical abilities of the cat.

Rationale: The Munchkin is being used/over used extensively to create "designer breeds." In addition to the previously-mentioned Experimental breeds there are more new "breeds" that are using the Munchkin: Bambino/Minskin (w/Sphynx), Genetta (w/Bengal), Skookum (w/LaPerm), Lambkin (w/Selkirk Rex) and the Napoleon (w/Persian Breed Group), which is planning to apply for advancement to Championship status at the Annual.

1024.1 Amendments. Proposals to amend the Show Rules, By-Laws and Registration Rules shall be considered by the Board of Directors at meetings and must be in writing and received in the Executive Office 60 days prior to the opening day of the meeting. Proposals to be submitted according to ARTICLE SEVENTEEN, 117.1.2 of the TICA By-Laws: "Procedure. Any member may submit a proposal to amend the Show Rules or Registration Rules. Said proposals shall be first submitted to the Genetics, Rules Committee and the Board of Directors in writing, stating the article and section to be amended and the wording of the new or amended section(s). The Board of Directors may approve, reject or refer the matter back to the appropriate committee. If the Board of Directors approves the matter, it shall be submitted to a membership vote on the annual ballot in October."

1024.2 Form and Format. The Board will entertain amendments to the By-Laws, Show Rules, and the Registration Rules at each meeting if presented in the proper format and in the proper time, with the proper authorizations, i.e., Rules Committee, Genetics Committee, etc.; and Standards, breed matters, and judging matters will be entertained at the Annual Meeting. Effective 05/01/92, those submitting proposals for changes must use the approved form. All proposals must be received in the Executive Office and by the appropriate committees 60 days prior to the meeting.

1017.1 Amendments. Proposals to amend the Show Rules and Registration Rules shall be considered by the Board of Directors at regularly scheduled meetings. Proposals from the membership must be in writing and received by the Rules Committee no later than 90 days prior to the opening day of the meeting to allow time for review in order to reach the Executive Office 60 days prior to the opening day of the meeting. Proposals received by the Rules Committee after the 90-day deadline will be placed on the following meeting agenda. Proposals are to be submitted according to ARTICLE SEVENTEEN of the TICA By-Laws.

1024.1 Amendments. Proposals to amend the By-Laws shall be considered by the Board of Directors at regularly scheduled meetings. Proposals from the membership must be in writing and received by the Rules Committee no later than 90 days prior to the opening day of the meeting to allow time for review in order to reach the Executive Office 60 days prior to the opening day of the meeting. Proposals received by the Rules Committee after the 90-day deadline will be placed on the following meeting agenda. Proposals are to be submitted according to ARTICLE TWENTY-FOUR, 124.1.1 of the TICA By-Laws.

Amend Show Rules 23.6.7.1 - Late Entries after closing dates (Bourreau)

Rationale :

In some countries like Russia, Italy, France, Belgium and perhaps in other countries some shows are organized by different Feline Associations under the same roof. At the moment following the rule above it is not possible to accept late entries for people who want to discover and enjoy TICA shows. It would be a great opportunity for TICA if we can accept these entries the days of the show in the format of simultaneous judgments of different associations.

I propose the following amendment in order to give opportunities to increase our number of membership.

Rules Committee notes:

On further clarification, we understand that in certain countries (e.g. France) the list with details of the cats entered must be provided to an official veterinarian 2 weeks before the show. Because the show is then closed under TICA rules, entries from cats entered in non-TICA shows held on the same date and in the same venue cannot be entered. Exhibitors from other associations seeing TICA for the first time on day 1 sometimes ask to enter the TICA show on Day 2 because they like the TICA format.

Amendment :

In the event that a show committee has declined any entry pursuant to 23.6.7, no further entries may be accepted for any reason whatsoever. **When a same roof welcomes simultaneous shows from different associations, late entries received the day of the show are allowed for cats already registered in the other shows. Nevertheless, additional pages of the catalog have to be delivered to the exhibitors before the beginning of the judgments.**

Rules Committee Comments:

The committee feels that, at this time, it is too early to submit a full rule amendment but have identified both pros and cons and some questions. This could be discussed at the Spring meeting, with a view to submitting a formal amendment at the Annual in time for the membership ballot. There is also a view that the situation could be managed within the existing rules by not closing the show, yet not accepting new entries before the show day itself under Show Rule 23.6.6.

A) As I understand this, it is only referring to 23.6.7 which has to do with accepting entries after the closing date, not after the show is full (which is addressed in 23.6.1).

So if the show management has turned down an entry because it was submitted after the closing date, he wants to allow exception to those requesting entry on the same day of the show, as long as that cat is also entered in another show at the same time at that same venue.

B) The problem with it then is that you have already turned away entries, that's not going to fly with TICA exhibitors. Once you turn someone away, you can't put someone else in. I see what he's getting at but this is really going to change the scope of things in Europe. Who's to say that the entry clerk deliberately is turning away entries then all of a sudden lets in someone who is a big campaigner. I understand that things are different over there but this really pushes the limit. I also know that this will upset the North American exhibitors. In my own opinion, this is not a good rule proposal change.

C) I understand what they are saying but why don't they simply leave the show open? That way they can take all late entries including ones on the day if they so wish?

D) As I understand it, they cannot leave the show open (in France anyway) because details of all cats entered must be sent to the Government Veterinarian 2 weeks before show date. Additional cats are not permitted into the show within that 2 weeks because they would not then be on that list.

Because the list of cats entered in the Traditional show is also supplied at the same time, then theoretically some of those cats could be added to the TICA show without causing problems with the authorities.

But I think I see what you are getting at. The show need not be closed but they could refuse *new* entries under Show Rule 23.6.6 (in France anyway) once they are in the 2 week period. Than any cat in the Traditional show could still be accepted as a late entry.

E) The initial amendment is in response to a situation in France -- we need to draft it in such a way that it addresses France but is general enough to be imposed across the whole of TICA.

F) We have limits on how many times a cat may be judged in a day -- do we need to factor something like that into the proposed rule?

G) We have rules for the TICA show on how many times a cat is judged on the weekend however I don't think we can legislate for what other shows do in the same venue.

H) Not trying to be negative because I support the move but I do think we need to consider both aspects carefully before deciding they aren't regulated. For example, yes we have rules that govern how many times a cat is judged in a *TICA* weekend but not how many times it is judged in a weekend that includes other organizations. Plus I think if a club declares a show closed and rejects regular entries but then accepts them from another organization's show that we have a potential legal issue so we at least need to discuss it -- as an exhibitor I would not be happy if you turned my entry down but then accepted another because it was entered in a non-TICA show.

Add National Awards – Standing Rules 901.4.3.7 (Lopez)

Work Item Description: Create National Awards to honor the top 5 cats, kittens, alters, household pets, and household pet kittens in isolated countries.

Rationale:

National Awards have been used in South America countries since 2011. This format might be good for countries like Russia, Ireland or Korea.

Amendment:

Add Standing Rules-901.4.3.7

901.4.3.7 National Awards (Countries under Isolated Area status ONLY). National Awards will be presented to the 5 cats, kittens, alters, household pets and household pet kittens having the highest aggregate points of all cats, kittens, alters, household pets, and household pet kittens, as applicable in the isolated country.

901.4.3.7.1 In order to receive National Awards, the isolated country must have sanctioned at least 3 TICA shows with a minimum of 20 rings during the show year.

901.4.3.7.2 In order to receive a National Award, the owner of the cat, kitten, alter, household pet or household pet kitten must have exhibited the cat, kitten, alter, household pet or household pet kitten, as applicable, in at least one TICA sanctioned cat show in the isolated countries presenting the award during the show year for which the National Award was earned. All awards earned during the show year will be listed accordingly for every isolated country, regionally and internationally.

901.4.3.7.3 NO cat, kitten, alter, household pet or household pet kitten shall receive a national award unless it has a TICA registration number.

901.4.3.7.3.1 The cumulative points of the 50 judgments of each registered cat, alter and household pet carrying the highest point value will be used to determine the aggregate National points for each registered cat, alter and household pet during each show year. The cumulative points of the 30 judgments of each registered kitten and each household pet kitten carrying the highest point value will be used to determine the aggregate National points for each registered kitten and each household pet kitten.

901.4.3.7.3.2 In order for a cat/kitten to be eligible for a national award, it must be shown at least once in that isolated country.

901.4.3.7.3.3 Points earned in a breed congress format (Show Rule 21.68) or a breed/multi-breed congress format (Show Rule 21.69) shall not be scored for national awards.

901.4.3.7.4 All winners are notified by letter by the appropriate Regional Director or Deputy Regional Director.

Rules Committee Comments:

A) Looks good to me - it does not address who is responsible for funding the awards/honors - (I don't think it's covered for regions either - the rules do state international awards are covered by EO)

B) My thoughts regarding the National Winners are as follows -

- I am in favor of National Winners

- I would award the Top 3 Kittens, Cats, Alters, HHP, HHP-Kitten for EVERY Country (not only Isolated Areas)

- BUT (and this is a very big BUT) for the National Winners I would actually only count the shows where the cats were shown in their NATIVE COUNTRY!!! This is the only way that we can maybe broaden the local exhibitor base. Otherwise we would get the "usual suspects" just another title.

C) Have you thought about the cost structure of this award program? At the moment, the region is assuming the cost. Does your proposal continue that? Not sure your proposal is clear on who assumes the cost.

D) I agree that it needs to be every country. I agree that only shows in the country should count to ensure we get awards to the new exhibitors we are trying to encourage and to also encourage people to put on more shows. I also feel very strongly that it should be worded as Country Winner and not National Winner -- I don't want to see us using the same designation as CFA. Every other title we have is unique and I think we should try to be unique here as well.

E) If points are to be accumulated but only if certain criteria are met (e.g. minimum of 3 shows with at least 20 rings), then the EO will need to amend some programming – otherwise the RDs will have to calculate all the various scores. The EO will need to create and run the reports for each isolated country as well.

I understand that this type of program has been used in South America recently. What success has it had in encouraging new exhibitors and also motivating those not chasing RW/IW awards?

TICA's Therapy Cat Program (Patton)

Rationale:

The purpose of these titles is to honor the cats and owners for the dedication required in performing as a therapy team. TICA would be the first cat registry that gives actual titles for these special cats and their owners.

1. All cats must be TICA registered.
2. All owners must be TICA members.
3. All cats will be certified by Pet Partners.org, at the owner's expense. (TICA will not certify these cats; only certifications from Pet Partners.org or an approved therapy pet organizations will be accepted.)
4. TICA will offer 3 levels of titles that can be achieved.
 - A. TC – Therapy Cat is awarded after the team has completed 100 approved visits.
 - B. TCX – Therapy Cat Excellence is awarded after the team has completed 200 approved visits.
 - C. TCD – Therapy Cat of Distinction is awarded after the team has completed 300 approved visits.

After each level has been accomplished the owner can apply for their certificate and their badge. TICA already has the certificates available online via TDS. These titles would be able to be downloaded and printed by the owners like other TICA titles are done, for a fee. An embroidered badge that can be sewn on the cat's vest would also be for sale to the owners. This badge would have the TICA logo and the letters of the title achieved.

Therapy teams would visit nursing homes, hospitals, Hospice, Ronald McDonald houses, and schools to make a difference in people's lives. For example in a nursing home setting, cats sit on the laps of residents while being petted. This is a form of physical therapy for some of the residents. Our cats can also go into chemotherapy units to provide support for these patients. Is there a better way to forget your woes than to have a cat purring on your lap?

Pet Partners.org has teams in Canada and has had inquiries from other countries. TICA could help expand cat therapy teams around the world. It would be a great partnership for a great cause.

PRO:

- To reward TICA cats and their owners for helping others.
- To showcase the versatility of cats.
- To award titles to cats that might not be able to be in the show hall.
- A self-sustaining title system.
- A working partnership with Pet Partners.org

CON:

- Positioning of titles.
- Insufficient number of participants.

Rules Committee Comments:

A) I think it looks great and like the pros and cons, except I'm not sure what 'positioning of titles' means under the cons.

B) I like this very much. This is another way to Partner getting TICA out into the Public arena in a very positive manner. This also gives a reward to our many pet owners/members who sacrifice their time devoted to helping less fortunate people. This could be our "Good Housekeeping?" seal of approval with the partnership of PP.org? Also I have to mention a possible income stream be it small or maybe not to TICA from the titles and possible memberships

C) I think it's a really useful addition to the range of TICA titles. The proposal, if accepted, would need re-drafting as an addition to the Standing Rules (901.x?). The rules would need (as noted above) to cater for equivalent organizations outside North America so that it can apply across TICA.

I am worried that the bar is set far too high with a minimum of 100 visits. If someone volunteers just once or twice a month, that's many years of visits before getting to the first title.

D) I think this is a great idea and might motivate more people to certify their cats as therapy cats. Not only could the cats receive titles, they would be providing a valuable service.

E) I have to agree with you on the unreasonably high number of visits required - just to reach the lowest level would require visits at least twice a week for a year, I don't know of any therapy animals that work that hard or often.

Addition of Roan to UCD (Gobble)

Rationale:

I would like to submit a request to have a new definition added to the UCD. As the Acting Chair of the Lykoi breed group, I am submitting this request on behalf of the breeders of the Lykoi. The Lykoi is a new breed as the result of a natural mutation from the domestic shorthair. The gene causes the hair coat to have a different color than any other breed of cat. The kittens are born with their normal coat color (black, blue, tabby, white, etc.) After a short time (usually 2-3 weeks), hair begins to fall loose and a new coat returns. This new coat will have the original color intermixed with white hair.

On close examination, the normal hair is a solid color from root to shaft, and the white hair is white from root to shaft. This color pattern has not been described in cats before. There can be a mix of 20% white all the way to 80% white depending on the cat. This unique color pattern has judges concerned about the color we call our cats.

The cats that are entered in shows are solid black at birth. This intermix of white hairs give the cats a gray to blue coloration that has judges questioning our color determination. If we can call them black roan with a definition of roan, many of these questions would not exist and we can show our cats with the correct color. Roan is a color that occurs in horses, dogs, cows, and guinea pigs, but not in cats. This definition would allow us to use the proper terminology from other animals in our cats. I propose an addition to the UCD:

I think this addition would help the judges and breeders understand the coloring of the Lykoi. I am open to any suggestions of changes the definition that would better suit TICA. My wife, Brittney, will be attending the annual meeting in Austria to present the Lykoi for advancement to Advance New Breed. Any other questions not answered in emails can be addressed to her about the unique color. Thank you for your time. Johnny Gobble

Amendment:

Roan: A color that is added to an animal's base coat which reflects the addition of solid, from root to tip, white hairs thickly interspersed over the animal's coat. For example, a black cat with this intermix of color would be called a black roan, a red cat with this intermix is a red roan.

Rules Committee Comments:

A) Since we're talking UCD - I'm sure this mutation would occur in a tabby variety of the cats - I think we need to take that into consideration.

Does roan still fit into the solid division? it's not really "and white" as we think of "and white" (although it certainly is)

B) Rather than a color, this sounds more like a pattern – which may or may not fit into the existing divisions. This needs input from Genetics before any modifications to the UCD can be put forward.

C) I also have looked up the color information on Wikipedia. I do think that before we in Rules do anything about this proposal, we get a complete rundown from the Genetics Committee.

D) Agreed

E) I agree too!

Top 15 Finals (Board Directive)

The Rules Committee was directed to identify all rules where changes are required to implement Top 15 Finals for classes where the number of cats present and competing is 75 or greater.

Please note that Rules have assumed that the points values for Finals would need adjusting so that any final in the 11-15 range would still be worth more than Best of Colour + Best of Division (i.e. 50 points) for any cat not making such a Final. For example, an AB Best would now be worth 250 (or even 300 points). In addition, the total points required at each level (Ch to SGC) should be adjusted to reflect that increase in points value for Best to 10th Best. (Otherwise it becomes “easier” to obtain titles with the new points values).

Rules Committee Comments:

There wasn't a consensus view on whether this proposal made sense and the point was also made that there could be a lot of work for the EO as well. Specific points raised were as follows:

A) As I have said in the past in the 2013/14 season, out of 236 shows, only 10 had classes with counts of 75 or more. IMO it is not sensible to change so many rules just because of the 3-5% of the shows during the season. It would have more sense to consider a top 12 final for classes with more than 60 present and competing. This change might impact in more shows, more regions and more cats. At the same time it might be easier for the clubs to implement 12 cages for these finals.

I would also like to suggest 5 merit awards instead of best 11, 12,13,14 ... Best 15.

We can keep the current points from best to 10 best and add 5 merit awards with the same points, 100 points for Allbreed finals and 50 points for Specialty finals.

I also would say the presentation of the top 15 format is up to the judge. Some judges just might prefer to say verbally their 5 merit awards and then present the normal top 10 system.

I just want to offer more possibilities to discuss as adding 5 merits awards when the class has 75 or more cats might be a less chaotic change to the rules and the scoring system.

B) I like the 12 idea much better. But also to consider is, If I show a cat/kitten and I get a top 10 final with 75 + entries, is that not a great accomplishment and does it not have more value and meaning?

C) You will still get that value ... but you also allow some other very deserving cats to final as well. And that is what exhibitors are asking for. Even being 15th best in a class of 75 would be a great accomplishment.

D) To do this change properly, we will need to change the points values for each Final, and also the points totals for titles, otherwise a 15th Best could be less than a cat that doesn't final yet gets BOC and BOD.

Then to be fair, every cat being shown should have their title points recalculated when the change comes in at the start of a show year. Otherwise cats that are part-way through earning titles would be at a disadvantage when the change comes in. That could be a bunch of work for the EO.

Also, upping the finals count also has a knock-on effect on the number of cages needed in the ring to hold the Finalled cats, and hence venue size.

I also recall that when Rules and the EO looked at this last time (circa 2009) there was a significant programming and screen design effort to increase the finals to 15 (plus the knock-on effect on testing and implementation). I assume that the Board are aware of this.

PROPOSAL 2: Add Registration Rule 31.6 Amend Registration Rules 33.2; 33.9 Structural Mutations

RATIONALE: This proposal would serve to stop the practice of combining established breeds with one or more structural mutations to create another breed. This is especially important when combining bone and cartilage mutations which may produce unpredictable dysfunction or pain to the cat. This rule would also serve to protect established breeds from being used to create "designer" breeds.

Add Registration Rule 31.6:

31.6 Structural mutation: *Appearance of the skeletal and/or cartilage expression different from the average domestic cat such as, but not limited to, folded ears, shortened legs, shortened or absent tail, etc. The difference in expression may or may not affect the physical abilities of the cat.*

Amend 33.2.1 and 32.2.2:

33.2.1 Domestic Hybrid Breed - A breed developed from a deliberate cross between two existing domestic breeds, incorporating characteristics of both parental breeds into the new breed. **Breeds that have a structural mutation as a breed characteristic must not be used as source breeds.**

33.2.2 Domestic x Non-Domestic Source Species Hybrid Breed – A breed being developed by means of deliberate foundation crosses between domestic cats and a single non-domestic source species. **The domestic cats used must not have a structural mutation.**

Amend 33.9

33.9 New Traits of a Championship Breed.

33.9.1 Any new trait or traits of a Championship Breed, not recognized for competition in the kitten, cat or alter class of that breed, **that is not a structural mutation (such as, but not limited to, folded ears, short legs etc.)** may be exhibited in the New Traits Class. New Traits Class cats appear in the catalogue and judges' books and judges include these cats in judging fees.

Add 33.9.4 and renumber the subsequent rules in Article 9:

39.4 Structural mutations are "owned" by the first breed establishing championship status that displays that structural mutation (such as folded ears: Scottish Fold; short legs: Munchkin; curled ears: American Curls, etc.) New breeds may only use this structural mutation with permission (a majority vote of the breed section) of the breed/breed group owning it.

PRO: It prevents the creation of new breeds in TICA resulting from the introduction of a structural mutation. It changes the purpose of the New Trait class to be solely trait differences in color, pattern or coat.

CON: It prevents the creation of new breeds in TICA resulting from the introduction of a structural mutation. It changes the purpose of the New Trait class to be solely trait differences in color, pattern or coat. The proposed rule changes do not protect existing breeds, or cats with structural mutations currently being shown in the New Traits class. No newly discovered structural mutations would be allowed to develop under these proposed rule changes.

Good point Carol. A short legged Sphynx is a structural mutation and with the proposal passed it can't be shown in the NT class. The cat needs to be DQ or transfer to the HHP class. A hairless Munchkin is not a structural mutation and it's allowed in the NT class.

The new rule states:

""33.9 New Traits of a Championship Breed.

33.9.1 Any new trait or traits of a Championship Breed, not recognized for competition in the kitten, cat or alter class of that breed, that is not a structural mutation (such as, but not limited to, folded ears, short legs etc.) may be exhibited in the New Traits Class. New Traits Class cats appear in the catalog and judges' books and judges include these cats in judging fees.""

It changes the purpose of the New Trait class to be solely trait differences in color, pattern or coat.

I really think we all need clear instructions from our JA about how to understand this new rule before May 1st. We can't send different and confusing messages to the exhibitors.
