You must also complete the following requirements:

- At least 90 days prior to the Board Meeting at which approval is sought: Submit an electronic Application for Acceptance as an Advanced New Breed Class to each member of the Genetics Committee and each member of the Rules Committee. Any proposed modifications to a previously approved standard must be submitted with the application.
- At least 60 days prior to the Board Meeting at which approval is sought: Following approval of proposal by the Genetics Committee and Rules Committee, the application must be submitted by the proposed Working Group Chair to the TICA Executive Office. Any comments of the Genetics Committee or Rules Committee must be included.
- At the Board Meeting where application is made: Make a formal presentation. Information presented should include photographs, illustrations, statistics, health and breeding reports, representatives of the breed and any other relevant material.
