The license fee is due no later than 4 weeks prior to the show date. *The Annual Awards fee is due no later than 7 days prior to the show date.*

The Executive Office cannot prepare and ship show supplies until this document has been received in the Executive Office. Please fill it out as soon as possible and send it together with a copy of your show flyer. The Executive Office is authorized to charge a fine of USD 25 for failure to submit show flyers. Show supplies are shipped the first week of the month prior to the month your show is held. If the application is not on file in the Executive Office when show supplies are shipped, a Late Application Fee of USD 25 will be charged. Show supplies will not be shipped without an application on file, and all charges for late shipment will be assessed to the club.

The undersigned hereby agrees to save and hold harmless The International Cat Association (TICA), its officers, directors, and employees from any and all liabilities arising out of the aforementioned show(s).
