Applications received after these deadlines will be presented at the following scheduled Judging Committee meeting. Once the application has been submitted, if all requirements have not been met by March 15th for the April meeting, July 15th for the August meeting, or November 15th for the December meeting, the applicant must reapply at a future scheduled Judging Committee meeting.
