## **Legislative Committee Report**

*Jay Bangle – Committee Chair*

### **January 2010 Board Meeting**

This report is for the second half of 2009.

#### Great Lakes Region

Still, no active liaison in Great Lakes region.

#### Mid Atlantic Region

Still, no liaison in Mid-Atlantic region.

#### Mid-Pacific

I'm pleased to introduce a new MP Liaison – Brigitte Cowell. Dr. Cowell is a SV breeder residing in San Francisco. She was instrumental in a small kurfuffle regarding CA Fish & Wildlife merely days after she took over the post. A mistaken wording would have made all Bengals, Savannahs and Chausies illegal in the state. In a little over 24 hours, Brigitte and Southwest's Liaison, Kristine Alessio were able to get the issue resolved.

Dr. Cowell's report:

#### Legislative Report – Mid-Pacific Region – 2009

I was appointed to the Legislative Committee mid-August, so this report only covers the last few months of the year.

#### Northern CA:

September 1<sup>st</sup>, California Fish & Game posted online a proposed new regulation, an addition to Title 14, Section 681 entitled "Hybrids". This came to the attention of several people that drew it to my, Jay Bangle's and Kristine Alessio's notice. The actual wording was not as concerning as the more unofficial "Statement Overview" that included the words "hybrid of restricted exotic cats and non-restricted domestic cats". Of course, this wording meant that all non-domestic source hybrid cat breeds (such as Bengals, Chausies and Savannahs) would be affected by this new regulation. This could be potentially devastating for breeders throughout the state.

A game of phone tag ensued, but eventually the right person in the department was cornered on the phone to express dismay and shock that we were worried. We were told that the department did not at all mean to regulate cat breeds, and that that wording must have gotten copied into the overview by mistake. The departmental source pointed out that the actual wording of 681 says "unless otherwise provided in these regulations" and

Ongoing efforts to change the status of Bengals, Savannahs and Chausies in Alaska, to allow them to be owned in that state continue. Proposals have been submitted to AK F&W to put these breeds on the “clean” list, which includes other domestic cats.

#### South Central Region

Report submitted by Kelly Crouch:

Arkansas:

AR S 864 - licensing of multiple pet owners, withdrawn by author.

Little rock - MSN and mandatory microchipping of free roaming cats required. Passed.

Kansas:

Wichita - animal Maintenance permit required if own more than 2 cats. Passed.

Louisiana

New Orleans - MSN, current status withdrawn

Denham springs - let limits passed before notice given to the committee of the proposed ordinance

Oklahoma

HB 1332: Pending legislation that will requires that anyone who sells, gives away, or transfers a cumulative total of thirty-five (35) or more dogs/cats (or any combination) of any age in any one (1) calendar year to be subject to licensure and inspections which mirror USDA standards. Did not get out of the conference committee.

Texas

HB 3180 - breeder/dealer licensing/puppy and kitten lemon law regulations. Anyone selling one dog or cat (including rescuers) would have been subject to regulations. Dead (Passed House Floor but not Senate). Companion Bill SB 1910 wasn't pursued as he chose instead to amend HB 2310 to include most of SB 1910. Author of HB 2310 did not accept the amendment and it was removed. This effectively killed all three bills.

SB 1845 sterilization of dogs and cats or \$300 Intact Animal Permit per dog and cat, Companion Bill HB 4277. Author didn't pursue passage of this bill.

Dallas - MSN, Breeder Permits, Pet Limits. Passed

Fort Worth - MSN, Mandatory microchipping. Passed

San Marcos - Mandatory microchipping. Rescinded

that the previous 671 already covered our hybrid cat breeds and they were not to be regulated.

We decided to be safe that we would attend the Fish & Game meeting to discuss the new regulations and have it put on record that this was the case. So we had a little trip out to Woodland, CA with a night's stay in a hotel and an early morning call to the meeting. All went as planned and the videotape record of the meeting confirms exactly as the source had already stated to us. A big sigh of relief all round. It was a very positive meeting as the Fish & Game Commissioners voiced their appreciation that we came to express concern, and invited us to suggest wording to make it clear that this regulation would not affect domestic cat breeds.

NV:

The city of Las Vegas, NV proposed a Mandatory Spay-Neuter Ordinance in November. This was passed 5-2 on November 18<sup>th</sup> and requires spay-neuter of all cats and dogs over 4 months of age. Permits were said to be available to dog and cat fanciers, law enforcement agencies, professional animal handlers and service animals. A Cat Fancier's Permit will cost \$50 a year but only allows up to 6 intact animals to the permit holder.

This ordinance is thought to be inspiring similar proposals in other NV counties, upcoming for next year possibly. Despite evidence to the contrary that this kind of regulation does not work, and despite letters from veterinary associations advising against it, it seems that it is still a popular concept with politicians and will continue to endanger hobby breeders of dogs and cats in the future.

UT:

Earlier this year, some upset was caused by an employee of the State's Department of Wildlife Resources, when she responded to a query by a person moving to the state on the legality of non-domestic source hybrid cat breeds. This employee stated that they were not legal. Close examination of the Rule 657-3 by Jay Bangle at the time indicated that this was an error as the DNR rules stated that any cat breed registered by The International Cat Association was allowed. That section preceded any section on feline hybrids but it seems it was possibly open to interpretation. By May, the opinion of the DWR employee had changed after consultation with their lawyer. By November they had email confirmation that UT was no longer misinterpreting the rules and that Bengals, Chausies and Savannahs were "safe". There was mention by this employee that the department was considering rewriting the law but nothing as to new wording has yet to be proposed.

OR: no new regulations have been proposed.

Northeast Region

No liaison for Northeast region.

Northwest Region

Plano - MSN, breeder licensing/standards. Passed.  
Southeast Region

No report submitted.

#### Southwest Region

Legislative Committee Report - SW Region  
Kristine C. Alessio, Esq.

California continued to be a battle ground for anti-breeder, anti-pet ownership legislation. Fortunately in October 2009, Governor Schwarzenegger vetoed the three bills which had the potential to affect our hobby and the fancy in general. AB 241 (statewide limit laws), AB 243 (permanent confiscation of animals without formal criminal charges being brought) and AB 1122 (selling on animals at public places such as fairgrounds) were vetoed.

In Southern California, the County of Los Angeles, On September 29, 2009, despite protest from TICA's Legislative Committee, tightened and revised their rules for breeders of dogs and cats. In a nutshell: 1. There will be a limit of five altered cats per residence without a animal facility permit. The cats will have to be licensed. (Section 10.20.038(B)); 2. If you have more than five cats and one litter a year you will need a Dog and Cat Breeding and/or Boarding Facility license (Section 10.08.070). The fees for this license range from \$300.00 to \$525.00 depending on the actual number of cats and dogs you have or 75% of the capacity for dogs and cats in your "Breeding Facility";3. In the proposed new definition of "Animal Facility", it could be construed as meaning a cat show hall; 4. The provisions of Section 10.20.040 which previously stated that cat licenses were not required when attending a cat show or in transit will be stricken. I am concerned that this will mean that any cat traveling through Los Angeles County en route to a show outside of the County may be forced to have a license. The County of Los Angeles has not responded to any concerns voiced by TICA concerning the fourth item listed herein.

Fortunately though on October 28, 2009, the Los Angeles County Planning Department rejected zoning changes that would have effectively eliminated dog and cat breeding within the County.

Arizona, Hawaii and New Mexico have not had specific legislative activity which affects the fancy during this reporting period.

#### The Future

I continue to bring myself back up to full-strength, and hope to be more active in the upcoming year. Several states, including CA will be active again, with MSN, breeder licensing, pet limits and other negative legislation in 2010. I hope that we will have more people helping us keep watch and actively fight in their localities in the coming year.

I will also ask all RD's to periodically remind their members of the importance of the Legislative Committee and to encourage members to participate, even when their region is sufficiently represented. Individuals are our eyes and ears in their local areas. Please encourage ALL members to keep tabs on their local, and state governments and what they are doing with regards to animal legislation. This is something that everyone needs to keep in mind.

### 109.1 Annual Convention.

109.1.1 Annual Convention. Labor Day weekend each year is reserved for the Annual Convention. No other shows may be held the weekend of the Annual Convention with the following exception. A club may receive permission to hold a show on the Annual weekend upon application to the Board. Application must state specific reasons for the request for exemption and why such a show would have no impact on the Annual.

109.1.1.1 The rotation for the Annual Conventions shall be: Mid Pacific - 2010, Mid Atlantic - 2011, Great Lakes - 2012, Northwest -2013, Northeast - 2014, International - 2015, Southwest - 2016, South Central - 2008, Southeast - 2009.

109.1.1.2 Proposals to host the Annual Convention in the designated region must be received for the Annual Meeting 3 years prior to the proposed convention.

109.1.1.3 In the event no club submits an acceptable proposal, any club in any region may submit a proposal to host the Annual Convention by the agenda deadline for the Semi-Annual Meeting 2½ years prior to the convention and a notice soliciting such proposals shall be published in the TICA TREND.

109.1.1.4 The subsequent designated order of rotation will remain the same.

### 109.2 Meetings of the Board.

109.2.1 All Board Meetings shall be scheduled for a minimum of 2 days.

109.2.1.1 Meetings of the Board shall be the fourth full weekend in January (Winter Meeting, the third full weekend in May (Spring Meeting) and the week immediately preceding Labor Day weekend (TICA Annual).

109.2.1.2 The Winter Meeting shall be held in Harlingen TX without a show OR at a location outside the United States in conjunction with a show, approved by the Board.

109.2.1.3 The Spring Meeting shall be held in the United States, rotating from Central to West to East, with or without a show. The meeting venue must be at or near a major international airport at a hotel with adequate meeting space, full restaurant service and airport shuttle.

109.2.1.4 The Winter and Spring meeting locations shall be selected by the Board without consideration of accompanying show.

109.2.1.5 Minutes of all meetings of the Board of Directors shall be completed within 10 working days following the meeting.

## Current Standing Rule

106.4.5 Feline Welfare Committee. The role of the Feline Welfare Committee is to assist in resolving complaints made to TICA about the welfare of cats, to aid and assist breeders who may need or request help, to promote the Responsible Breeder Program, to create and assist in the implementation of a breeder mentoring program or other programs to assist TICA members with feline welfare issues, and to make recommendations to the Board of Directors on programs to promote feline welfare and responsible breeding.

### **Discussion on FW committee's role**

The roles of a Feline Welfare Committee (FWC) and a Rescue Committee (RC) would seem to be similar. After all, rescue could be seen as the work of those concerned with feline welfare. For the purposes of having committees we need to come to a good description of each group, making their roles distinct and delineating where the division between their roles are. That is something the entire FWC seems to agree on!

Note: There is not a standing rule defining the TICA Rescue Committee and its purpose in TICA – may we suggest a rule that states; The Rescue Committee in TICA functions as a liaison with PCBR and other Rescues.

The role we see for FWC is:

- Our mission statement is in the title of the Committee. We are the Feline “Welfare” Committee so that the welfare of the cats is our priority and we do what we can to help the cats regardless of which other organizations we might need to contact for help.
- Handling complaints, this may involve setting up new procedures allowing a two-step process with an initial “anonymous” step before evidence is collected showing the need for a formal complaint. This may also involve setting up procedures to investigate or inspect the situation.
- Creating programs to aid breeders and enthusiasts, to prevent confiscations or the need to surrender cats to Rescue. This may involve setting up regional groups that confidentially may volunteer to do cleanup projects, organization and other assistance to a fancier in need.
- Promoting education to improve feline welfare.

Confidentiality seems key to smooth and effective function of the FWC, we feel we will need to create confidentiality agreement documents, firstly for FWC members guaranteeing that complaints will be confidential until such time as it is presented to the Board. Secondly, for any participants in the proposed regional programs to offer assistance to breeders or fanciers in need.

How we see FWC differing from RC:

- FWC does not handle rescues, any situation requiring physical transfer of cats will be referred to RC
- In any situation FWC is involved in, be it a complaint issue or breeder assistance, at the point where cats need to be removed from the breeder/fancier's premises then FWC would step back and pass the situation to Rescue to take over. Cleanup of facilities would be the realm of FWC, moving of cats would be for RC.

We asked DeLynne Saltmore, chair of TICA Rescue Committee, to submit rescues position for your review....it is as follows:

**Roles and Responsibilities  
Rescue Committee As Opposed To Welfare Committee**

The TICA Rescue Committee would like to submit the following information (cover page and three attachments) with respect to the delineation of roles and responsibilities of the two committees:

1. Clarification of what rescue is and what it is not.
2. Tips for Rehoming a Cat (referred to in the "What Rescue Is Not" portion of Attachment 1).
3. A comparison chart. This was previously submitted back in 2006 as requested at that time.

## WHAT PUREBRED RESCUE IS...

Often there is a lack of understanding of what Purebred Rescue is, and what it is not. Generally, each individual rescue program will consider many factors that can vary considerably from one organization to another, and that will dictate how the rescue program will operate as well as its scope and limitations.

- ◆ First and foremost, a Purebred Rescue program is the safety net for cats of any recognizable breed that find themselves homeless and in shelters.
- ◆ In some extreme situations, that same safety net can extend to cats that, because of emergency situations, are in danger, but have not yet been relinquished to a shelter. This can include such situations as owners who suffer serious illness or death. As a general rule, it is not wise for a rescue program to routinely accept all direct owner relinquishments of cats. In those emergency situations where a rescue does accept such cats, care must be taken to obtain written authorization by the owner, or if that person is incapacitated, by the family.
- ◆ A rescue program ideally will involve removal of cats from high risk situations, with the rescue group assuming full responsibility for the vetting and adoption process. Alternatively, it might include other activities, such as coordinating transport and rescues, providing expertise in identifying purebred cats, designating donations to the shelter for care of specific purebred cats, providing help to shelter personnel in grooming cats in preparation for adoption, transporting and many other similar activities.
- ◆ Rescue, in some cases, will mean "cleaning up" after the few less than scrupulous breeders - those who do not exercise proper care in choosing homes for their kittens, and who do not provide the education that new owners need to ensure that the animal will be in that home for life. As a result, the cats will usually be poor representatives of their breeds. Some, in fact, will require the rescuer to make a close judgment call at the shelter in order to determine whether, for instance, the cat in that cage really is or is not a particular breed (rarely are papers relinquished with the cat). Generally, any genuine doubt should be resolved in the cat's favor.
- ◆ Purebred Rescue is a part of the puzzle that can help achieve the goal of no unnecessary shelter euthanasia. It is the part of the puzzle where the organized cat fancy offers unique expertise and actively participates.

## WHAT RESCUE IS NOT...

- ◆ Rescue is not the forcible removal of another person's property, or the seizure of a cat without the owner's permission. While fanciers generally abhor the practice, for instance, of allowing cats outdoors, that alone is no justification for capturing another person's cat and calling it "rescue." The authorities and courts are more likely to call it "theft," and there may be significant penalties.
- ◆ Rescue is not a vehicle for breeders to place their retired breeding cats, and this practice can completely undermine an otherwise exemplary program. Neither is rescue the place for catteries to dump cats or kittens when they get overloaded. Cats should be safe with the breeder, and it is the breeder who has the responsibility of

finding them new homes.

- ◆ Rescue is absolutely, positively not a vehicle for placing intact, breeding cats, no matter what the source, the breed, or the quality of the cat! Once any individual cat has entered the system (other than in disputed legal cases), the time for anyone putting it into a breeding program is past, and the quickest way to undermine an entire rescue program is to even broach this possibility with a shelter.
- ◆ A rescue group can quickly become overwhelmed if it becomes a convenient dumping ground for cat owners who want to relinquish their cats. The contact person should develop a list of questions that will help determine whether a genuine emergency exists which fits the criteria for rescue. Quite often, with counseling, the contact person can resolve the problem causing the owner to want to relinquish the cat. When the owner has definitely made up their mind to relinquish, then the rescuer can offer advice on ways that the owner can place the cat or refer them to our "[Tips on rehoming your cat](#)". If the rescue has resources to accept owner turn-ins, then charging a small "relinquishment fee" is one option. Arranging an appointment for intake 1-2 weeks later is a technique you may want to use to assess how much of an emergency the situation is.
- ◆ Rescue is not for every purebred cat. There are some cats that are simply not adoptable and would be a terrible drain on rescue resources that could be put to better use helping cats that are candidates for adoption. Chronically, actively aggressive, biting cats, for instance, raise significant liability concerns. There may also be circumstances where it is more humane for a cat to be euthanized.
- ◆ Rescue is not a means for others to browbeat cat owners. A relinquishing owner almost always believes that he has exhausted all avenues of keeping his cat. A call to the rescue program, if the rescue contact is patient and diplomatic, may be an opportunity to provide education to resolve problems so that the owner can keep the cat. Blaming or heaping guilt on the cat owner does the cat no good. There are many owners who can benefit from some diplomatic suggestions and education.
- ◆ A rescue program should be used only very cautiously in those rare cases in which a breeder may have become overwhelmed by unexpected circumstances and the quality of the cat care begins deteriorating. If "intervention" is to happen, very careful consideration must be given to the extent of direct activity in dealing with that breeder's cats. It is absolutely necessary to obtain documentation attesting to the legal relinquishment of ownership of each specific cat to avoid later regrets on the part of the breeder and possible legal action against your group.

## IF YOU ARE AN OWNER LOOKING TO REHOME YOUR CAT

NOTE: Please do not turn to rescue for a safe haven for your cat unless there is absolutely no other choice. There are many purebreds in shelters who need those rescue spaces and if a rescue takes your cat that may well mean another purebred pet in a shelter will be killed.

### BASIC SUGGESTIONS FOR PLACING YOUR CAT:

- Spay and neuter your pet if not already spayed or neutered.
- Make sure your pet is up to date on vaccinations
- Wash and groom your pet before taking pictures or showing your pet to potential adopters
- Prepare a history of your pet including veterinary history, favorite treat, what food the cat is used to eating, what litter the cat is used to using and what sort of litterbox. Preparing a cat [resume](#) to give to potential adopters is a good idea.
- Screen all potential adopters. Ask about their experience grooming a Persian and clipping nails. Ask how much time they are at home and what arrangements they make for a pet when they are away or ill. Ask if they have ever declawed a cat. Ask if they ever allow their cats outside. Ask to for their permission to speak directly to their vet about their history with animals, including how up to date the animals are on vaccines, how diligent they are about maintenance issues like teeth cleaning, and under what conditions they have euthanized pets, if ever. Ask if they have ever brought an animal to a shelter to relinquish the cat. Find out what other animals they have and have had and what experience they have with grooming. Find out if any people in the household have allergies. Ask if they will allow you to visit their home before you place the cat there. Ask if they have arrangements in place for someone to care for the cat should they become ill, are hospitalized, or die.

### ADVERTISING YOUR PET:

1. Contact the breeder and ask if they will take the cat back or help you rehome the cat
2. Contact the [Breed Rescue](#) to see if they can help you advertise your cat.
3. Advertise your cat and charge a nominal fee (do not offer for free as it attracts undesirable interest from those who may not value your pet:
  - Post an ad on <http://www.petfinder.com/post/classifiedhop.html>
  - Make flyers which display your cat's photo and put your contact information on it. You can make a flyer here: <http://www.bestfriends.org/nomorehomelesspets/resourcelibrary/flyermaker/flyermaker.cfm>. Ask your vet to post it in his/her office. Put them up at work. Ask to post them at the local pet stores and food markets. Post them at your church. Post them on community bulletin boards. Give them to your friends and family and ask that they post them where ever they can. Post them at the local grooming establishments.
  - Put an ad in your local newspaper - charge a minimal fee to discourage those who would sell to research laboratories

### **PREPARING FLYERS:**

- Describe the appearance, size, and age of the animal.
- Describe his/her nature and appealing qualities.
- Include the pet's name
- State that the pet is spayed or neutered.
- Define any limitations, e.g. not good with cats/small children/ other dogs/other cats.
- Use a good photograph. Color is best. Copy places like Kinko's can help with these.
- Be sure to put in your phone number, and time you can be reached.

### **PREPARING A CAT RESUME:**

A cat "resume" provides an opportunity to present potential adopter with a summary of your pet's best qualities and an example of your commitment to your pet. We suggest that you include the information below in their cat resume:

- Tell the potential adopter what foods your cat is used to and what litter you normally use. Provide the cat's usual litter box, dishes, toys, scratching post, if possible, and a worn article of your clothing to place in their bedding - the familiar items and the scent of you will make the transition easier.
- Provide a complete veterinary history from your veterinarian for the adopter to take to the new vet. If your cat is not spayed or neutered, please make arrangements to have spay or neuter done prior to placement in a new home.
- Describe your pet's age, activity level, and/or breed traits. Describe characteristics that make your pet suited or unsuited for living with other animals.. Tell the adopter something special about your pet's personality, and how much you care about your pet. There can be a big difference between a 10-year-old cat and an active, inquisitive kitten. If your pet is quiet, calm and/or less active, point that out. If you have an active cat, explain how you fulfill his/her exercise requirements and what cat toys are used during play times.
- Give examples of your pet's good behavior. If your cat has lived in other homes before temporarily and is accustomed to changes, be sure to say so. If you have more than one cat or a dog, let the new home know how your cat gets along with the other animals. If your cat uses a scratching post, say so and make sure to note that your cat is litterbox trained.
- Explain any bathing or grooming requirements, including frequency of claw clipping and grooming, and shampoos used.
- Describe any behavioural quirks, difficulties with certain situations (the vet, other animals, thunder storms, etc). The foster home needs to know what to expect for them to be a "good fit" for your cat.

In addition to your cat's resume, you may also want to provide addresses of your cat's usual groomer, veterinarian and a picture of your cat.

**NOTES TO FINANCIAL STATEMENTS**  
June 30, 2009 and 2008

**NOTE A - SIGNIFICANT ACCOUNTING POLICIES**

The International Cat Association, Inc. (known as "TICA") was incorporated October 25, 1982 under the Texas Non-Profit Corporation Act, with its primary purpose being the promotion and dissemination of educational and scientific information on felines to the general public. The Board of Directors, comprised of a President and Vice-President, and Regional Directors, oversees the activities of the Association.

***Basis of Accounting***

Basis of accounting refers to when revenues and expenditures or expenses are recognized in the accounts and reported in the financial statements. Basis of accounting relates to the timing of the measurements made, regardless of the measurement focus applied.

Financial statement presentation follows the recommendations of the Financial Accounting Standards Board in its Statement of Financial Accounting Standards (SFAS) No. 117, *Financial Statements of Not-for-Profit Organizations*. Under SFAS No. 117, the Association is required to report information regarding its financial position and activities according to three classes of net assets; unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

***Revenue Recognition***

Contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support, depending on the existence and/or nature of any donor restrictions. Contributions received with donor-imposed restrictions that are met in the same year in which the contributions are received are classified as unrestricted contributions.

All donor-restricted contributions are reported as an increase in temporarily or permanently restricted net assets, depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions. No activity was temporarily or permanently restricted during the years ended June 30, 2009 and 2008.

***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***Concentrations of Risk***

***Concentrations of Risk Due to Temporary Cash Investments and Trade Accounts Receivable***

Financial instruments that potentially subject the Association to concentrations of risk consist principally of temporary cash investments and trade accounts receivable. The Association places its temporary cash investments with financial institutions and limits the amount of credit exposure to any one financial institution. Concentrations of credit risk with respect to trade accounts receivable are limited due to the large number of members comprising the Association's membership and their dispersion across different geographic areas.

**NOTE A - SIGNIFICANT ACCOUNTING POLICIES - Continued**

***Concentration of Risk Arising from Cash Deposits in Excess of Insured Limits***

The Association maintains cash balances with high quality credit institutions. At times such cash and investments may be in excess of the FDIC insurance limit.

***Income Taxes***

For all periods presented, income taxes are calculated using the liability method in accordance with the provisions set forth in Statement of Financial Accounting Standards (SFAS) No. 109. Deferred income tax assets and liabilities are computed annually for differences between the financial statement and tax basis of assets and liabilities that will result in taxable or deductible amounts in the future based on enacted tax laws and rates applicable to the periods in which the differences are expected to affect taxable income. Valuation allowances are established when necessary to reduce deferred tax assets to the amount expected to be realized. Income tax expense is the tax payable or refundable for the period plus or minus that change during the period in deferred tax assets and liabilities.

***Inventories***

Inventories of supplies for resale as of June 30, 2009 and 2008, is stated at principally the lower of cost or market. Cost is determined on the first-in, first-out basis.

***Property, Plant and Equipment***

Property, plant and equipment acquisitions have consistently been recorded at cost if purchased or fair value at date of gift if donated. Major renewals and improvements which extend the life of an asset or benefit one or more subsequent periods are capitalized. Replacements, maintenance, and repairs which do not extend or improve the life of existing assets are charged against income in the period incurred. When properties or equipment are retired or otherwise disposed of, the property and related accumulated depreciation accounts are relieved of the applicable amounts. Gains or losses from normal retirements or sales are credited or charged to income.

***Depreciation***

Equipment and furniture are being depreciated using the straight-line method over their estimated useful lives, ranging from 3 to 10 years. Depreciation expense totaled \$33,116 and \$32,785 for the years ended June 30, 2009 and 2008.

***Cash and Cash Equivalents***

For purposes of the statements of cash flows, the Association considers all highly liquid debt instruments with a maturity of three months or less to be cash equivalents.

***Certificates of Deposit***

Certificates of deposit, totaling \$167,467 and \$164,499 at June 30, 2009 and 2008, are presented on a separate line on the accompanying financial statements. The certificates bear interest ranging from 3.11% to 3.75% and have maturities ranging from three months to one year, with penalties for early withdrawal. Any penalties for early withdrawal would not have a material effect on the financial statements.

**NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued**

***Non-Profit Status***

The Association has adopted the policy that no member shall personally profit from the operations of the Association except for reasonable compensation for services actually rendered by officers and employees of the Association.

***Prepaid Expenses***

Prepaid expenses are advance payments for products or services that will be used in operations at some future period.

***Credit Memos***

Credit memos are generated when customers overpay for services or remit payment for registrations that are pending approval or required documentation. The credits are reduced when customers are refunded or once required documentation is received and the registration is granted.

**NOTE B - NOTES PAYABLE**

The notes payable are related to capital leases. The notes are payable to Pitney Bowes, Inc. and the implied interest rate on both notes is 7%. See Note C relating to the capital leases.

**NOTE C - CAPITAL LEASES**

As of September 7, 2005, TICA entered into a seventy-two month lease with Pitney Bowes, Inc. for a folding machine. The lease has been classified as a capital lease because the lease term exceeds 75% of the estimated economic life of the assets. Therefore, the present value of the monthly lease payments has been capitalized as a fixed asset with an associated note payable. The implied interest rate is 7%. The monthly payments on the lease are \$655.

As of June 23, 2005, TICA entered into a sixty-nine month lease with Pitney Bowes, Inc. for a postage machine. The lease has been classified as a capital lease because the lease term exceeds 75% of the estimated economic life of the asset. Therefore, the present value of the monthly lease payments has been capitalized as a fixed asset with an associated note payable. The implied interest rate is 7%. The monthly payments on the lease are \$675.

**NOTE D - EMPLOYEE BENEFIT PLAN**

TICA has a defined contribution retirement plan covering all employees who have worked there longer than one year. Under the plan, TICA will match an employee's salary deferral contributions up to a maximum of 3% of the employee's compensation. Under the Internal Revenue Code, the plan is referred to as a Savings Incentive Match Plan for Employees.

**NOTE E - FEDERAL INCOME TAXES AND DEFERRED INCOME TAXES**

As discussed in Note A, the Association was organized and incorporated under the Texas Non-Profit Corporation Act and filed an application for exempt status. The Association had originally intended to be exempt from federal income taxes under the provisions of Section 501(c)(6) of the Internal Revenue Code. However, the application originally submitted to the Internal Revenue Service in 1993 for consideration as a not-for-profit, exempt organization under Section 501(c)(6) of the Internal Revenue Code was denied. As a result, TICA has filed federal income tax returns as a for-profit corporation with applicable provisions made for federal income taxes. Deferred income taxes are computed by applying statutory rates to temporary differences between the recognition of income and expense for financial statements and income tax return purposes based upon the expected period in which the differences will reverse. The principal difference arises from the use of different methods of depreciation for financial reporting and tax return purposes. The provision for federal income taxes is computed on pre-tax accounting income at statutory rates.

## TREND REPORT SUMMARY

Brigitte McMinn

TREND advertising rates need to go up again to finally get them to reflect the distribution rates of the TREND – I have raised prices once, but didn't want to raise them all at once to stop advertising. The TREND no longer offers discounts on ads –i.e. placing a years worth gets you x off, but does offer discounts on cattery ads placed for a full year (basically I have this set up as seven issues - the first ad is full price and then you are offered the discount if you go the full year)

Shipping rates again - The TREND printing fees were almost 100% covered by advertising. Shipping rates need to reflect the increases made by the US Post office annually in May. First Class Shipping fees should be raised. (Currently \$8/year)

Other recommendations/observations:

TREND Back issues should be offered on the web at \$15 each - I think you will be surprised to find that people WILL order them! Each issue, I send a minimum of 4 people wanting to buy extra copies to the EO –

Regional and International Winners issues will ALWAYS breakdown at a higher cost due to additional pages to include winner information (17 pages in current year issue).

3.25 pages of Board minutes - consider web only.

Judges List/Clerks/ - consider printing every other issue to reduce printing/postage fees

RD Candidate Statement fees should reflect current advertising rates - Statements were 1/2 page in length - 1/2 page B/W ad is \$150 - or \$125 for clubs. \$30 does not cover costs to print.

Revise By-Law 1.5.4.1, Standing Rule 105.4.2 (Crockett)  
Board Direction

Revise HHP Committee to include one representative from each Region

Revise:

1.5.4.1 Breed Committees Except for the Household Pet Breed Committee, the number of breed committee members... (continue as current)

Renumber 105.4.2 to 105.4.3

Add:

105.4.2 The number of Breed Committee members for household pets shall be equal to the number of TICA regions. One member shall be elected from each region.

Rationale: Since there is no breeding requirement, only owning/showing, it is quite different from the rest of the committees.

Rules would need to be rewritten to increase the number of committee members from 7 to the number of regions (currently 13). Further there would need to be ballots for each region.

Breed chair would be the regional rep with the highest number of votes.

Some History:

In the Oct/Nov 1996 Trend the standing committees (like us) are listed. One of them is Household Pet, led by (as I emembered) Patti Andrews. I see Gloria Mahan and Linda Swierczynski listed as members of the committee. Both are still active in TICA.

The other committee shown on the website at that URL is NOT the elected committee. It IS different from the 3 year rotation committee. It is specifically appointed by the Board. And it's 'charter' is different from the breed committee. The breed committee is involved with the standards/rules. THAT committee is charged with promoting the HHP.

Rules Comments:

(DL)

1) I disagree with this idea. The purpose of the breed committees according to 14.2 of the by-laws is to : "be responsible for developing a comprehensive standard for the breed/breed group and proposing amendments and revisions of the standards for the breed/breed group." I would include to be aware of any rule changes which might affect the breed.

I don't see that it is necessary for the committee members to be elected one from each of the regions in order to effectively do this. Not that it wouldn't be good to have members from several areas. I just don't see any necessity to REQUIRE one member from each region.

I DO see where the multiple locations would be beneficial for the OTHER HHP committee. My understanding of that committee is to promote the HHP and to make cat people aware of showing HHPs, etc. This committee can be found at <http://tica.org/members/committees/hhp.php>

2) I'm happy as things are. It ain't broke, dun fix it!

Those who are interested in keeping watch over rules and regulations are not necessarily the same people as those who like to promote. I personally tend to be rather quiet, reserved and more interested in 'book work'.

Others are very outgoing and are great at convincing others of their view points. I think having two separate

committees with different foci is the better choice. Although it's true that HHPs don't have conformation and therefore there isn't much to do...there are many breeds that DO have conformation who haven't made changes for a long time. And over the years, HHPs HAVE made some changes: the titles have changed, the rules for HHP kittens have changed, and more. Some of the changes came from the breed committee, some from the Board. There is nothing wrong with a committee that simply keeps an eye on things.

What I WOULD like to see is for the other committee to be doing something actively. I haven't heard of anything they've done. If they have it would be nice if they'd toot their horn.

(BT) You are right - there are many breed committees that do nothing and haven't changed anything in years.....they are supposed to be presenting a breed seminar every 3 years....but I don't really see that happening either. Maybe at the Annual and the individual CEU events but other than that we seldom see seminars in conjunction with shows any more.

Maybe the way to write the proposal would be your suggestion for change and a brief \_ "there are now the breed committee that is elected" and the HHP Committee that is a Standing Committee appointed by the President and perhaps the focus of one per Region should be on that committee as they are for the promotion of HHPs and HHP showing?

(LS) Well, I'm going to leave the whole HHP committee to y'all with only my thought that it seems to me a whole lot of "tempest in a teapot" - in other words, there isn't anything to fix, since there isn't anything broken (although that might just be because there isn't anything going on at all), so pretty much a Giant Waste of Time (with the added potential of pissing people off that run for the HHP breed committee).

(KS) I also think we should eliminate the appointed committee and make it an elected one.

(AF) Why not just merge the committees; one member from each region would work, but the number seems to be excessive.

With the elected committee having only 2 of 7 needed members, they are considered (by the EO) "inactive", and as such not able to accomplish much.

The appointed committee appears to also be "inactive", since nothing seems to be known about their activities (even from committee members).

I agree that the whole situation is not much of a problem, but having only one committee involved in HHP affairs, would be a more reasonable situation (even if they do nothing). Perhaps the restructuring into one overall committee would bring more interest in and visibility to HHP activities throughout TICA.

So to wrap up; I'm for one and only one HHP committee. How many members and how they find their way to the committee is up to the Board.

(AR) Why is the board considering this change? It looks like a make-work project to me.

We might suggest to the board of directors that they consider having only one HHP committee, and that the HHP Breed Committee might have their scope expanded to include the HHP Committee's mission.

I also would defer to Dorothy's experience with the HHP world.

And in that same vein - I think maybe the board was intending that the appointed HHP Committee - Not the elected HHP Breed Committee - was the one that should have a member from every region - That makes sense to me - a promoter in every region.

## Discussion Regarding Breed Sections/Groups

### Input Board

Regarding breed sections/groups:

I think we should limit the current consideration to breed committee members and what their breed section membership should be (or is required to be) in order to be a breed committee member. The rule at 15.4.2.5.3 only specifically addresses members of a breed section that have been merged into a breed group and who are seeking membership on the breed group committee. This rule does not state the requirements for breed section membership after election to the committee (only prior to the election; i.e., to be on the ballot).

After being elected to a breed group committee, the E.O. is requiring some breed committee members to be section members in all the breed sections of the applicable breed group, but apparently no rules require this and it has become an issue with some of the membership.

Further, there is an inconsistency with the 14.3.1 through 14.3.3 proposed rules, whereby only single breed section membership is sufficient to allow a member to vote on ballots affecting a single breed, but breed committee membership is required in all the breed group sections (in accordance with E.O. office procedure) to be a member of the related breed committee. There could be some rationale for this in that a breed group committee member could be forming opinions, making decisions, and voting on all issues affecting all the breeds in the breed group, thus knowledge of and experience with all the breeds in the breed group could be useful, and therefore membership in all the relevant breed sections may be necessary.

For a merged breed group, a solution could be to add wording to the 15.4.2.5.3; e.g., "~~~ to seek membership on, **and if so elected, to become a member of** the breed group committee." For a more comprehensive solution with respect to the proposed rules, specific wording may be needed to follow 15.4.2.5 for determining to which breed sections a committee member must belong. Such wording would need to be consistent with the intent of the voting restrictions for breed section/group members.

An additional issue, but not rule specific, is the recognition (on the Web site and in the TREND) of duplicate breed committee members for the longhair/shorthair breed committees, and also a HHP and HHP Kitten "Breed" Committee. The election for these "committees" is but for one committee, and the one committee oversees the breed, not two committees - one for longhair, one for shorthair, both with the same members. When there are two committees listed for the same purpose, they should be consolidated into a single breed committee.

New wording is also needed at 15.4.1.4 stating the procedure for filling a vacant breed committee position other than the committee chair, especially when the committee election has not resulted in enough committee members to fill the committee. In practice, it can be done a number of ways, but there has been uncertainty from prospective candidates about the process for becoming a committee member when not via election.

For example; 15.4.1.4 could read:

"When a breed committee election results in an insufficient number of elected committee members, the elected committee chair will solicit breed section members' interest in serving on the breed committee and forward the names with the chair's (or committee's) recommendation to the Board for consideration for appointment to the unfilled breed committee vacancies."

(or something like that)

33.9 New Traits of a Championship Breed.

33.9.2 Requirements for Championship Status. A new trait or traits may apply for Championship Status upon completion of the following:

33.9.2.1 At least ten individual examples of the new trait or traits have been shown.

33.9.2.2 At least ten TICA members in good standing actively breeding and/or exhibiting the new trait or traits in the New Traits Class.

33.9.2.3 A minimum number of cats expressing the new trait or traits have been registered in the 3 years prior to application as follows:

33.9.2.3.1 Ten cats in breeds registering fewer than 100 cats OR

33.9.2.3.2 Ten percent of the cats registered, not to exceed 50 cats, for those breeds registering 100 or more cats.

33.9.2.3.3 When registering a cat with a new trait other than color, the “non-standard” box on the blue slip must be checked and the trait(s) indicated on the blue slip in order to facilitate tracking.

33.9.2.4 Submission of an electronic Application for Advancement to Championship to each member of the Breed Committee, (and if part of a Breed Group, to each member of each Breed Committee in the Breed Group), each member of the Genetics Committee, and each member of the Rules Committee, at least 120 days before the applicable Board meeting. The application must be signed by at least ten TICA members in good standing (applications available from the TICA Executive Office or at tica.org).

33.9.2.4.1 Any required standard changes must be included in the application.

33.9.2.5 Following approval of the Genetics Committee and the Rules Committee, and at least 90 days prior to the applicable Board meeting, the approved application shall be submitted by the Breed Committee Chair to the Executive Office for polling of the Breed Sections. The application shall include comments of the Genetics Committee on the genetic validity of the new trait or traits and any comments of the Rules Committee.

33.9.2.6 Upon receipt of the application marked as approved, the Executive Office shall issue a poll to all members of the related Breed Section(s). Polls must be returned to the TICA Ballot Judge no later than 30 days from the date of issue. In cases of a Breed Group, a majority of the Breed Section Members voting in EACH of the Breed Groups, must vote to approve the new trait or traits in order to advance to championship status. The results of the poll shall be included in the meeting agenda with the application.

33.9.2.6.1 The expense of any poll shall be the financial responsibility of the individuals requesting the poll.

33.9.2.7 A Notice of Intent to Apply for Advancement to Championship Status must be published in the TICA TREND at least 120 days prior to the meeting at which the application for advancement will be heard, and which invites comments about the breed to be forwarded to the Executive Office.

33.9.3 Meeting the requirements set forth in these rules does not guarantee advancement. The Board of Directors shall judge each request for advancement on a case by case basis.

**Rules Comments:**

(AR) Puts the dollar amounts in the Standing Rules where they belong.

(LS) Removes control over fees from membership.

(MW) The wording of the rule changes is fine. I would prefer to see the new fees as separate ballot items from the move of fees to Standing Rules.

Bearing in mind that Experimental breeds do not always move beyond the Experimental register, the Board may wish to consider if \$50 is too low an amount for putting a breed on the Experimental Register.

### Add Standing Rule 202.1.2.1 Show Dates

202.1.2.1 In regions where clubs are 500 miles apart, or more, the Regional Director may approve show dates for more than one club on the same weekend.

Rationale: Regional Directors need to be able to use judgment when assigning show dates. There is no reason to deny clubs in the same region that are geographically very distant from each other from scheduling shows on the same weekend. For example, a show in Argentina is not going to impact a show in Colombia; a show in Germany is not going to impact a show in Russia; a show in Costa Rica is not going to impact a show in Texas. On the other hand, while in different regions, a show in New Jersey could have a great impact on a show in New York.

Comments from Rules:

(AR) Yes, well, at one time we did have such a rule, but if we can't find it, we need to write a new one. I favor allowing more management by the troops on the ground, so am reluctant to encourage more restrictions, such as trying to legislate regarding shows in two or more regions. That is something the RDs and show managers have pretty much always worked out to everybody's benefit.

(KS) I do agree with the last line. A show in two regions on the same weekend can and does have exhibitors that could/would drive to both if they were on separate weekends. Not sure what can be done about it. Maybe it can be changed to 750 miles (or keep it at 500) but include any region affected.

(BT) The proposal puts in writing something that has been procedure and thought to be part of the rules!

(DL) I agree with you Bobbie. The California portion of MidPacific has always avoided So Cal dates as many people are willing to travel that far.

(MW) When I was running EN, we got a lot of show requests for duplicate weekends - often a UK club and a mainland Europe club (or vice versa).

The way I tackled it was to get the club that booked the first date (and therefore entitled to the date) to confirm that it was OK for the other club to have a show on the same weekend.

I believe that Ralph is similarly pragmatic about handling clubs that both want the same weekend..

## **Add new Standing Rule 901.4.1 (Junior Program Awards)**

(Existing 901.4.1 currently blank)

### **Rationale:**

Following the Annual 2009 Board Meeting at which the original 901.4.1 was removed as obsolete (following the introduction of the new JE program), Rules Committee were instructed to provide replacement rules that reflected the new JE program. Including these rules in 901.4 ensures that all awards at Regional and International level are co-located in the Standing Rules.

### **Add:**

#### 901.4.1. Junior Exhibitor Program Achievements

901.4.1.1 Junior Exhibitor Showmanship Excellence Award. Junior exhibitors meeting the qualifications set out in 83.1 of the Junior Program shall be recognised at Regional Award Ceremonies.

901.4.1.2 The Top Ten Junior Exhibitors will be recognized at the Regional Level with appropriate awards similar to those of the Top Twenty Cats.

901.4.1.3 The Top Five Junior Exhibitors from each Region will be recognized in the program at the International Awards ceremony.

901.4.1.4 All Junior Exhibitors who complete the program (including those who complete with Distinction), will be honored at the Annual Convention with an appropriate award, featured in the visual media presentation at the Annual Awards Banquet and in the TICA YEARBOOK in color, free of charge. The list of recipients will be printed in the TICA TREND.

# Issuance of Cattery Names

## Consider Office Policy Change

### The TICA Registration Rules, ARTICLE Eight, state:

*38.1 Cattery names may be permanently registered with the association upon written application and payment of the required fees.*

*38.2 A cattery name may not **exceed fifteen letters**. Cattery names **must differ by two letters**.*

*38.3 A cattery name may not duplicate the name of an accepted breed.*

*38.4 Registered cattery names may not be used unless the registered owner of the cattery name signs the application for registration or consent of such owner is filed in writing with an established association for cat registration.*

*38.5 The use of a breeder's registered cattery name is restricted to a prefix.*

*38.6 A breeder who initially registers cats without a cattery prefix and subsequently registers a cattery name may subsequently add a cattery prefix by paying the required registration fee to re-register such cats.*

*38.7 A new owner's registered cattery name may be added as a suffix (preceded by " of ") when this is possible without violating 38.9 or 38.10, of this article or violating ARTICLE TEN, 310.3.*

*38.8 A cat's name may include only one cattery name prefix and one cattery name suffix.*

*38.9 Once added, a cattery name suffix cannot be dropped or changed except upon payment of the required fee and surrender of the former registration certificate to the registrar.*

*38.10 Registered cattery names may be transferred upon surrender of the certificate of cattery name registration with written assignment of the transfer of ownership and payment of the required transfer fee.*

### Following are the Office Policies to support the Rules

Cattery names may ONLY be one word in length consisting of no more than 15 letters and **must differ by at least two letters** from any already registered cattery name.

#### **Cattery names may not contain:**

- **more than 15 letters**
- punctuation marks (#, &, -, etc.)
- apostrophes
- spaces
- hyphenations
- more than one word
- duplications

A cattery name is a permanent record of the Association and may not be changed, however, you may register as many cattery names as you wish. Your cattery name may only be used as a prefix when you are the breeder; it may be used as a suffix when you are the registered owner of the cat. The cattery name that you register is the name that will be used in the registration of your cats and cats

*of your breeding in the prefix or suffix position. An apostrophe "s" may not be added to a TICA registered cattery name unless the cattery name was originally registered with an apostrophe "s". Cattery names registered after 05/01/1992 may not use apostrophe "s". When transferring a cat into your name you may drop the suffix and add your cattery name for a fee of \$7 for each addition or deletion. Any use of the word "of" in any language may denote a cattery suffix, and foreign translations for the word "of" will not be allowed i.e., av, de, etc.*

**Proposal:** While it makes sense to restrict cattery names from the use of punctuation marks, apostrophes and hyphenations, I suggest that the Office be given discretion to modify their policy to either allow the use of two words in a cattery name or, alternatively, to count a space as one of two letters difference from an existing name, as long as it is not simply a duplication of a current cattery name.

## **Registration of Duplicate Names (from other registries)**

**Requested by Christian**

Issue: /CF, /FI, etc... If there is a way to track this on the pedigrees/registrations without being a part of the cat's registered name itself.

Discussion: Here's a made up example, and an explanation:

Momcats Miss Kitty of Kingsransom/CF

The complaint is as follows:

1. First reaction "I don't co-own the cat with a cattery names "CF" (Co-owners are notated with a "&" or a "/")
2. Second reaction, after explanation. "Kingsransom is a TICA cattery, although Momcats is not. This looks like Kingsransom is a CFA cattery."
3. Why does this have to be where it is, as it is on the registration form? There is plenty of room elsewhere, where the point could be made more clear.
4. What if a name is 35 characters? Is the name sacrificed in order to add the /CF?
5. What about "Punctuation marks of any kind (&, ', #, etc.) are not allowed in the name of the cat" Is this a violation of that?
6. If this cat is then sold to a cattery who shows, or is simply registered in, FIFE or GCCF or whatever, that cats' name will now have the /CF on their forms as well? (I assume)

Solution: Could this be on the pedigree or registration form somewhere else, other than in the cats' name?

### **Information provided by Executive Office:**

The whole purpose of these three characters was to allow international owners to register their cats with the names and punctuations that were allowed in their own associations. We can now register the cat exactly as it is registered in another association EVEN if the cattery prefix or suffix is a duplicate to one of TICA's registered catteries. When we registered them in the past, we would drop the prefix (if it was already registered to a TICA breeder) or the suffix (if it was already registered to a TICA owner) and any punctuation.

Yes, we can track them, but the whole reason for having them appear in the name of the cat is so that when you look at a pedigree and it has /CF or /IT on the name of any cat, you know that the cattery prefix or suffix does not belong to a TICA registered cattery.

# HHP Shelter/Rescue Registration Program

(Requested by Christian)

Issue: Do we wish to promote this program?

Discussion: This is an inexpensive way to get shelters/rescues involved in TICA.

Opinion: Getting shelters/rescues involved in TICA not only promotes our image as “the good guys,” but is a potential source of income.

1. Process for shelters to sign up. I can easily create a form, but think that someone in the office (Hart), for uniformity, should design the simple form, and possibly have an online shelter/rescue sign up as well.
2. I feel that the shelters/rescues should be assigned a number, similar to membership numbers, such as (ex.) RS-1234-HH (RS being rescue, HH instead of region). I think that this would speed the ease of tracking rebates in the office. There should be a space on the shelter (or all) HHP Registration Forms for any participating shelters to fill in their name and tracking number, before giving it to the new owners.
3. We need to decide on a rebate amount. I still think \$2 each is the best incentive for shelters to promote TICA, but there were some of you who felt \$1 was enough. Remember, most of these cats would not be registered otherwise.
4. Leslie has said that she doesn't care when they ask for their rebates, but I believe for ease of implementation, there should be between 2 and 4 times a year, with a set date, where the shelters/rescues should be allowed to request their money in writing. The office could select lighter volume months for this.
5. I would be happy to write up a program introduction for the shelters, and for the TICA site. Additionally, I would be happy to create a small poster sized flyer for those rescues/shelters who sign up to post in their buildings. or at their events, explaining why people should register their cats, and how much fun it is to show them.

## Cattery listings on TICA's web site

Requested by Christian

Issue: The paid cattery listings on TICA's website give the public a false sense of security when purchasing pedigreed cats, which Directors have to explain later, when there are problems.

Discussion: I would estimate that most of the few people who advertise there are not the type of people that really need to be "representing" TICA. However, I understand the annual fee, and how it limits some great breeders. It's kind of like Cat Fancy magazine/Cats USA - there are some good breeders who list there, however, the majority of the people who advertise there are questionable, at best. They just happen to have money from their breeding program for advertising.

Discussion: I would like to discuss simply if we want to relook at this system. I was personally a fan of Gloria's free listings, as then there were so many there that people knew they had to research. At this time, people think the few listed are TICA's elite. Is this really a money maker for TICA, or more of a headache?
